PERSONAL PROFILE

I am a Consultant Clinical Psychologist and Health and Care Professions Council (HCPC) registered Practitioner (Clinical) Psychologist. I currently hold an NHS role as a Consultant and Lead for Neuropsychology in Neurorehabilitation and Acute Services. Prior to this I have held several NHS positions working across neuro-intensive care, acute stroke and neurology wards and specialist outpatient clinics with both acquired brain injury and neurodegenerative conditions. I have also worked as with the third sector parties to improve mental health provision across the UK for neurological conditions.

My experience includes neuropsychological assessment, formulation and rehabilitation/psychological intervention across a range of neurological conditions. Currently I work with people with profound neuro-disability and their families providing assessment, intervention, risk and behavioural management and psychological support. I have particular experience in assessing people with complex neurological presentations where traditional approaches may be limited due to significant physical, cognitive or contextual matters to consider. I have experience of leading interdisciplinary teams, providing consultation on complex cases, providing psychological support and supervision to treating teams, and experience of working within the context of the Mental Capacity Act and Deprivation of Liberty Safeguards in neurorehabilitation settings. I regularly provide specialist external training, and I also teach on the Doctorate courses in Clinical Psychology. I keep an active interest in research and policy, where I remain actively engaged.
