I am a dedicated and motivated Principal Clinical Neuropsychologist. I am registered with the HCPC (PYL32280) and the British Psychological Society (430920), and I am entered on the Specialist Register of Clinical Neuropsychologists (SRCN). My experience includes neuropsychological assessment and rehabilitation for individuals in a range of settings, from secure hospitals through to community work, and across the life span and ability range. I am skilled in clinically leading complex cases, leading interdisciplinary teams and working alongside multiple other agencies. I have particular interests in third-wave approaches to therapy and EMDR alongside my experience in Neurobehavioural approaches.

- Experience in cognitive rehabilitation, individual and group-based interventions.
- Provision of formulation meetings and training for therapy and support staff to improve understanding, and enhance effectiveness of interactions and interventions for clients.
- Ability to communicate sensitive and complex information, in both verbal and written form, to a range of audiences, at times within the context of heightened emotion or conflict situations.

- Skilled in systemic and family support, to enhance outcomes within rehabilitation for the client, and improve emotional wellbeing and understanding for families and caregivers.
- Experienced in co-ordinating and supporting complex discharge planning, and in joint working with external agencies such as commissioning, social care, legal teams and case managers.

Senior Community Clinical Psychologist

For one year I committed one day per week to the Disabilities Trust's Northeast Community Services, providing Psychology support and oversight for the Trust's supported living services.

- Experienced in brief assessment and formulation of emotional and behavioural symptoms following acquired brain injury, in order to independently make decisions and recommendations about clients' needs, in a timely manner.
- Provision of short-term intervention for individuals within a community setting, with a focus on enhancing quality of life.
- Consultation with managers and support workers, and oversight of support plans, so as to maximise client's well-being and quality of life, and to reduce burnout and distress for caregivers.
- Experienced in making decisions about the commissioning of clinical services, and to weigh up the need for Psychology input at that time, including decisions about termination of therapy and clinical services where appropriate.

After qualifying as a Clinical Psychologist in 2015, I worked within a specialist hospital providing assessment and rehabilitation for individuals with complex and challenging needs following acquired brain injury.

- Skilled in holistic neuropsychological assessment and person-centred formulation for individuals with one or more co-morbid neurological diagnoses, complex mental health difficulties, forensic histories and significant substance misuse.
- Experienced in psychological intervention through both direct client work and systemic support, to address high levels of aggression or distress, significant risk to self or others, and/or behaviours which limit a client's opportunities for social inclusion.
- Resilient and able to maintain a professional and therapeutic manner in the face of some intense, highly emotive or challenging situations.
- Skilled in complex and formulation-driven risk assessment and management.
- Experienced in rehabilitation for significant deficits in insight and executive functioning.
- Knowledge and experience of working with individuals who may be subject to Mental Health Act or Mental Capacity Act legislation; experience in complex capacity assessments and leading best interest decision meetings.
- Regularly delivered in-house training to all staff regarding acquired brain injury, as well as providing debriefs, tutorials and formulation meetings to support staff.
