I am a Senior Assistant Psychologist and British Psychological Society (BPS) Graduate Member with several years of experience in neurorehabilitation and mental health services. Across various roles as a Therapy/Rehabilitation Assistant, Occupational Therapy Assistant, Assistant Case Manager, and more recently an Assistant Psychologist, I have worked with diverse neurological populations in community clinical settings. I have experience assisting in complex rehabilitation with degenerative and acquired neurological conditions including traumatic brain injury and perinatal brain injury, and I have supported neuropsychological work with patients presenting with a range of disorders including language and communication difficulties, episodic memory impairment, dysexecutive syndrome, as well as some of the rarer neuropsychological syndromes.

As an Assistant Psychologist, I am responsible for supporting neuropsychological assessments and interventions under the close direction of a Practitioner Psychologist. This includes interviewing, administering neuropsychometric tests, contributing to report writing, and a broad range of therapy interventions such as; guiding families to understand the impact of neurological conditions on behaviour; providing elements of cognitive behaviour therapy and exposure therapy to help clients overcome trauma, anxiety, and low mood. I support the implementation of person-centred care plans tailored to individual needs, collaborating with dynamic multidisciplinary teams across Physiotherapy, Occupational Therapy, and Speech and Language Therapy. I am adept at optimising processes to support time and cost-efficient work. As part of my role, I support Case Managers, Solicitors and Clinicians by providing comprehensive records that evidence client progression and ongoing challenges using analytics and trends. I have experience contributing to risk assessments, Initial Needs Assessments and supporting with the delivery of training programs.
