
According to the Washington Post, PRISM data accounts for nearly 1 in 7 intelligence reports.

The presentation further boasts of "strong growth" in PRISM's reach, noting the number of online communications obtained increased by 248 percent in 2012 for Skype alone, with "exponential growth in Skype reporting... Looks like the word is getting out about our capability against Skype."

US intelligence requests made through PRISM in 2012 increased by 131 percent for Facebook, and by 63 percent for Google, according to the presentation.



According to the Guardian, when the NSA reviews a communication flagged for further investigation, it can then issue what it calls a "report." The NSA revealed that "over 2,000 PRISM-based reports" are now issued every month, representing a 27 percent increase since last year.

Jameel Jaffer, the director of the ACLU's Center for Democracy, told the Guardian it was astonishing the NSA would directly ask companies to grant access to user data: "It's shocking enough just that the NSA is asking companies to do this. The NSA is part of the military. The military has been granted unprecedented access to civilian communications."

"This is unprecedented militarisation of domestic communications infrastructure. That's profoundly troubling to anyone who is concerned

Terrorist Plots, Hatched by the F.B.I.

THE United States has been narrowly saved from lethal terrorist plots in recent years - or so it has seemed. A would-be suicide bomber was intercepted on his way to the Capitol; a scheme to bomb synagogues and shoot Stinger missiles at military aircraft was developed by men in Newburgh, N.Y.; and a fanciful idea to fly explosive-laden model planes into the Pentagon and the Capitol was hatched in Massachusetts.

But all these dramas were facilitated by the F.B.I., whose undercover agents and informers posed as terrorists offering a dummy missile, fake C-4 explosives, a disarmed

suicide vest and rudimentary training. Suspects naïvely played their parts until they were arrested.

When an Oregon college student, Mohamed Osman Mohamud, thought of using a car bomb to attack a festive Christmas-tree lighting ceremony in Portland, the F.B.I. provided a van loaded with six 55-gallon drums of "inert

material," harmless blasting caps, a detonator cord and a gallon of diesel fuel to make the van smell flammable. An undercover F.B.I. agent even did the driving, with Mr. Mohamud in the passenger seat. To trigger the bomb the student punched a number into a cellphone and got no boom, only a bust.

This is legal, but is it legitimate? Without the F.B.I., would the culprits commit violence on their own? Is cultivating potential terrorists the best use of the manpower designed to find the real ones? Judging by their official answers, the F.B.I. and the Justice Department are sure of themselves — too sure, perhaps.

Carefully orchestrated sting operations usually hold up in court. Defendants invariably

claim entrapment and almost always lose, because the law requires that they show no predisposition to commit the crime, even when induced by government agents. To underscore their predisposition, many suspects are "warned about the seriousness of their plots and given opportunities to back out," said Dean Boyd, a Justice Department spokesman. But not always, recorded conversations show. Sometimes they are coaxed to continue.

Undercover operations, long practiced by the F.B.I., have become a mainstay of counterterrorism, and they have changed in response to the post-9/11 focus on prevention. "Prior to 9/11 it would be very unusual for the F.B.I. to present a crime opportunity that wasn't in the scope of the activities that a person was already involved in," said Mike German of the American Civil Liberties Union, a lawyer and former F.B.I. agent who infiltrated white supremacist groups. An alleged drug dealer would be set up to sell drugs to an undercover agent, an arms trafficker to sell weapons. That still happens routinely, but less so in counterterrorism, and for good reason.

"There isn't a business of terrorism in the United States, thank God," a former federal prosecutor, David Raskin, explained.

"You're not going to be able to go to a street corner and find somebody who's already blown something up," he said. Therefore, the usual goal is not "to find somebody who's already engaged in terrorism but find somebody who would jump at the opportunity if a real terrorist showed up in town."

And that's the gray area. Who is susceptible? Anyone who plays along with the agents, apparently. Once the snare is set, law enforcement sees no choice. "Ignoring such threats is not an option," Mr. Boyd argued, "given the possibility that the suspect could act alone at any time or find someone else willing to help him."

Typically, the stings initially target suspects for pure speech — comments to an informer outside a mosque, angry postings on Web sites, e-mails with radicals overseas — then woo them into relationships with informers, who are often convicted felons working in exchange for leniency, or with F.B.I. agents posing as members of Al Qaeda or other groups.

Some targets have previous involvement in more than idle talk: for example, Waad Ramadan Alwan, an Iraqi in Kentucky, whose fingerprints were found on an unexploded roadside bomb near Bayji, Iraq, and <u>Raja Khan of Chicago</u>, who had sent funds to an Al Qaeda leader in Pakistan.

The Federal Bureau of Investigation employs upwards of 15,000 undercover agents today, ten times what they had on the roster back in 1975.

If you think that's a few spies too many — spies earning as much as \$100,000 per assignment — one doesn't have to go too deep into their track record to see their accomplishments. Those agents are responsible for an overwhelming amount of terrorist stings that have stopped major domestic catastrophes in the vein of 9/11 from happening on American soil.

Another thing those agents are responsible for, however, is plotting those very schemes.

The FBI has in recent years used trained informants not just to snitch on suspected terrorists, but to set them up from the get-go. A recent report put together by Mother Jones and the Investigative Reporting Program at the University of California-Berkley analyses some striking statistics about the role of FBI informants in terrorism cases that the Bureau has targeted in the decade since the September 11 attacks.

The report reveals that the FBI regularly infiltrates communities where they suspect terrorist-minded individuals to be engaging with others. Regardless of their intentions, agents are sent in to converse within the community, find suspects that could potentially carry out "lone wolf" attacks and then, more or less, encourage them to do so. By providing weaponry, funds and a plan, FBI-directed agents will encourage otherwise-unwilling participants to plot out terrorist attacks, only to bust them before any events fully materialize.

Additionally, one former high-level FBI officials speaking to Mother Jones says that, for every informant officially employed by the bureau, up to three unofficial agents are working undercover.

The FBI has used those informants to set-up and thus shut-down several of the more high profile would-be attacks in recent years. The report reveals that the Washington DC Metro bombing plot, the New York City subway plot, the attempt to blow up Chicago's Sears Tower and dozens more were all orchestrated by FBI agents. In fact, reads the report, only three of the more well-known terror plots of the last decade weren't orchestrated by FBI-involved agents.

The report reveals that in many of the stings, important meetings between informants and the unknowing participants are left purposely unrecorded, as to avoid any entrapment charges that could cause the case to be dismissed. Perhaps the most high-profile of the FBI-proposed plots was the case of the Newburgh 4. Around an hour outside of New York City, an informant infiltrated a Muslim community and engaged four local men to carry out a series of attacks. Those men may have never actually carried out an attack, but once the informant offered them a plot and a pair of missiles, they agreed. Defense attorneys cried "entrapment," but the men still were sentenced to 25 years apiece.

"The problem with the cases we're talking about is that defendants would not have done anything if not kicked in the ass by government agents," Martin Stolar tells Mother Jones. Stolar represented the suspect involved in a New York City bombing plot that was set-up by FBI agents. "They're creating crimes to solve crimes so they can claim a victory in the war on terror." For their part, the FBI says this method is a plan for "preemption," "prevention" and "disruption."

The report also reveals that, of the 500-plus prosecutions of terrorism-related cases they analyzed, nearly half of them involved the use of informants, many of whom worked for the FBI in exchange for money or to work off criminal charges. Of the 158 prosecutions carried out, 49 defendants participated in plots that agent provocateurs arranged on behalf of the FBI.

Experts note that the chance of winning a terrorism-related trial, entrapment or not, is near impossible. "The plots people are accused of being part of — attacking subway systems or trying to bomb a building — are so frightening that they can overwhelm a jury," David Cole, a Georgetown University law professor, tells Mother Jones. Since 9/11, almost two-thirds of the cases linked to terrorism have ended with guilty pleas. "They don't say, 'I've been entrapped,' or, 'I was immature," a retired FBI official remarks.

All of this and those guilty pleas often stem for just being in the right place at the wrong time. Farhana Khera of the group Muslim Advocate notes that agents go into mosques on "fishing expeditions" just to see where they can get interest in the community. "The FBI is now telling agents they can go into houses of worship without probable cause," says Khera. "That raises serious constitutional issues."

From the set-up to the big finish, the whole sting operation is ripe with constitutional issues such as that. A decade since 9/11, however, the FBI is reaching through whatever means it can pull together to keep terrorists — or whom they think could someday become one — from ever hurting America.

Nearly 95 per cent of terrorist arrests have Tags FBI, Terrorism, USA been the result of FBI foiling its own entrapment plots as a part of the so-called post-9/11 War on Terror, a new study revealed.

According to thereport entitled 'Inventing Terrorists: The Lawfare of Preemptive Prosecution', the majority of arrests involved the unjust prosecution of targeted Muslim Americans.

The 175-page study by Muslim advocacy group SALAM analyzes 399 individuals in cases included on the list of the US Department of Justice from 2001 to 2010.

"According to this study's classification, the number of preemptive prosecution cases is 289 out of 399, or 72.4 percent. The number of elements of preemptive prosecution cases is 87 out of 399, or 21.8 percent. Combining preemptive prosecution cases and elements of preemptive prosecution cases, the total number of such cases on the DOJ list is 376, or 94.2 percent," the report concluded.

The authors define 'preemptive prosecution' as "a law enforcement strategy adopted after 9/11, to target and prosecute individuals or organizations whose beliefs, ideology, or religious affiliations raise security concerns for the government."

Nearly 25 percent of cases (99 of 399) contained material support charges. Another almost 30 per cent of cases consisted of conspiracy charges. More than 17 per cent of the analyzed cases (71 of 399 cases) involved sting operations. Over 16 percent of cases (65 of 399 cases) included false statement or perjury charges, and around six percent of cases involved immigration-related charges.

According to the report, since 9/11 only 11 cases posed "potentially significant" threat to the United States.

"Only three were successful (the [Tamerlan and Dzhokhar] Tsarnaev brothers and Major Nidal Hasan), accounting for 17 deaths and several hundred injuries," the paper says.

One of the FBI's strategies involved "using agents provocateur to actively entrap targets in criminal plots manufactured and controlled by the government."

"The government uses agents provocateur to target individuals who express dissident ideologies and then provides those provocateurs 25 with fake (harmless) missiles, bombs, guns, money, encouragement, friendship, and the technical and strategic planning necessary to see if the targeted individual can be manipulated into planning violent or criminal action," the report concluded.

The government could also choose to use "minor 'technical' crimes," such as errors on immigration forms, an alleged false statement to a government official, gun possession, tax or financial issues, etc., to go after someone for their "ideology."

"What they were trying to do is to convince the American public that there is this large army of potential terrorists that they should all be very-very scared about. They are very much engaged in world-wide surveillance and this surveillance is very valuable to them. They can learn a lot about all sorts of things and in a sense control issues to their advantage," Steven Downs, an attorney for Project SALAM, which issued the report, told RT. "And the entire legal justification for that depends on there being a war on terror. Without a war on terror they have no right to do this. So they have to keep this war on terror going, they have to keep finding people and arresting them and locking them up and scarring everybody."

In the conclusion, authors of the report offered the US government several recommendations that the DOJ "should employ" to change the present unfair terrorism laws. A total seven recommendations call on the US government to accurately identify people who offer material support for terrorism, strengthening the "entrapment" defense in the courts; abolish "terror-enhanced sentencing" that triples or quadruples jail time in cases linked to terrorist acts; disallow secret court proceedings, and immediately notifying defendants if any evidence in their case is derived from secret surveillance.

New OKC Revelations Spotlight FBI Involvement In Bombing

Nichols' claim that McVeigh had government handlers supported by huge weight of known evidence

New claims by Oklahoma City Bombing conspirator Terry Nichols that Timothy McVeigh was being steered by a high-level FBI official are supported by a plethora of evidence that proves McVeigh did not act alone and that authorities had prior warnings and were complicit in the bombing of the Alfred P. Murrah building.

The Salt Lake Tribune reported yesterday,

Oklahoma City bombing conspirator Terry Nichols says a high-ranking FBI official "apparently" was directing Timothy McVeigh in the plot to blow up a government building and might have changed the original target of the attack, according to a new affidavit filed in U.S. District Court in Utah.

The official and other conspirators are being protected by the federal government "in a cover-up to escape its responsibility for the loss of life in Oklahoma," Nichols claims in a Feb. 9 affidavit.

Documents that supposedly help back up his allegations have been sealed to protect information in them, such as Social Security numbers and dates of birth.

The U.S. Attorney's Office in Utah had no comment on the allegations. The FBI and Justice Department in Washington, D.C., also declined comment.

The affidavit was filed in a lawsuit brought by attorney Jesse Trentadue, whose brother Kenneth was tortured and beaten to death in an Oklahoma City federal prison in 1995. Authorities claimed Trentadue had committed suicide but he was being held in a suicide proof cell at the time and autopsy photos of his body showed he had been shocked with a stun gun, bruised, burned, sliced and then hung.

Jesse Trentadue has amassed evidence that his brother was mistaken for one of Timothy McVeigh's alleged bombing accomplices and in attempting to get him to talk Federal agents went too far and then tried to instigate a cover-up of the murder.

Just like 9/11, the official story of the Oklahoma City Bombing, that McVeigh alone carried out the attack using a fertilizer truck bomb, is contradicted by a plethora of eyewitness account as well as physical and circumstantial evidence.

- In early April 1995 a <u>Ryder truck identical to the one used in the bombing was filmed by a pilot</u> during an overflight of of an area near Camp Gruber-Braggs, Oklahoma. A June 17th, 1997 Washington Post article authenticates the photos as being exactly what they appear to be, photos of a Ryder truck in a clandestine base at Camp Gruber-Braggs. Why were the military in possession of a Ryder truck housed in a remote clandestine army base days before the Alfred P. Murrah bombing?
- In a 1993 letter to his sister, McVeigh claimed that he was approached by military intelligence and had joined

an "elite squad of government paid assassins." McVeigh often contradicted himself and changed his story on a whim to fit in with the latest government version of events. Is the Camp Grafton footage evidence of McVeigh's enrollment in such a clandestine program?

- Multiple reports of Arabs at the scene assisting McVeigh were ignored and surveillance tapes were withheld under national security. The likely reason for this was the fact that Bush senior and Clinton were <u>responsible for bringing in nearly 1,000</u> Iraqi soldiers captured by U.S. forces during the 1991 Persian Gulf War, some of whom were involved in the bombing.

- The FBI claimed McVeigh scouted the Alfred P. Murrah building weeks before the bombing and yet on the morning of the attack he stopped at a local gas station to ask directions, lending credibility to the new claims that he was being controlled by other conspirators and that the target of the bombing had been changed.
- Original reports of two explosions and several failed devices being defused by bomb squads were buried by the establishment as the official explanation that McVeigh acted alone was pushed. Scientific analysis conducted by General Benton K. Partin revealed core columns were blown out from within the building and the extensive damage to the Alfred P. Murrah building was completely inconsistent with the explanation of a single and relatively weak fertilizer truck bomb.
- Many eyewitnesses reported that bomb squads in full reaction gear were seen around the building immediately before the blast. Police officer <u>Terence Yeakey</u>, who helped save dozens of victims, was one such witness. Yeakey compiled extensive files on his observations but was later found with his throat and wrists slashed having also been shot in the head after he had told friends he was being followed by authorities.
- Several individuals received prior warning that the bombing was about to take place. Bruce Shaw, who rushed to the Murrah building to find his wife who was employed there with the Federal Credit Union, testified that an ATF agent told him that ATF staff had been warned on their pagers not to come to work that day.
- The aftermath of the bombing led to the passage of the Omnibus Crime Bill and the demonization of the 'Patriot Movement', which was spreading like wildfire as opposition to federal government abuse grew following the events at Ruby Ridge and Waco. The consequences of the Oklahoma City Bombing effectively dismantled the Patriot Movement before the turn of the century.

In December, we <u>reported on a video</u>that shows McVeigh at a U.S. military base that specialized in explosives and demolition training over a year after he supposedly left the army. The tape, released by film producer Bill Bean, was the subject of a Hustler Magazine feature story.

Appearing last night on George Noory's Coast to Coast broadcast, America's biggest late night radio show, Alex Jones said he expected to talk to Jesse Trentadue imminently and it was further suggested by Noory that he and Jones should travel to Nichols' prison to interview him in person.

Federal Judge Slaps FBI for Continuing OKC Bombing Cover-Up

During a March 20 hearing in Salt Lake City, U.S. District Judge Clark Waddoups described as "astounding" the FBI's claim that critical video of the 1995 Oklahoma City Bombing had simply gone "missing" – an assertion that buttresses attorney Jesse Trentadue's belief that the Bureau has spared no effort to cover up critical facts about the atrocity.

Trentadue, whose brother Kenney was murdered by federal agents in Oklahoma shortly after the 1995 terrorist attack, filed a Freedom of Information Act request for surveillance video of Timothy McVeigh parking the truck bomb outside the Murrah Federal Building, and dashcam video of his arrest by a state trooper 90 minutes after the explosion. The FBI claims that these indispensable pieces of evidence regarding what was at the time the worst terrorist act in U.S. history have simply vanished in the tenebrous depths of an official warehouse, much like the Ark of the Covenant was at the end of the first Indiana Jones film. The attorney filed his first FOIA request in December 2006, and the Bureau has done its formidable best to ignore, mislead, misdirect, and otherwise obstruct efforts to produce the records, as it is required to by law.

"The FBI has submitted several declarations from its top records manager to show the agency has searched electronic databases and evidence warehouses without success," reports the Deseret News of Salt Lake City. "But Waddoups said the declarations lack credibility because they do not include firsthand knowledge or details about who, when, where or how the searches were conducted."


Did the FBI Bury Oklahoma City Bombing Evidence?

One lawyer's relentless quest for information reveals fresh hints of a coverup.

In 2007, Mother Jones was the first national media outlet to tell the full story

(http://motherjones.com/politics/2007/07/search-john-doeno-2-story-feds-never-told-about-oklahoma-city-bombing) of Jesse Trentadue and his quest for the truth, which began four months after the attack on Oklahoma City's Alfred P. Murrah Federal Building on April 19, 1995, killed 168 people. It was then that Trentadue, a Salt Lake City lawyer, learned that his brother, a construction worker and onetime bank robber, had died in a federal prison in Oklahoma City.

Prison officials said the prisoner had hanged himself. But Kenney Trentadue, who had never revealed any suicidal inclination, was shipped home for burial with bruises all over his body and lacerations on his face and throat—suggesting something more sinister. Even Oklahoma City's chief medical examiner would later say, publicly, that it was "very likely he was murdered." But the most compelling evidence in the case was altered or turned up missing. Jesse Trentadue was never able to prove what had actually happened to his brother—though he did win a \$1.1 million civil suit for "emotional distress" to his family, based on the way the government had handled the aftermath of Kenney's death.

Trentadue had all but given up, when, in the spring of 2003, he got a call from a small-town newspaper reporter in Oklahoma named J.D. Cash. Cash told him that Kenney very much resembled the police sketch of John Doe No. 2, whom the FBI initially believed to be a second bomber in the Oklahoma City attack. Cash also pointed out that both Kenney and John Doe No. 2 resembled Richard Lee Guthrie, a notorious figure on the racist far right. In 1994 and 1995, Guthrie and his gang, which called itself the Aryan Republican Army (ARA), had carried out 22 bank robberies across the Midwest, netting some \$250,000 to support their white-supremacist movement.

Might federal officials have believed that Kenney Trentadue was in fact Richard Lee Guthrie, and

that Guthrie was John Doe No. 2? Could he have been beaten to death in an interrogation gone bad? That theory provided what Jesse believed might be a missing motive for his brother's murder, and he set about learning all he could about the federal investigations of the bombing and the Aryan Republican Army.

By 2003, however, the Oklahoma City case was closed. Timothy McVeigh was declared the lone bomber and executed for his crime; Terry Nichols, named as his sole accomplice, was serving a life sentence in a federal supermax in Florence, Colorado. Federal

officials denied—and the judge in the McVeigh trial rebuffed—any attempts to show that McVeigh and Nichols hadn't acted alone. Stonewalled at every turn, Trentadue remained determined to satisfy his curiosity. His primary tool would be the Freedom of Information Act (FOIA).

An initial batch of documents, received through a FOIA request, showed that the FBI was investigating a link between the bombers and Guthrie's ARA. The connection involved a remote religious compound called Elohim City in eastern Oklahoma's Ozark Mountains, a kind of sanctuary for far-right extremists from the Klan and the Aryan Nations to the then-burgeoning militia movement that inspired McVeigh.

The documents revealed that federal law enforcement had informants close to Elohim City. As I wrote (http://motherjones.com/politics/2007/07/search-john-doe-no-2-story-feds-never-told-about-oklahoma-city-bombing?page=7) in my original story, they also showed

...that the bureau was interested in any communication between McVeigh and the ARA immediately before the bombing, and that Guthrie himself was in Pittsburg, Kansas—some 200 miles from Oklahoma City—three days before the attack. In addition, the memos indicate that the FBI received reports of McVeigh calling and possibly visiting Elohim City before the bombing, at one point seeking "to recruit a second conspirator."

The documents also have one source reporting that McVeigh had a "lengthy relationship" with someone at Elohim City, and that he called that person just two days before the bombing. (These documents were never shown to McVeigh's lawyer.) The Justice Department and the FBI would not comment on the documents; an FBI spokesman in Oklahoma City told me that the bureau is confident it has caught and convicted those responsible for the bombing.

After the story ran, Trentadue continued his quest for information. He tried to depose Terry Nichols, along with a federal inmate named David Paul Hammer, who said he had talked with McVeigh at length while they were on death row together. A federal district court judge in Utah gave Trentadue the go-ahead, but his decision was reversed (http://www.sltrib.com/news/ci_12741839) by the 10th US Circuit Court of Appeals. Trentadue also learned from the CIA that it had a spy satellite over Oklahoma at the time of the bombing, but the agency withheld details from him due to national security concerns.

Trentadue placed one FOIA after another, always getting the runaround from the FBI. Finally, after three years, he persuaded Clark Waddoups, another Utah-based federal judge, to order the FBI to respond by June 30, 2011. Trentadue was particularly interested in 20 or more video surveillance tapes from cameras located on the Murrah building—cameras that might have shown, among other things, whether McVeigh was alone when he parked a truckload of explosives beneath the building and then fled from his truck.

Earlier, the FBI had produced a document

(https://www.documentcloud.org/documents/217175-fbi-response-to-may-13-2011-order.html) suggesting that the videotapes didn't exist, based on an investigatory report "in which an individual personally involved in clearing the Murrah building after the bombing with The FBI suggested that the Murrah building's cameras apparent familiarity with its surveillance systems, stated that it was 'a shame...that the surveillance cameras were never hooked up again after they put in a new security system approximately two years ago." The person in question was an elevator repairman (https://www.documentcloud.org/documents/217176-elevator-repairman.html) who had done some work in the Murrah building and had gone there shortly after the blast.

were never hooked up, based on a claim by an elevator repairman.

But Trentadue argued that the cameras were indeed operational at the time of the bombing, citing two affidavits he'd obtained. The first one (https://www.documentcloud.org/documents/217174-browning-declaration.html) came from Don Browning, an Oklahoma City police officer (now retired) who shortly after the blast had "observed men wearing jackets with 'FBI' printed on the back removing the surveillance video cameras from the exterior of the Murrah Federal Building. I thought this was part of the FBI's evidence gathering or 'chain of custody' procedures since those exterior cameras would have shown and recorded delivery of the bomb in a Ryder truck that morning as well as the person or persons who exited that truck."

The <u>second affidavit (https://www.documentcloud.org/documents/217173-cooley-declaration.html)</u> came from Joe Bradford Cooley, an employee for a subcontractor bidding on running the surveillance system. Cooley said he made frequent inspections of the system, including cameras and monitors, and that everything was running correctly up to the time the bomb went off. In addition, a <u>Secret Service timeline (https://www.documentcloud.org/documents/217178-secret-service-timeline.html)</u> of that day refers to one observer who said, "Security video shows Ryder truck pulling up to the federal building and then pausing (7 to 10 seconds) before resuming into a slot in front of the building."

Now, in a sworn declaration (https://www.documentcloud.org/documents/217177-third-hardy-declaration.html) to the court, David M. Hardy, a section chief in the FBI's Records Management Division, said that he was "unaware of the existence or likely location of additional tapes...and do not know of anyone who would know where additional tapes would be located."

FBI agent Ricardo Ojeda said the bureau kept "zero files" on important cases—"containing information the FBI would not generally want disclosed to the defense." The judge ordered the FBI to search its records manually, but the bureau resisted (https://www.documentcloud.org/documents/217175-fbi-response-to-may-13-2011-order.html)_, arguing that the courts had previously relieved it of doing manual searches, and that "a manual search of the first 14 day worth of records in the OKBOMB case file would be extremely burdensome...Hardy estimates that this material consists of approximately 450,000 pages and would take one employee over 1 1/2 years to search. Mr. Hardy indicates that such an undertaking would be unprecedented and could negatively impact his office's ability to carry out other obligations."

Trentadue is questioning whether the bureau in fact has several sets of files—the main case file and others. In <u>an affidavit</u> (https://www.documentcloud.org/documents/217179-ojeda-affidavit.html)

from an earlier case, FBI agent Ricardo Ojeda, who was assigned to investigate the bombing, said the bureau kept what it called "zero files" on important cases. These, Ojeda said, were "reports containing information the FBI would not generally want disclosed to the defense and which were kept separate from a specific case file. These files were kept internally within the bureau and typically were not turned over to the prosecution or the defense." When the FBI assigned numbers to its files, Ojeda said, "a zero after that number would mean that the report should go into the 'zero' file."

The FBI has long sought to hide certain files, according to <u>a recent investigation</u> (http://www.iwatchnews.org/2011/06/02/4790/judge-orders-fbi-cough-information-about-previously-secret-computer-drive) by the Center for Public Integrity. In the '70s there were "June" files, which in the 1990s became the "zero" files. In 1996, the zero files were upgraded to the "I-Drive" files.

Fury as academics claim 9/11 was 'inside job'

The 9/11 terrorist attack on America which left almost 3,000 people dead was an "inside job", according to a group of leading academics.

Around 75 top professors and leading scientists believe the attacks were puppeteered by war mongers in the White House to justify the invasion and the occupation of oil-rich Arab countries.

The claims have caused outrage and anger in the US which marks the fifth anniversary of the terrorist attacks on Monday.

But leading scientists say the facts of their investigations cannot be ignored and say they have evidence that points to one of the biggest conspiracies ever perpetrated.

Professor Steven Jones, who lectures in physics at the Brigham Young University in Utah, says the official version of events is the biggest and most evil cover up in history.

He has joined the 9/11 Scholars for Truth whose membership includes up to 75 leading scientists and experts from universities across the US.

Prof Jones said: "We don't believe that 19 hijackers and a few others in a cave in Afghanistan pulled this off acting alone.

"We challenge this official conspiracy theory and, by God, we're going to get to the bottom of this."

In essays and journals, the scientists are giving credence to many of the conspiracy theories that have circulated on the internet in the past five years.

They believe a group of US neo-conservatives called the Project for a New American Century, set on US world dominance, orchestrated the 9/11 attacks as an excuse to hit Iraq, Afghanistan and later Iran.

The group says scientific evidence over the attacks on the World Trade Centre and the Pentagon is conclusive proof.

Professor Jones said it was impossible for the twin towers to have collapsed in the way they did from the collision of two aeroplanes.

He maintains jet fuel does not burn at temperatures high enough to melt steel beams and claims horizontal puffs of smoke seen during the collapse of the towers are indicative of controlled explosions used to bring down the towers.

The group also maintains World Trade Centre 7 - a neighbouring building which caught fire and collapsed later in the day - was only partially damaged but had to be destroyed because it housed a clandestine CIA station.

Professor James Fetzer, 65, a retired philosopher of science at the University of Minnesota, said: "The evidence is so overwhelming, but most Americans don't have time to take a look at this."

The 9/11 Commission dismissed the numerous conspiracy theories after its exhaustive investigation into the terror attacks.

Subsequent examinations of the towers' structure have sought to prove they were significantly weakened by the impact which tore off fire retardant materials and led the steel beams bending under heat and then collapsing.

Christopher Pyle, professor of constitutional law at Mt Holyoake College in Massachusetts, has dismissed the academic group.

He said: "To plant bombs in three buildings with enough bomb materials and wiring? It's too huge a project and would require far too many people to keep it a secret afterwards.

"After every major crisis, like the assassinations of JFK or Martin Luther King, we've had conspiracy theorists who come up with plausible scenarios for gullible people. It's a waste of time."

But University of Wisconsin assistant professor, Kevin Barrett, said experts are unwilling to believe theories which don't fit into their belief systems.

He said: "People will disregard evidence it if causes their faith to be shattered. I think we were all shocked. And then, when the voice of authority told us what happened, we just believed it."

As the fifth anniversary approached, the 9/11 Scholars for Truth is urging Congress to reopen the investigation claiming they have amassed a wealth of scientific evidence to prove their version of the terror attacks.

The 9/11 Truth Movement's Dangers

Nation: Dishonest Government Leads To Cynical Theorists

According to a July poll conducted by Scripps News Service, one-third of Americans think the government either carried out the 9/11 attacks or intentionally allowed them to happen in order to provide a pretext for war in the Middle East. This is at once alarming and unsurprising. Alarming, because if tens of millions of Americans really

believe their government was complicit in the murder of 3,000 of their fellow citizens, they seem remarkably sanguine about this fact. By and large, life continues as before, even though tens of millions of people apparently believe they are being governed by mass murderers. Unsurprising, because the government these Americans suspect of complicity in 9/11 has acquired a justified reputation for deception: weapons of mass destruction, secret prisons, illegal wiretapping. What else are they hiding?

This pattern of deception has not only fed diffuse public cynicism but has provided an opening for alternate theories of 9/11 to flourish. As these theories — propounded by the so-called 9/11 Truth Movement — seep toward the edges of the mainstream, they have raised the specter of the return (if it ever left) of what Richard Hofstadter famously described as "the paranoid style in American politics." But the real danger posed by the Truth Movement isn't paranoia. Rather, the danger is that it will discredit and deform the salutary skepticism Americans increasingly show toward their leaders.

The Truth Movement's recent growth can be largely attributed to the Internet-distributed documentary "Loose Change." A low-budget film produced by two 20-somethings that purports to debunk the official story of 9/11, it's been viewed over the Internet millions of times. Complementing "Loose Change" are the more highbrow offerings of a handful of writers and scholars, many of whom are associated with Scholars for 9/11 Truth. Two of these academics, retired theologian David Ray Griffin and retired Brigham Young University physics professor Steven Jones, have written books and articles that serve as the movement's canon. Videos of their lectures circulate among the burgeoning portions of the Internet devoted to the cause of the "truthers." A variety of groups have chapters across the country and organize conferences that draw hundreds. In the last election cycle, the website www.911truth.org even produced a questionnaire with pointed inquiries for candidates, just like the U.S. Chamber of Commerce or the Sierra Club. The Truth Movement's relationship to the truth may be tenuous, but that it is a movement is no longer in doubt.

Truth activists often maintain they are simply "raising questions," and as such tend to focus with dogged persistence on physical minutiae: the lampposts near the Pentagon that should have been knocked down by Flight 77, the altitude in Pennsylvania at which cellphones on Flight 93 should have stopped working, the temperature at which jet fuel burns and at which steel melts. They then use these perceived inconsistencies to argue that the central events of 9/11 — the plane hitting the Pentagon, the towers collapsing — were not what they appeared to be. So: The eyewitness accounts of those who heard explosions in the World Trade Center, combined with the facts that jet fuel burns at 1,500 degrees Fahrenheit and steel melts at 2,500, shows that the towers were brought down by controlled explosions from inside the buildings, not by the planes crashing into them.

If the official story is wrong, then what did happen? As you might expect, there's quite a bit of dissension on this point. Like any movement, the Truth Movement is beset by internecine fights between different factions: those who subscribe to what are termed LIHOP theories (that the government "let it happen on purpose") and the more radical MIHOP ("made it happen on purpose") contingent. Even within these groups, there are divisions: Some believe the WTC was detonated with explosives after the planes hit and some don't even think there were any planes.

Critics Demand Resignation of U.N. Official Who Wants Probe of 9/11 'Inside Job' Theories

Critics called for the resignation of Richard Falk, U.N. spec rapporteur on human rights in the Palestinian territories, for bias against Israel and his support of 9/11 conspiracy theories. Critics are calling for the resignation of a U.N. official who publicly supports investigating theories that the Sept. 11 attacks on the World Trade Center and the ntagon were an "inside job."

Richard Falk, the special rapporteur on human rights in the Palestinian territories, investigates alleged Israeli violations of human rights law for the U.N.'s Human Rights Council.

But the former Princeton professor would also like to investigate whether 'some sort of controlled explosion from within" destroyed the Twin Towers, he told FOXNews.com.

"I do think there are questions that haven't been answered, questions about the way the buildings collapsed and the failure to heed a variety of signals that there was danger

coming," Falk said.

"I think [his beliefs are] fruitcake city, but among many delegations to the U.N. it's probably the conventional wisdom," said John Bolton, a former U.S. ambassador to the U.N. known for his straight talk on U.N. hypocrisy.

But Hillel Neuer, executive director of U.N. Watch, a non-governmental organization that monitors the U.N., wants Falk removed from his job.

"He should resign," said Neuer, who raised concerns about Falk's ability to be an objective observer. Neuer has also criticized Falk for being biased against Israel.

"If he were a principled person he would recognize the fact that he has very extreme views," Neuer said.

In 2004, Falk wrote the forward to "The New Pearl Harbor: Disturbing Questions About the Bush Administration and 9/11," a book written by David Ray Griffin, a Sept. 11 conspiracy theorist.

Griffin's book argues that the Twin Towers may have been brought down by a "controlled demolition" — not by two airliners hijacked by Al Qaeda operatives — and that the Pentagon may not have been hit by a plane at all.

Griffin "doesn't take a so-called conspiracy view and he raises questions that haven't been answered." Falk told FOXNews.com. "I think [the book] deserved to be published and I have no

Falk said that while he supports alternative theories behind the World Trade Center attack, he doesn't claim the U.S. government was responsible.

"I'm an agnostic on the issue," he said.

But Bolton is hardly agnostic on the issue of Falk's views.


