### August Primary Election

FBDC President Sally Hirst opened tonight's virtual meeting by noting that it is just 118 days until the November election, but importantly, it is just weeks until the August 18th primary election. Some races will be decided in August; other races will determine the Democratic candidates that move on to the November election.

U. S. Congress 6th District: Voters will determine whether Clint Curtis or Richard Thripp be will face Republican Congressman Matt Waltz in November. Waltz is in his first term. County Commissioner, District 3: The race will be decided on August 18th. Kim Carney and David Sullivan, two Republicans, face no opposition in November.

Other races include School Board, Public Defender, and Circuit Judges, and Committeewomen in Precincts 7 and 19 . In Palm Coast, voters will choose a mayor and two city council members.

## Voter Information

In the run-up to the August 18th primary election, here are some important dates to remember.

**July 20 is the deadline to register to vote, or to update your party affiliation.** To do so, the Supervisor of Elections asks that you consider using Florida's online voter registration system. [RegisterToVoteFlorida.gov/home](https://www.registertovoteflorida.gov/home). For paper forms instead of going online, go in person to the Supervisor of Elections office at 1769 E. Moody Blvd in Bunnell.

**August 3-15 Early Voting takes place at three locations in Flagler County.** (1) Flagler County Supervisor of Elections Office at 1769 E. Moody Blvd in Bunnell; (2) Flagler County Public Library, 2500 Palm Coast Parkway in Palm Coast; and (3) Palm Coast Community Center, 305 Palm Coast Parkway NW in Palm Coast. Early voting polls are open 10am to 6pm.

**August 8 is the deadline to request your Vote-By-Mail ballot.** Vote-By-Mail is highly recommended. It is the safest and easiest way to guarantee your vote is received and counted. **Be sure to mail your Vote-By-Mail ballot on time.** It must arrive at the Supervisor of Elections office by 7pm on primary day, August 18th. A postmark does not extend the deadline.

**To return your Vote-By-Mail ballot in person,** go to the Supervisor of Elections Office in Bunnell. Visit their office or use the Secure Drop Box at the SOE main entrance. During Early Voting, August 3-15, you may also go to one of the three Early Voting sites during polling hours.

## Cori Hermle for County Commission

Cori Hermle, the Democratic candidate for County Commission, District 1, joined our virtual meeting. Cori is running unopposed in the primary; her opponent in the November general election will be Republican Andy Dance. Despite the

complications of running for office during a pandemic which limits face to face contact with potential voters, she has received strong and enthusiastic support in her run for office. She's pushing for government accountability, saying she's concerned about the decisions being made by the current county commission. For instance, the old emergency operations building is now being sold, asking price \$750,000, despite the huge amount of debt, in the millions of dollars, the county took on to buy it and update it. For starters, she says we need to come up with a plan. We need to get a better idea of how we're spending our cash, our taxpayer dollars, especially when we're likely to be facing a horrible economic situation in the years ahead. Another concern for Hermle is quality of life for Flagler County. She says, again, it gets back to the decision making process. Amendments to zoning, last-minute decision making, lack of forethought as to how decisions will affect the the community, potentially burdening the infrastructure. She said, based on work she's done with stakeholder groups, she is concerned about damage to the the environment. She is a state government employee with the Florida Department of Agriculture, working on water supply and water quality issues related to the agricultural industry. She works with them as stakeholders on various different projects. She says there is a way to have growth but it has to be smart. You have to have a plan, she says. She says there is a way to integrate the infrastructure you need, the quality of life you need, while preserving the environment. It means planning it out, articulating the goals, and putting it on paper. And most importantly, sticking to the plan.

## Adopt a Highway

The FBDC cleaned a section of Florida highway on June 17th as part of the Adopt-A-Highway program, removing 150 pounds of trash along State Road 100. Seven members of FBDC cleaned from Colbert Lane near Publix to the intersection of Moody Blvd and A1A. You'll see Florida Department of Transportation signs at both ends of that stretch recognizing the Flagler Beach Democratic Club for its work. One member said he enjoyed the hours he spent in an orange vest picking up trash because it was, during a pandemic, time safely spent with fellow members of the organization, and it felt good to do something positive for the community. The FBDC crew wore masks and practiced social distancing. Sherri Sanders spearheaded FBDC's Adopt-A-Highway effort, and customized our orange vests with FBDC lettering for our first outing. The Republican party has a history of using voter suppression techniques, the effect of which pushes likely Democratic voters off the voter rolls and out of the voting booth. News reports abound about the large Republican war chest that would be used to fuel legal efforts along those lines. To counter that threat, one of the things Democrats can do locally is to become official poll workers, and now, according to Sally Hirst, it is a bit easier to go through the process of becoming one. The Supervisor of Elections will provide the training. Sally said that the process of becoming a poll worker is easier than ever. ## Voter Rights, Voter Disenfranchisement in Florida

On November 6, 2018, nearly 65 percent of Florida voters—more than 5 million people—resoundingly approved Amendment 4, restoring voting rights to over a million of their fellow citizens. Since then, Governor Ron DeSantis has pushed to overturn voter sentiment on the issue. And the latest news isn't good: This month, The U.S. Supreme Court left in place a lower court order that likely will prevent hundreds of thousands of felons in Florida from voting in the November election. FBDC members discussed the issue only briefly at tonight's meeting. We have more recent information below.
