PROCLAMATION HONORING OCTOBER AS ALZHEIMER'S AWARENESS MONTH

In recognition of the more than five million Americans living with Alzheimer's disease and related dementias, 180,000 of whom live in our State of North Carolina.

WHEREAS, Alzheimer's is a disease that currently can't be prevented, slowed or cured; and

WHEREAS, every 66 seconds someone in the United States develops Alzheimer's, which could result in an estimated 210,000 North Carolina residents living with the disease by 2025, 16.7% increase; and

WHEREAS, Alzheimer's disease is the 6th leading cause of death in North Carolina, and kills more people nationwide than breast and prostate cancer combined; and

WHEREAS, the total cost in 2020 of caring for those in the United States with Alzheimer's disease and other dementias is estimated at \$305 billion. By 2050, these costs could rise as high as \$1.1trillion; and

WHEREAS, Medicare and Medicaid are expected to cover \$206 billion or 67% of the total health care and long-term care payments for people with Alzheimer's or other dementias, representing a significant financial commitment from federal agencies and the taxpayers who fund them; and

WHEREAS, despite the contributions to coverage made by Medicare and Medicaid, individual out-of-pocket spending is expected to reach \$66 billion or 22% of total payments this year, a staggering financial responsibility for those afflicted and their family caregivers; and

WHEREAS, family caregivers provide approximately 18.6 billion unpaid hours of care, with 35% of dementia caregivers reporting that their own health has gotten worse due to care responsibilities; and

WHEREAS, it is imperative that there be greater public awareness of this serious public health crisis.

NOW, THEREFORE, I, Mayor M. Steven Morris, do hereby proclaim October 2020 as ALZHEIMER'S AWARENESS MONTH in the City of Rockingham,

and encourage all our residents to learn more about Alzheimer's disease, the impact on those affected, and how the adoption of healthy lifestyle habits may reduce the risk of cognitive decline. The downtown water fountain will be lite in the color purple in honor and memory of those living with Alzheimer's disease for the month of October.
