How do good intentions of a mission go bad? Well, let me tell you of this beautiful staple in the Harlem community called New York City Mission Society. It was used to save many young people for a very long time. It was a place of life, second chances, hope, community, and the cornerstone of love. What every Community Center should be and the multitude fall short. This organization was amazing in its time of good leadership and management. I, Shawanna Vaughn, arrived at New York City Mission at the demise of a once-great hope of the community. The change of guard to new leadership and business practices didn't create a better outcome for an already crumbling infrastructure not of a building but an organizational structure. I worked for a program called Snug, which was guns spelled backward. It was a harm reduction initiative that came out of Chicago, known as Ceasefire. This, I thought, was perfect for me. I was already developing my own grassroots organization and desired more knowledge and training. My belief was that our missions were aligned.

The realization of finding out our missions were incredibly different; the criminal elements of individuals who were employed unaddressed and the safety of others ignored. In a statement by the supervisor of this program, he stated, "we were meant for war because we worked there." I would like to pose a question. Is working at a nonprofit organization in Harlem the same as signing up for the military? Ponder that. But, the fact you did need bulletproof vest on occasion or protective gear in which we didn't have nor combat training when a co-worker put himself in harm's way in front of assault weapons at New York City Mission Society so our lives could be spared that day.

While it looked like the Wild Wild West in a city, state, and federally funded program, the president of this company opted for personal security as we worked in wartime conditions. This atmosphere caused Post-traumatic stress disorder, anxiety, and depression to me and others; who were not part of being a gang member, committing a crime, and causing irreversible harm to young people and a community that is already fragile and fractured. There is an obligation to stand for injustice in our communities, systems, and against organizations that put profit over people. Standing alone and offering truth to dismantle horrific behaviors in this organization, which was once the safety net for the multitude to thrive and become who they dreamed of and create lasting relationships.

Fast forward 2020 currently in a legal battle still trying to attain justice for the injustice that was caused to me as a human being, a woman, and an employee of the New York Mission Society. I've been my own attorney (pro se) an uphill struggle, but I've persevered stayed the course to justice. I need the support of community, parents, and those who fund city, state, and federal programs and hold them accountable for their actions. Taxpayers, I'm speaking directly to you. Tell, New York City Mission Society, it's time to do the right thing. The tactic is still profit over people. Apologies are helpful in Healing; this organization owes workers that, but we will most likely never get one that is genuine. The closure comes in many ways, but for me, compensated through damages is my solace. Let's put people over profit.

She is also a graduate of the State University of New York at Buffalo where she graduated cum laude with a Bachelor of Arts in English. She is admitted to practice in New York State and the United States District Courts for the Southern, Eastern, and Northern Districts of New York. Jodi is a fluent Spanish speaker.
