

## Planned Service Agreement

Your backflow preventer, or vacuum breaker, which has to be installed above ground to meet area requirements, can freeze and burst during winter months. To prevent dealing with cracked pipes, gushing water, and high repair bills, we offer a Planned Service Agreement.

Simply complete the slip below and mail it, with your payment, back to ensure you are included on our automatic call lists.

**OPTION # 1 - An annual fee of \$150 for two yearly visits, including one walk through.**

# 1 - Spring Turn-On & Walk Through

(\$35 savings on scheduling separate)

We will call ahead and schedule a time for a technician to come to your home, walk through the system, making adjustments and repairs as needed, leaving your controller appropriately set for spring.

\*\* Includes one hour of labor. All parts used during this visit will be billed separately. \*\*

# 2 - Fall Winterization

This visit consists of a basic shut down to make sure no water remains in your vacuum breaker for winter.

\*\* Louisiana laws now regulate all running vacuum breakers be tested annually to ensure there is no chance of backflow of grey water into the city water lines. One of the above visits can include that test and submittal of all needed reports to the city, as long as it's noted prior to the visit.

Should repairs be needed to get the unit to passing, those parts will be billed outside the scope of this agreement. \*\*

**OPTION # 2 - An annual fee of \$110 for two yearly visits.**

(\$40 savings on scheduling separate)

# 2 - Fall Winterization

\*\* Neither visit includes the cost of a walk through or controller check. Our technician will leave a visitation slip as documentation of his visit to your home. All calls outside of this basic agreement will be billed separately. \*\*

By being listed as a Service Agreement Customer, you will be given priority over other customers, should you require a visit between the two listed above. All service calls outside the scope of this contact will be charged to the residence accordingly. This contract will run from the month in which it is returned to that month in the following year. An option to renew will be mailed upon expiration so you never have to worry about missing a scheduled visit.

TERMS: This contract is non-refundable. In case of move, it may be transferred to the new homeowner during sale or to your new home. If your property is commercial or over ten zones and requires two technicians, the second tech is at an additional charge, to be billed with parts used on site. (If one tech visits it would take him over an hour, resulting in additional charges as well.) We service all of Louisiana, but additional charges for extended drive times may apply for those outside our regular area.
