**ARTICLES OF ORGANIZATION
OF

The undersigned, being at least 18 years of age and being authorized to execute and file these Articles of Organization, hereby certifies to the Maryland State Department of Assessments and Taxation that:

FIRST: The name of the limited liability company (hereinafter referred to as the "Company") is Strong By Siegel, LLC.

SECOND: The purposes for which the Company is formed is to engage in any lawful business permitted by the Maryland Limited Liability Company Act, as amended from time to time.


