COIFFE HIGHLIGHTS/NEW ITEMS

- Our audit team has been working on the rulemaking hearing which was held on August 15th. We did have one of our team members at the meeting and spoke live about the changes we were proposing. Several other members attended online and got a chance to comment as well. From our last newsletter we mentioned that our goal for trying to add to the rules has to do with the Risk Limiting Audit (RLA) used in Colorado. We just found out last week that the members of the rulemaking committee announced their decisions, but did not decide to add any of our suggested changes. Knowing that information we are now looking into whether filing some sort of lawsuit will be our next move. Without the changes in the rules our audit team feels that the canvass board in all the counties of Colorado cannot certify the election. We are contacting the Colorado GOP to see what their thoughts are on this subject. We will continue to keep you updated in our future newsletters.
- The Secretary of State has compiled 14 Ballot Measures that will be in this year's election. Included is a link to the 2024 State Ballot Information Booklet (Blue Book) https://leg.colorado.gov/publications/2024-blue-book-english. It is long and detailed but very important for all our volunteers to read and understand what you will be voting for. Of special note is Proposition 131, which is the Ranked Choice Voting (RCV) ballot measure. Please refer to page 52-56 to read about the pros and cons of RCV

- and we hope you will see why, we believe, it is a terrible choice for Coloradoans.
- COIFFE Committee volunteers spent 1½ hours on a presentation put together by Kris Jurski from The People's Audit, his website is the-peoples-audit.org. We hope everyone will go to his website and see the great work that Kris and his organization have done to help identify real change in the voter rolls in the states in which he has done his work. We plan to work towards getting him to help us in Colorado.
- Task Force Progress Update: United Sovereign Americans (USA) has filed nine lawsuits in Federal District Courts in the following states: MD, PA, OH, FL, TX, NC, MI, CO & GA. Lawsuits are filed against Secretaries of State or Election Boards, Attorneys General, and the United States Attorney General. The Writ of Mandamus is appropriate and necessary to justify the rights of citizens when a governmental agency or official has refused to perform a ministerial duty that the Petitioners has established, has a clear legal right, to have the governmental agency or officials, in this case Respondents, perform to ensure mandating accurate registration rolls, transparency, compliance, and proper certification of the voting systems and elections.
