Several members of COIFFE's Executive Committee are currently involved in defeating Ranked Choice Voting (RCV) in Colorado. We are fighting against Kent Thiry's proposed RCV initiatives. The false narratives are many, and they must be debunked. Join this serious effort today! Thiry's proposed changes will fundamentally eliminate the political parties and the current election system in CO. Grassroots activists are countering that offensive with three common sense initiatives:

- 1. Initiative 201: Prohibit Ranked Choice Voting (aka "Instant Runoff Elections") in CO,
- 2. Initiative 202: Preserve Ballot Access through Caucus and Assembly,
- 3. Initiative 278: Close Primaries.

Signatures need to be collected from 2% of each of Colorado's 35 Senate Districts no later than July 31st. We need volunteers to collect signatures in their <u>Senate District</u>. Please contact the <u>Good Initiatives Team</u> to volunteer. We need all hands on deck!

COIFFE HIGHLIGHTS/NEWS

◆ Task Force: On May 17, 2024, Maryland Election Integrity LLC and United Sovereign Americans (USA) filed a Notice of Appeal to the United States Court of Appeals for the 4th District in response to the lower court's refusal to hear the case based on standing. USA moved forward in Colorado by submitting a formal Complaint to the Secretary of State's office at the Capitol on May 8th. We did not receive a response to that SOS complaint within the requested timeframe of ten business days. Therefore, Suspicious Activity Reports (SAR) requesting investigations were filed on May 23rd with the following agencies: CSP Investigative Services, Colorado AG, FBI Civil Rights Division, DOJ and DHS. The Task Force's current major focus: fundraising, media exposure and education by presentation of the "Colorado Resolution" document. Funding for upcoming Federal District Court lawsuits continues to be high on the list of priorities.

- ◆ In the last month COIFFE volunteers have successfully searched for deceased voters on the Colorado voter rolls. At our last Volunteer Zoom meeting, DeAnn Jacobs and Mila Shusterman briefly presented and discussed their experiences using EagleAl and we thank them for their time, knowledge and dedication.
- ◆ Non-citizen voting continues to be a growing concern. Last week, Cleta Mitchell of www.whoscounting.us presented at a press conference with Speaker of the House Mike Johnson, Congressman Chip Roy (TX), Senator Mike Lee (UT) and several others to introduce the SAVE Act which clarifies proof of citizenship to be a registered voter in the US.
- ◆ Last month we introduced you to an <u>Epoch Times article</u> on the history of Colorado turning blue. In the article, two resources were mentioned that we highly recommend: <u>Rocky Mountain Heist</u> and <u>The Blueprint: How Democrats Won Colorado</u>.
