GROOMING POLICIES, PROCEDURES AND PETS RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT (AGREEMENT)

In consideration for grooming, training, and other services (herein after "Services") at Riverview Kennel LLC, I make the following representations and agree to all of the following policies, terms and conditions:

- 1. **CONSENT.** I entrust my pet to Riverview Kennel LLC for the purpose of Services. I understand and am aware that all due care will be taken with my pet for the safety of the pet and employee, contractor, or other agent providing Services. I am aware that neglect of my pet's coat can be a cause for problems after grooming such as clipper/brush irritation. If my pet is wiggly or doesn't remain still during grooming, accidents can happen such as nicks/scrapes from clippers or scissors.
- 2. **VACCINATIONS.** I certify that my pet, if over six months of age, is currently vaccinated against rabies. I agree to disclose if my pet's rabies vaccination is expired and understand that I will be refused service if proof of my pet's rabies vaccination is not provided prior to Services. Riverview Kennel LLC will only accept proof of rabies vaccination in writing from a licensed vetrinarian. Other vaccinations including bordetella and distemper are highly recommended; however are not necessary for receiving Services. If my dog or cat does not have a distemper or bordetella vaccination I assume the risk of a disease that may be dangerous or even deadly to my pet. Riverview Kennel LLC is not responsible for my pet's contraction of any such infectious disease.
- 3. MATTED COAT. I am aware that if my pet is receiving grooming sercies and its coat is matted, the coat my have to be partially or completely shaved down to remove matting depending upon condition. I grant Riverview Kennel LLC and its employees full discretion to determine if my pet's coat contains matting and how to best remedy it. Additional charge may apply depending on the severity of matting.
- 4. **PERSONAL PROPERTY.** I understand that Riverview Kennel LLC shall not be responsible or liable for any lost, stolen, or damaged personal property belonging either to my pet or me.
- 5. CANELLATION POLICY. I understand that I may be charged a \$25 fee, if I fail to cancel my grooming reservation 24 hours in advance.
- 6. **RIGHT TO REFUSE SERVICE.** Riverview Kennel LLC has the right to refuse service for any reason. In the event that a pet cannot participate or receive Services safely without danger to the groomer/employees/others Riverview Kennel LLC may use muzzles, e-collars, slings, straps, etc. Services may be stopped before completion if necessary for the safety of the pet or groomer/employee/other. Service fees may still be applied in this event.
- 7. **ABANDONED PETS.** No pet may be abandoned at Riverview Kennel LLC. I agree that I will not neglect to pick up my pet from Riverview Kennel LLC by the time she/he is scheduled to leave without providing notification. If my pet is left at Riverview Kennel LLC without any contact or instructions from me of the ability, willingness or plans to pick him/her up it will be considered abandoned upon the fifth day of such notification failure. I understand that if I abandon my pet at Riverview Kennel LLC, Riverview Kennel LLC will become the legal owner of the pet. Riverview Kennel LLC will, in its sole discretion, determine whether to try to rehome or adopt out the pet from the Riverview Kennel LLC location at which he/she was abandoned or will relinquish the pet to an animal shelter or appropriate authority of choice. I FULLY UNDERSTAND AND AGREE THAT IF I ABANDON MY PET AT RIVERVIEW KENNEL LLC, I MAY BE UNABLE TO RETRIEVE POSSESSION OF MY PET AND WILL HAVE NO RECOURSE AGAINST RIVERVIEW KENNEL LLC.
- 8. **PET PHOTOS AND VIDEO RELEASE.** I agree to allow Riverview Kennel LLC, its owners, employees, officers, directors and agents to use my pets name and any images or likeness of my pet taken while he/she is at Riverview Kennel LLC, in any format or form, for use, at any time, in any media, marketing, advertising, illustration, trade or promotional materials. I agree that this provision shall be binding on me and all of my successors, heirs, legal representatives and assignees.
- 9. **DUTY TO DISCLOSE.** I have disclosed and will continue to disclose on an ongoing basis, any and all medical or other conditions, including personality concerns or behaviors that may affect my pet's ability to participate in Services. I agree to waive any claim against Riverview Kennel LLC pertaining to harm, injury to, or loss of my pet that may be related to or caused in part by any preexisting health-related or medical condition of my pet.
- 10. REFUNDS. Refer to the Riverview Kennel LLC Return Policy.
- 11. ACCEPTANCE AND ACKNOWLEDGEMENT OF PARTICIPATION RISK. I FULLY UNDERSTAND THAT, a) THERE ARE INHERENT AND POTENTIAL RISKS INVOLVED WITH INTERACTIONS BETWEEN HUMANS AND PETS, AS WELL AS BETWEEN PETS AND OTHER PETS, WHICH MAY RESULT IN PROPERTY DAMAGE OR BODILY INJURY, INCLUDING BUT NOT LIMITED TO, PERMANENT DISABILITY, SICKNESS OR DEATH TO HUMAN OR PET; AND b) THERE MAY BE OTHER RISKS NOT KNOWN TO ME NOR READILY FORSEEABLE AT THIS TIME. I FULLY ACCEPT AND ASSUME ALL RISKS AND RESPONSIBILITY FOR ALL RISKS, INCLUDING AND WITHOUT LIMITATION, ALL LOSSES, COSTS AND DAMAGES INCURRED AS A RESULT OF MY PET PARTICIPATING IN TRAINING/GROOMING, INCLUDING ANY VETERINARIAN EXPENSES INCURRED ON BEHALF OF MY PET. SICKNESS SHALL BE DEFINED TO INCLUDE ANY ILLNESS INCLUDING BUT NOT LIMITED TO BORDETELLA OR ANY OTHER FORM OF CONTAGIOUS ILLNESS.
- 12. **VETERINARIAN LIABILITY AND CARE.** I agree to allow Riverview Kennel LLC to obtain medical treatment for my pet, if, in its sole discretion it appears that my pet is ill, injured or exhibits any other behavior that would reasonably sugges that my pet may need medical treatment. I agree to be fully responsible for the cost of such treatment.
- 13. WAIVER, RELEASE AND INDEMNIFICATION. I HEREBY AGREE TO EXPRESSLY AND FOREVER GENERALLY WAIVE, DISCHARGE CLAIMS, INDEMIFY, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS, AND DEFEND RIVERVIEW KENNEL LLC, THEIR INVITEES, SPONSORS, ADVERTISERS, OWNERS, OFFICERS, DIRECTORS, EMPLOYEES, VOLUNTEERS, AGENTS, REPRESENTATIVES, LEASORS, AND ALL OTHERS HAVING INTEREST IN RIVERVIEW KENNEL LLC FROM AND AGAINST ANY AND ALL INJURY, LIABILITY, CLAIMS, LITIGATION, ACTIONS, SUITS, COSTŚ, LOSSES, DAMAGES, ATTORNEY'S FEES, EXPENSE, OR DEMANDS OF EVERY CHARACTER WHATSOEVER ON THE ACCOUNT OF, ARISING OUT OF RESULTING FROM OR RELATING IN ANY WAY TO ANY ACT OR OMISSION OF THE RELEASEES, INCLUDING NEGLIGENCE, AND MY OR MY PETS PARTICIPATION AT RIVERVIEW KENNEL LLC OR OTHERWISE. I AGREE THAT THIS RELEASE SHALL BE BINDING ON ME AND MY SUCCESSORS, HEIRS, LEGAL REPRESENTATIVES, AND ASSIGNEES. I ALSO EXPRESSLY AND FOREVER RELEASE RIVERVIEW KENNEL LLC FROM ANY DUTY TO PROTECT ME OR MY PET(S) FROM INJURY OF ANY KIND, AND AGREE THAT EVEN IF RIVERVIEW KENNEL LLC CHOOSES TO IMPLEMENT SAFETY PRECAUTIONS, SUCH ACTIONS SHALL NOT ALTER THE FACT THAT I HAVE RELEASED RIVERVIEW KENNEL LLC FROM ANY DUTY TO PROTECT ME OR MY PET(S).
