Motion by Roy Helms, second by Denise Rohan that resolution 1.2024 is in proper form as amended. <u>Motion Carried.</u>

The first whereas clause added the word 'to' after responders and changed 'survivors to' to 'survivors of'.

Motion by Roy Helms, second by Wayne Jensen that resolution 1.2024 is germane to The American Legion. <u>Motion Carried.</u>

Motion by David Gough, second by Ted DeMicchi to recommend approval of resolution 1.2024. <u>Motion</u> <u>Carried.</u>

Motion by Ted DeMicchi, second by Al Richards to forward resolution 1.2024 to the Veterans Affairs & Rehabilitation Convention Committee. <u>Motion Carried.</u>

Resolution 2.2024- Extend Access to Veterans Affairs benefits and healthcare for Military Responders and Survivors of the Terrorist Attacks on 9/11/2001 at the Crash Sites in New York, Pennsylvania, and Washington DC.

Resolution 4.2024- Amending Title 4 of the United States Code to provide for the display of United States Flags on the graves of veterans of the United States Armed Services

Motion by Al Richards, second by Ted DeMicchi to forward resolution 4.2024 to the Legislative Convention Committee. <u>Motion Carried.</u>

Motion by Roy Helms, second by Denise Rohan that resolution 5.2024 is in proper form.

Bob Shappell questioned the word attacked in the whereas clause, due to national's rules regarding wording in resolutions. Denise Rohan stated that there was a National Resolution passed last year stating the same thing.

Motion Carried.

Motion by Denise Rohan, second by Ted DeMicchi that resolution 5.2024 is germane to The American Legion. <u>Motion Carried.</u>

Motion by Al Richards, second by Wayne Jensen to recommend rejection of resolution 5.2024, as resolution 20, passed at the 2023 National Convention, covers the same thing. <u>Motion Carried.</u>

Motion by Ted DeMicchi, second by Bob Batty to forward resolution 5.2024 to the Resolutions Convention Committee. <u>Motion Carried.</u>

Resolution 6.2024- Membership Committee Structure Change

Motion by Roy Helms, second by David Gough that resolution 6.2024 is in proper form. Motion Carried.

Motion by Ted DeMicchi, second by Al Richards that resolution 6.2024 is germane to The American Legion. <u>Motion Carried.</u>

Ted DeMicchi asked for clarification regarding 'must be represented at the membership meeting'. Denise suggested changing the wording to 'should'. Roy suggested the wording 'all Districts are encouraged to be'.

Motion by Wayne Jensen, second by David Gough to recommend Rejection of resolution 6.2024. <u>Motion</u> <u>Carried.</u>

Resolution was rejected due to the 2^{nd} to the last resolve clause. Wayne Jensen stated that he is in favor of the current structure of the committee and that is why he made the motion.

Motion by David Gough, second by Roy Helms to reconsider the motion. Motion Carried.

Motion by Ted DeMicchi, second by David Gough to recommend Rejection of resolution 6.2024. <u>Motion</u> <u>Carried.</u>

Rejection due to current writing with recommendation to re-write the resolution with removal of the second resolve clause.

Motion by Ted DeMicchi, second Al Richards to forward resolution 6.2024 to the Constitutional Amendments Convention Committee. <u>Motion Carried.</u>

Resolution 7.2024- Wisconsin Recognition of Employer of the Year

Denise explained the difference between the National Award and what this award could do. Anderson Window for example, cannot verify their percentage of veterans, which is a requirement for the National Award.

Motion by Ted DeMicchi, second by Wayne Jensen to recommend approval, with changes, of resolution 7.2024.

In final whereas clause change 'Many of these employers will not be competitive in The American Legion National program because they have a percentage number of veteran employees that is not competitive in the National American Legion selection' to 'Many of these employers will not be competitive in The American Legion National program because they are unable to verify the percentage number of veteran employees that is competitive in the National American Legion selection'

In the first resolve clause change 'Applications for the award shall be available in the Posts annual packets.' to 'Applications for the award shall be available on the Department Website, wilegion.org.' and change 'Chairman of the Veterans Employment Committee in' to 'Veterans Employment Chair on'.

Motion Carried.

Resolution 8.2024- Chairman of Cremated Remains
