## **Members and Trainers Rights & Responsibilities:**

- If dangerous or inappropriate behavior on or off the horse by a member is reported in writing to the Board, the member will be subject to Board review and possible loss of membership.
- Unsafe or illegal behaviors may result in consequences from the PBEA Board.

- Be respectful and support the PBEA Board and its decisions. Be courteous when presenting different ideas or when disagreeing with other club members.
- Be considerate of those contributing their time to put on Events and maintain the Park. Be courteous to Officials, Organizers and Volunteers.
