**Definitions**

% = % (w/w) = Percent (weight of analyte / weight of product). ND = None Detected (defined by dynamic range of the method).

Percentage of Delta 9-THC on a dry weight basis = The percentage of Delta 9-THC by weight in cannabis item after excluding all moisture from the item. Total Potential Delta 9-THC or CBD is calculated to take into account the loss of a carboxyl group during decarboxylation step, using the following formulas: Total Potential Delta 9-THC = Delta 9-THC + (Delta 9-THCa \* (0.877)) and Total CBD = CBD + (CBDa \* (0.877)). Fail equates to a concentration level of Delta 9-THC, on a dry weight basis, higher than 0.3 percent + or - the measurement uncertainty.
