### First Nation Administrative Law

We are in the process to be accredited for the First Nation Administrative Law, by the Fiscal Management Board.

What does this mean?

We, the Lytton First Nation had to have the Financial Administrative Law, which included updating several policies, Finance, Human Resource, and Operation Manual, Threshold and Whistle Blower policy. This led into the band to apply for the 10-year grant funding from Indigenous Service Canada.

The 10-year grant gives the band security to plan for program and projects, be eligible to work with banks or finance institutions for more funds/loans to enhance our financial planning to implement goals and objectives.

This is where the management and policies are in place and create transparency and accountability to the chief and council and community.

"The First Nation Health Authority (FNHA), Health Benefits' has designed this check list to process your medical transportation travel and /or reimbursement request in a timely manner. Correct completion of the required forms and associated documentation is crucial to ensure that your travel and /or reimbursement is processed quickly and efficiently.

- <u>1.</u> Request for Medical Transportation Form & Client Responsibility
- This form must be filled out and submitted to our office at least five (5) days prior to your appointment to ensure enough time for our office to make your travel arrangements.
- •The forms you can come and fill out at the New LFN Health Center, or you can pick-up at the LFN Band Office and leave it in my box at the band office.
- •Attend their medical appointment as scheduled. Clients who do not attend medical appointments may be required to pay back any benefits they have received and /or pay for their travel costs on subsequent medical travel.
- Give notification when cancelling an appointment prior to the date of the appointment: including 24 hours' notice to cancel any hotel arrangements.

The following documentation must also be submitted along with the Medical Transportation request form:

- **a**. Documentation from a doctor's office confirming your upcoming appointment complete with date and time.
- **b.** Copy of the physician's referral including the office address, date, time, and reason for the appointment (if applicable) FNHA, Health Benefits funds travel to the nearest appropriate health professional and/or health facility. Depending on the nature of your appointment, medical justification may need to be provided to support your travel request.

Note: Clients who do not provide enough notice may be required to reschedule their appointment or pay for the travel and get reimbursed. Purchase orders are for Emergency travel only and must be used up within that week.

### 2. Confirmation of Attendance Form

After your appointment is complete, this form must be stamped by the physician and/or signed by the physician where you attended your appointment confirming your attendance. Please ensure that the date and time of your appointment have also been included on the form. If the section regarding pending appointments is completed by the same doctor, this will eliminate the need to obtain another confirmation of appointment.

Clients are to hand in the Confirmation Attendance Form for confirming their appointments for any future travel. Please ensure your name, DOB and current date is on the Confirming Attendance form when you return it. So, that I know who it belongs to. Travel expenses will not be reimbursed without the written confirmation of attendance.

Medical Transportation Policy Framework - Non-Insured Health Benefits Program "EXCLUSIONS" Criteria – Certain types of travel, benefits and services will NOT be provided under the NIHB Program under any circumstances and are not subject to the NIHB appeal process. These include assistance with:

- **1.** Compassionate travel;
- **2.** Travel for clients residing in an off-reserve location
- **3.** Where the appropriate health services are available locally;
- **4.** Appointments for clients in the care of federal, provincial or territorial institutions (e.g., incarcerated clients)
- **5.** Court-ordered treatment/assessment, or as a condition of parole, coordinated by the justice system;
- 6. Appointments while travelling outside of Canada
- **7.** Travel for the purposes of a third-party requested medical examination;
- **8.** The return trip home in cases of an illness while away from home other than for approved travel to access medically required health services;
- **9.** Travel only too pick-up new or repeat prescriptions or vision care products;
- **10.** Travel to access health related services that are not identified in section 1.3, unless coordinated;
- **11.** Payment of professional fee(s) for preparation of doctor's note/document preparation to support provision of benefits;
- **12.** Transportation to adult day care, respite care and/or interval/safe houses.

### 1) Travel for eye exam covered by MSP/FNHA

**A.** When a client has an appointment with an optometrist/ophthalmologist for eye exam by MSP/FNHA, them travel is funded to the closest appropriate health professional/facility via the most economical means. If the service is available locally (i.e. visiting optometrist), then no travel is required. If client is requesting travel to a farther place, then submit a Benefit Exception management's review. Medical justification is required. Please fax the Benefit Exception and supporting documentation to FNHA at 1 604 666 0292. You will have to call the optometrist/ophthalmologist to find out if the eye exam is billed to MSP or FNHA, then ask for the prior approval number.

- 2) Travel is not funded if the eye exam is not covered by MSP/FNHA.
- **3)** To make it easier please have the Optometrist mail your glasses to you.
- 4) Travel to pick-up glasses is an "exclusion" of the program not a benefit and not appealable"



"The Social Development department receives financial assistance from the Indigenous Service Canada for Income Assistance and Assisted living on the fiscal year basis and now our funding is changed the 10-year grant system. The Social Development department follows the Income Assistance Regional social development policies and procedures handbook.

Social Development has been working with other departments within Lytton First Nation on updating the Comprehensive Community Plan 2017-2022 which is updated annually.

October 2,3,4, 2019 Cheryl Jumbo and Bernadine Paul attended 3 day training workshops with Indigenous Service Canada for the Income Assistance Regional Social Development policy and procedures Handbook Training. The session included an overview of the BC Region Social Development policy and procedures handbook chapters 1-12 including best practices, compliance and reporting for Social Development Managers.

The training was very informative for there have been a few changes that benefit clients on Income Assistance and Assisted Living program.

October 17, 2019 Bobby L. Jumbo, Finance Manager, Bernadine Paul, Financial Assistant, Steve Wilson, Band Administrator, Niakia Hanna, Councillor Finance Committee member attended Forum in Richmond for BC New Fiscal Relationship 10-Year Grant Recipients.

The forum was attended by other First Nation Bands, Indigenous Service Canada Funding Service officers, Lands, Capital, Economic Development Program officers, and Financial Management Board staff. This was an informative workshop and I am happy to say that the Lytton First Nation is doing very well with the operations of the Lytton First Nation Administration office and Chief and Council work well as a Team, especially on the Comprehensive Community Plan 2017-2022.

Through the Comprehensive Community Plan the Social Development department formed a committee that meet on a monthly basis. Listed below are the committee members. The Social Development committee had the first committee meeting July 16, 2019 and had reviewed the draft terms of reference and recommended changes and appointed the Chair and Co-Chair discussed the Social Development Community Comprehensive plan updated scheduled next meeting for Sept 12, 2019. The committee will meet on a monthly basis or have at least 9 months annually.

The Committee met again and will make recommendations for Chief and Council's final approval for the Terms of reference and apply for funding for a receptionist with the Social Development Department will be advertised upon approval of funding.

To date there are 30 community members that receive Level 1 Home Support from the home support workers listed above.

The social development staff met with Lisa Colwell who is the Home Care Nurse from Tl'Kemstin Community Health Centre to work together on updating the client files we created a list for the Home Support clients and filled the forms out for Lisa, she will schedule appointments with the clients to prepare assessments and return to the Social Development department for the client files. Lisa Colwell and Stacey Thom have recommended that we should have another nurse in Lytton.

A friendly reminder that the monthly renewal forms must be signed on the 15<sup>th</sup> of every month. Incentive hours have been reduced to 20 hours.

Good food bags for clients that are parents, families and elders that start in October and ends in July each season. The bags are delivered on the 3rd week every month.

The Social Development department is recruiting income assistance clients that will help bag and deliver the good food bags we require 3 drivers and 3 people for bagging the food. If you are interested, please call the social development department during regular business hour Monday to Friday from 8:30 to 4:30 at 250-455-2301.

In the social development department and fill out forms and sign budget and decision forms this required
for the reporting of finance of income assistance.



Death Benefits as of January 2017 LFN Social Development department is requested from Indigenous Service Canada to start filing for the Canada pension death benefits, this benefit is used to assist with the Burial costs, Funeral arrangements for the lost loved ones.

The Social development department had coordinated a Chinese auction to help pay for the annual Christmas parties for the youth and elders. We would like to thank the other program departments that donated items for the auction as well the Community members that donated and volunteers that supported this fundraiser, we thank you for your support and contributions.

Social development hired a Community Event planner that is responsible for planning all the Christmas activities which include the annual Christmas parade, Elders' dinner, children's dinner and staff dinner.

Should any community members would like to volunteer please contact Yvonne Dixon during regular business hour at 250-455-2304.

Bernadine Paul signed up for the Community Volunteer Income tax program which is available to unemployed people or on income assistance or on pension. I finally have the ufile programs working properly now and still learning the programs I thank you in advance for your patience while waiting for your income tax, some community members have not done their income taxes for 5 years or more.

I also provide support to community members with old age pension, Canada pension plan, Guaranteed income supplement applications. Again, thank you for your patience greatly appreciated.



"LFN Community Comprehensive Planning was very informative, update for our Band members.

I have extra copies of the new Bill S-3, that is where Great Grandmother's and Grandmothers that were removed from the band(s) due to marriage or had children with non-registered man.

Applications to register Newborn, adults & children is also available online under https://lfn.band and the Guarantor form you will also need. I have done approximately 250 Secure Certificate of Indian Status (SCIS), approximately 30 returns due to the photo, I recommend if you are travelling in from out of town to bring in 2 passport photos from either Walmart, Cosco.

Please use darker colored tops when coming in, no florescent colours, makes the background dark, which is unacceptable back East. Reminder to call in when coming so that I can prepare your paperwork, especially if I have to do both cards for you!

If you would like a 5-year card done for your child for travelling across the border I would recommend you bring in 2 passport photos.

Adult SCIS is good for 10 years, children(s) is good for 5 years, for adults even if your recent card is not expired for a few years you can apply for 10-year card.

LFN members \$5.00 for SCIS and CIS, Non LFN members \$20.00 (SCIS), \$50.00 CIS

If you have received your new SCIS there is a 9 digit number on the back, please put that in a safe keeping place, because if you lose it you will have to contact INAC, at 1-800-567-9604 before another card can be re-issued.
