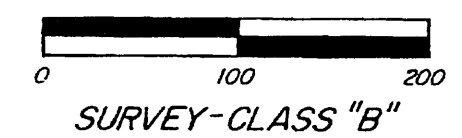

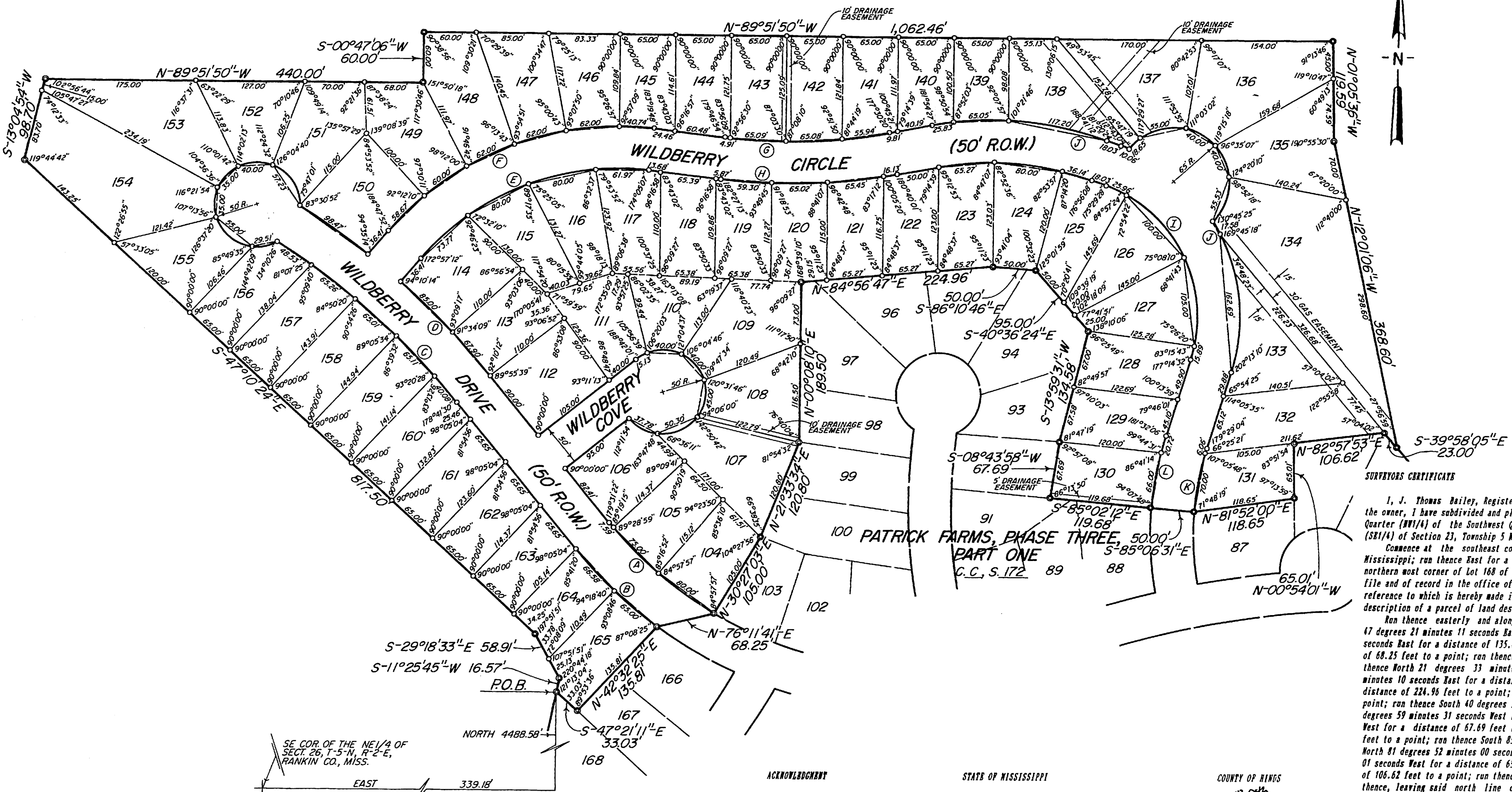

Feet Wide Utility Easement In Certain Areas.

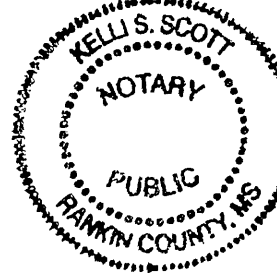

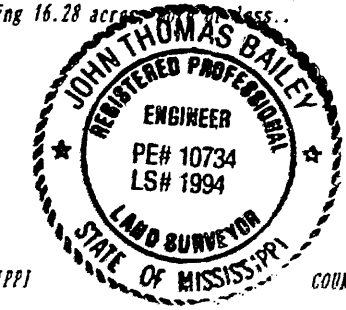
