Carlton Williams, Our Clean and Green Czar For Philadelphia Was Special Guest At Last N. 22nd Street Biz Association Meeting

Business Owners along the North 22nd Street Business Corridor and throughout the Allegheny West community of North Philadelphia, if you missed the last North 22nd Street Business Association Meeting, you missed a special one. In December of 2023, then Philadelphia Streets Commissioner Carlton Williams came out with a team of his staff from the Streets Department, to talk with our business owners about how we can best attack the trash problem, littering and illegal dumping that has seen a major increase in the last 6 months or so, in our community. We invited Commissioner Williams to help us figure out what can we do differently, to try and keep our business corridor and our community looking cleaner than it does. Commissioner Williams said the first thing is, "Business owners do have to take responsibility for outside in front of your place of business. Whether you dropped the trash or not, as a business owner, you are responsible to clean -up in front of your own store. You have to be mindful how you put your trash out and when you put your trash out. You need to have good trash cans with tops to the trash cans that fit. Keep tops on your trash cans. Tops on trash cans certainly help keep rodents and other stray animals from getting in the trash and making matters worse. Also, business owners like other citizens in Philadelphia should only put your trash out on the day in which trash is collected for where you live or work. If you have to use some trash bags, once your trash cans are full, make sure you tie the trash bags up tightly, again in an effort to try and keep stray animals out. Until it is your trash collection day, trash receptacles should be stored behind your business, not on the front sidewalk where customers and area residents have to walk by your trash, smell your trash and have to be forced to look at it, simply because its right there in your face. We want to be supportive of business owners in Philadelphia. However, we need you to support your city. You can do that by following simple sanitation rules. For business owners who want to ignore what the city is asking you to do, you will start seeing first a citation/warning and then tickets will start being written against your address, if you don't clean up in front of your business and if you put trash out before the scheduled collection day".

City of Philadelphia Commercial Recycling Fact Sheet for Businesses and Building Owners

Section 10-724 of the Philadelphia Code requires operators of all commercial institutional, and industrial properties-including residential buildings with more than six dwelling units-to establish recycling services and educate tenants and employees about recycling. This requirement saves money, resources and the environment.

Building Owners/Operators Responsibilities Include:

Establishing adequate recycling services. Contact your current waste hauler or shop around for the best deal on recycling services. You may be able to cut costs by reducing the size or collection frequency of your trash service.

Filing a Commercial Waste Report: List the materials collected for recycling and name your contracted waste and recycling hauler(s). File your Commercial Waste Report at CommercialWaste.Phila.gov.

Share the Report: Post your Report Certificate in a place where everyone can see it. Educate your tenants and employees with signs and fliers showing what they can and cannot recycle. Download these materials and discover additional resources at Phila.gov/programs/recycling-program/resources.

Follow these steps and being compliance with the recycling law.

Who is Responsible?

All building operators are responsible for complying with the Code. An operator is any person or entity that arranges for the collection of waste and recyclables in a building, in some cases, buildings have more than one operator.



Recyclable materials include: plastic bottles, paper, cardboard, food & beverage cans, food & beverage cartons, glass bottles & containers.

Enforcement:

Officers from the Streets and Walkways Education and Enforcement Program (SWEEP) will be inspecting commercial properties to ensure compliance. Penalties include fines of up to \$300/day.

Sweep Officers will be looking for two things: Source separation of recyclable material and evidence that your Commercial Waste Report has been filed and shared. Mixed waste processing, or separating recyclables form trash "back at the plant," is NOT practiced legally in the Philadelphia region. If your hauler tells you, it's ok to mix recyclables with waste, find another hauler.

The Philadelphia Recycling Office offers free services to help businesses waste less, recycle more and comply with the City's recycling law. For more information call Philly 311. 
