Regular Monthly Meeting**

June 8, 2017

Minutes

The regular monthly meeting of Sangamon Township was called to order at 7:00 p.m. by Supervisor Kathleen Piatt. Roll call was taken. Mike Nolan, Kathleen Piatt, Bill Olson and Steve Harper were present. John Foley was absent.

Debbie Marshall-Clerk, Larry Sebens-Highway Commissioner and Brent Buckalew-Assessor were also present.

The pledge of allegiance was recited.

Public Comment:

Thomas Scott announced that the Historical Champaign Havana Railway Society is gathering railroad ties to lay and connect White Heath to Champaign by rails.

Minutes:

A motion to approve and accept the regular monthly May 2017 minutes was made by Bill Olson and seconded by Steve Harper. With no discussion, all were in favor.

Invoices:

A motion to approve invoices was made by Steve Harper and seconded by Mike Nolan. Mike asked if the cost to retain our bookkeeper will decrease. As the information is organized, the cost will go down. With a roll call vote of 4 ayes and 0 nays, the motion to approve invoices passed.

Announcements/communications:

Kathleen contacted F.E. Moran regarding the existing security system at the Township building. We would like to discontinue the service. However since we signed a contract, the best they can do credit us \$150--and we must pay monthly until the contract expires in 17 months. Also under consideration is cancelling the landline to the Township building and establishing a Township email address. Kathleen made arrangements to pay the Highway departments' employees medical insurance a month in advance so there is no possibility of a delinquent month.

Debbie shared a thank you from the Paul Branch family for our memorial gift of flowers. Paul had served as a longtime Supervisor of Sangamon Township.

Larry plans to buy a used skidsteer to work on road edges. This could also lead to sharing equipment with Piatt County if the county buys a grinder.

Kathleen read aloud the Ordinance establishing a prevailing rate of wage for construction work. Bill Olson made a motion to accept the ordinance and Steve Harper seconded it. With a roll call vote of 4 ayes and 0 nays the motion passed.
