

**Sangamon Township  
Regular Monthly Meeting**

**Held at Sangamon Township Building, 1264 Old Rt 47 White Heath Illinois**

***June 14, 2018***

The regular monthly meeting of Sangamon Township was called to order at 7:00 p.m. by Supervisor Kathleen Piatt. Roll call was taken. Kathleen Piatt, Mike Nolan and Bill Olson were present. Steve Harper and John Foley were absent.

Debbie Marshall-Clerk and Larry Sebens-Highway Commissioner were also present.

The pledge of allegiance was recited.

**Public Comment:**

Sally Nolan (who maintains our website) is working with “Go Daddy” on our website. Beginning July 1<sup>st</sup>, they want everyone who uses their service to update to SSL. Anyone who doesn’t will appear as unsecure and Google will put them at bottom of list when folks are searching. There is also a security program available to monitor our website.

**Minutes:**

A motion to approve and accept the regular monthly May minutes was made by Mike Nolan and seconded by Bill Olson. The minutes were unanimously approved.

**Invoices:**

A motion to approve invoices was made by Mike Nolan and seconded by Bill Olson. With a roll call vote of 3 ayes and 0 nays, the motion to approve invoices passed.

**Announcements/communications:**

Kathleen shared an estimate given to her by Sexton Frannie Dick for tree removal in several cemeteries. Mike mentioned that TOIRMA will pay up to \$2500 if a tree goes down in a cemetery.

Kathleen presented an accounting contract for Kemper. She will make copies for the Trustees. The contract is in effect until December 31, 2018.

**Old Business:**

Mike has a bid from Chris Dick of Illini Overhead Doors to install 3 doors at the buildings at White Heath ball diamond at no more than \$250 for total installation. Mike Nolan made a motion to purchase 3 doors for \$1750 total and pay Illini Over Head Doors for total installation at no more than \$250. Bill Olson seconded the motion. A roll call vote of 3 ayes and 0 nays passed the motion unanimously.

**New Business:**

Debbie read aloud the prevailing wage ordinance. Bill Olson made a motion to accept the ordinance and Mike Nolan seconded the motion. With a roll call vote of 3 ayes and 0 nays, the motion carried.

There have been personnel changes in our Township Road crew. Casey left for another job and Linc McCollum has been hired as his replacement.

A motion to go into closed session to discuss a legal matter was made by Mike Nolan and seconded by Bill Olson. All were in favor and the group moved to closed session at 7:30 P.M.

After adjourning from closed session, a motion to adjourn the regular monthly meeting was made by Mike Nolan and seconded by Kathleen Piatt. All were in favor. Meeting adjourned at 7:49 P.M.
