

**Sangamon Township
Regular Monthly Meeting
September 11, 2025**

The meeting was called to order at 7:00 pm by Supervisor Mike Nolan. Roll call was taken. Present were Supervisor Nolan and Trustees Bill Blickhan, Tim King, and Kathleen Piatt. Also present were Highway Commissioner Larry Sebens and Clerk Kevin Duff. Absent was Trustee Tosha Valentine. The Pledge of Allegiance was recited. There was no public comment.

Under announcements, the Plunk Subdivision plans are going for review to the County Zoning Board this month.

Trustee Blickhan made a motion seconded by Trustee Piatt to approve the August meeting minutes as amended. A voice vote was taken and the motion passed unanimously.

A motion was made by Trustee King and seconded by Trustee Blickhan to approve the invoices. A roll call vote was taken and the motion passed unanimously.

Transfers and deposits were discussed. Transfers were made as required by the audit.

Trustee Blickhan reported that the final bill for the new ball diamond grading and drainage work has been received for the amount quoted in 2023. A bill from the vendor Brian Sebens has been received for pumping out the abandoned septic tank found during construction and pumping out the drain tile tank to complete tile installations. A motion was made by Trustee Blickhan and seconded by Trustee King for an amount to follow for a grant to the White Heath Rec League for a backstop and a fence between the dugouts and future bleacher locations at the new ball diamond. A roll call vote was taken and the motion passed unanimously. The Rec League is still looking for someone to sow grass seed at the new ball diamond. The lime infield has been done. Additional lime (maybe 4 loads at \$1,000/load) will probably be needed. The gravel delivered for the parking lot expansion will be used on the new drive and additional gravel will be needed for the parking lot expansion.

A grant application for IDNR is due September 30, 2025. A motion was made by Trustee Piatt and seconded by Trustee King to apply for a \$400k grant for future lights and electrical service for the new ball diamond. A roll call vote was taken and the motion passed unanimously.

No audit questions were raised.

One request for General Assistance was made and given for \$350.

Clean up Days this year will be October 9 and 10 at the same times as last year.

The second tax receipt for this year has not yet been received.

A transaction report for the Illinois Fund and a positive financial projection were made.

The final oil and chip work on Blueberry Lane as agreed with the land purchase has been made by Commissioner Sebens. Trustee Blickhan will let Rick Pontious know.

Commissioner Sebens reported that a record 14 miles of oil and chip has been installed this summer.

A brief discussion about funding future cemetery work was had.

A motion was made by Trustee Piatt and seconded by Trustee Blickhan to adjourn the meeting. A voice vote was taken and the motion passed unanimously. The meeting adjourned at 8:10 pm.
