## APRIL IS **Fair Housing** Month

This year, we commemorate the 56th anniversary of the passage of the Fair Housing Act, the landmark civil rights law signed by President Lyndon B. Johnson on April 11, 1968, that made discrimination in housing transactions unlawful. The Fair Housing Act prohibits discrimination in housing because of race, color national origin, religion, sex (including gender identity and sexual orientation), disability, and familial status. What are low income home loans?

The path to homeownership can be fraught with challenges, low-income home loans—a specialized type of mortgage designed to level the playing field for buyers facing financial barriers.

Low-income mortgage programs focus on addressing the common challenges that low-income earners encounter, such as managing debt, maintaining less- payment is not a universal than-stellar credit scores, and requirement. struggling to save for a significant down payment.

Even better, the home seller can pay closing costs worth up to 3% of the purchase price. Instead of negotiating a lower sales price, try asking the seller to cover your closing costs.

Private mortgage insurance (PMI) may also be discounted for these low-income home loans. You're likely to get a lower PMI rate than borrowers with standard conventional mortgages, which could save you a lot of money from month to month.

"This is the biggest benefit," says Jon Meyer, loan expert and licensed mortgage loan originator. "The PMI is offered at a lower rate than with a standard conventional loan." Finally, Home Possible and HomeReady might make special allowances for applicants with low incomes. For instance, HomeReady lets you add income from a renter on your mortgage application, as long as they've lived with you for at least a year prior. This can help boost your qualifying income and make it easier to get financing. You might qualify for HomeReady or Home Possible if your household income is below local income limits and you have a credit score between 620 and 660.
