

The family of civil rights leader Malcolm X announced on the anniversary of his 1965 assassination that they intend to sue U.S. government entities — including the FBI, CIA and New York Police Department for \$100 million, alleging they played a part in his death.

Attorneys detailed the forthcoming lawsuit at a news conference Tuesday, at the same Manhattan location where the religious and civil rights leader was shot and killed 58 years ago.


"We want justice served for our father," said one of his daughters, Ilyasah Shabazz, an administrator of Malcolm X's estate. She spoke at the news conference alongside her sister Qubilah.

The circumstances surrounding Malcolm X's death have long been shrouded in mystery. Two men who were convicted of murdering the activist were exonerated in 2021 after serving decades in prison — and the New York District Attorney admitted that the case against them was flawed, and that law enforcement at the time withheld evidence.

The move renewed public interest in the case and fueled long-held conspiracy theories about the possible culpability of law enforcement, particularly of the New York Police Department.

under New York law by anyone planning to sue the state, filing notices of claim that said government entities at the federal and local level in New York "conspired with each other and with other individuals and acted, and failed to act, in such a way as to bring about the wrongful death of Malcolm X," according to the Associated Press. At the news conference, civil rights attorney Ben Crump appeared to put an even finer point on it. Asked directly by a journalist if he thought government agencies were involved in the conspiracy to assassinate Malcolm X, Crump replied: "That is what we are alleging, yes."

The CIA did not respond to a request for comment Wednesday. Spokespeople for the because they were incensed by Malcolm FBI, NYPD and New York District Attor-



ney's Office declined to comment. Ilyasah Shabazz took the first steps required Malcolm X was assassinated on Feb. 21, 1965, when he was just 39. He was shot while preparing to give a speech at the Audubon Ballroom. A bodyguard shot one of the assailants trying to flee the scene,

Talmadge Hayer, and captured him. Hayer, who goes by Mujahid Abdul Halim, later confessed to killing Malcolm X. He spent 45 years in prison and was released on parole in 2010.

However, Hayer long insisted that the two other men who were arrested and jailed for the crime, Muhammad A. Aziz and Khalil Islam, both members of the Nation of Islam, were innocent.

Haver told authorities in 1977 that he planned the killing with four different men

Elijah Muhammad.

After decades in prison, Aziz, who previously went by the name of Norman "3X" Butler, was paroled in 1985. Islam, who went by Thomas "15X" Johnson, was paroled in 1987.

They were the subject of a Netflix documentary, "Who Killed Malcolm X?," that came out the same year as the New York district attorney began to reinvestigate the case. Following a review of the available evidence from the case, the New York District Attorney's Office recommended that the two men's first-degree murder convictions be vacated.

The office also acknowledged law enforcement failings in the case. It said the FBI and NYPD did not honor their obligation to disclose exculpatory evidence to prosecu-X's public feud with Nation of Islam leader tors and the accused — including "infor-

mation that implicated other suspects; that identified witnesses who failed to identify defendant Islam; and that revealed witnesses to be FBI informants."

It said FBI records suggested "that information was deliberately withheld." Last October, Aziz and the estate of Khalil Islam received a \$36 million settlement from the city of New York. The city's Law Department said in a statement at the time that it agreed with former Manhattan District Attorney Cyrus R. Vance Jr.'s conclusion that the men had been wrongfully convicted.

Crump said Tuesday that the city's settlement and the District Attorney's conclusions made it possible to build a case for wrongful death against authorities involved in the 1965 investigation and gave "Malcolm's daughters an opportunity to seek legal redress, finally.'

"If the government compensated the two gentlemen that were wrongfully convicted for the assassination of Malcolm X with tens of millions of dollars, then what is to be the compensation for the daughters who suffered the most from the assassination of Malcolm X?" Crump asked.

Attorney Ray Hamlin, whom Crump identified as his co-counsel, said that family members of Malcolm X involved in the prospective lawsuit include his daughters Ilyasah, Qubilah, Gamilah and Malaak Shabazz — as well as the daughter of Malikah Shabazz, another of Malcolm X's daughters who died in 2021.

Speaking briefly from the podium during Tuesday's news conference, Ilyasah Shabazz — who was in the room when Malcolm X was assassinated — described her father as man who "gave his life for human

"The truth about the circumstances leading to the death of our father is important, not only to his family, but to many followers, many admirers, many who look to him for guidance, for love," Shabazz said. Sydney Trent, Shayna Jacobs and Marisa Iati contributed to this report.





Washington Marijuana Social Equity Application Nears Deadline

The state of Washington is set to dole out more than 40 new cannabis retail licenses this month to so-called social equity applicants—but the deadline is fast approaching. With the application period kicking off on March 1, qualified prospective license holders have until March 30 to apply. The Washington State Liquor and Cannabis Board, a state regulatory agency overseeing the two industries, is handling the social equity applications.

According to the agency, more than 40 licenses that "were forfeited, cancelled, revoked or never issued will be available in specific jurisdictions across the state" as part of the program. The Washington State Liquor and Cannabis Board says that, in order to qualify for the social equity cannabis program, applicants must meet the following criteria:

"At least a 51 percent majority, or controlling interest, in the applicant, must be held by a person(s), who has or have resided in Washington state for six months prior to the application date, and meets at least two of the following qualifications: lived in a disproportionately impacted area (DIA) in Washington state for a minimum of five years between 1980 and 2010 ... OR applicant or a family member has been arrested or convicted of a cannabis offense; OR household income was less than the median household income within the state of Washington (\$82,400)."

According to Axios, applicants "who have served time in prison for a cannabis offense will get higher priority when it comes to distributing the social equity licenses," as will those applicants who "make less than the state's median income, and who have lived in areas with high rates of drug convictions, poverty, and unemployment."

Social equity provisions have become the norm in states that legalize recreational cannabis for adults, as advocates have stressed the importance of remedying harms inflicted on individuals and communities in the era of prohibition. But in Washington, which became one of the first two states to legalize recreational marijuana back in 2012, those social equity provisions did not come until later.

The ballot measure approved by voters there more than a decade ago, Initiative 502, "did not include provisions or create programs to acknowledge the disproportionate harms the enforcement of cannabis laws had on certain populations and communities," the Washington State Liquor and Cannabis Board explained earlier this year, when it announced the more than 40 social equity applications that would be made available.

The state created the social equity cannabis program in 2020, when the state's Democratic governor, Jay Inslee, signed a bill into law that provided "the opportunity to provide a limited

number of cannabis retail licenses to individuals disproportionately impacted by the enforcement of cannabis prohibition laws."

"The LCB recognizes that cannabis prohibition laws were disproportionately enforced for decades and that the cumulative harms from this enforcement remain today," the agency explains on its website. "In 2020, in response to a policy priority identified by the Board, the LCB developed agency-request legislation created the state Social Equity program, the Social Equity in Cannabis Task Force and the opportunity to provide a limited number of cannabis retail licenses to individuals disproportionately impacted by the enforcement of cannabis prohibition laws."

But the state clearly still has a lot of work to do; as Axios noted, more than 10 years after the voters there made history, Washington's cannabis industry "remains dominated by white entrepreneurs."

The State Liquor and Cannabis Board reported in January 2020 that 82% of cannabis retailers in Washington were owned by white individuals. Only 3% were owned by Black residents, and 2% were Hispanic-owned.

Izzo Sets Record for Most Consecutive NCAA Tournament Appearances as Spartans Extend Streak to 25 Straight

EAST LANSING, Mich. – Michigan State has earned a bid to its 25th consecutive NCAA Tournament, extending the longest NCAA Tournament streak in Big Ten history.

And in the process, MSU head coach Tom Izzo became the first head coach in history to lead his team to 25 consecutive NCAA Tournament appearances (previous record: Duke's Mike Krzyzewski with 24 straight from 1996-2019).

The seventh-seeded Spartans (19-12, 11-8 Big Ten) will face No. 10-seeded USC (22-10, 14-6 Pac-12) in the first round of the East Region on Friday, March 17 at 12:15 p.m. (TV: CBS). The game will be played at Nationwide Arena in Columbus, Ohio.

The winner between the Spartans and Trojans will take on the winner of second-seeded Marquette

(28-6) and No. 15-seeded Vermont (23-10) on Sunday, March 19.

Michigan State's streak of 25 straight NCAA Tournaments is not only a Big Ten record, it's also the third-longest in NCAA history (Kansas, 33, 1990-2023; North Carolina, 27, 1975-2001). In addition, MSU's streak is the second-longest active streak in the nation (Kansas, 33).

USC finished tied for second place in the Pac-12 standings with a 14-6 league record.

This will mark the seventh all-time meeting between MSU and USC; the series is currently tied, 3-3. The schools last met in the second round of the 2009 NCAA Tournament, as the second-seeded Spartans beat the No. 10 seed Trojans, 74-69, en route to reaching the NCAA Championship game.

Michigan State is making its 36th appearance in the NCAA Tournament with a record of 70-34 (.673) in its previous 35 tournaments. MSU has made 10 trips to the Final Four (1957, 1979, 1999, 2000, 2001, 2005, 2009, 2010, 2015, 2019) and captured the NCAA Championship in 1979 and 2000. MSU's .673 winning percentage is the eighth-best all-time in NCAA Tournament play, while the program's 70 total victories rank sixth all-time. Michigan State's 10 Final Four appearances are tied for sixth most.

The East Regional is set for March 23 and March 25 (Thursday, Saturday) at Madison Square Garden in New York. The 2023 Final Four will be held at NRG Stadium in Houston on April 1 and April 3 (Saturday, Monday).

She coached some of the most MSU's most prolific scorers, including Aerial Powers who earned first-team All-Big Ten honors three times (2014-16), as well as being named an All-American her final two seasons. During the 2017 season, Tori Jankoska became the Spartans' all-time leading scorer as well as capturing first-team All-Big Ten and All-America honors. In 2022, Nia Clouden was named first team All-B1G, as well as capturing AP and WBCA honorable mention All-America honors.

During her tenure, Merchant coached three WNBA first-round draft picks in Powers (2016), Jankoska (2017) and Clouden (2022).

EAST LANSING, Mich. - Michigan State Vice President and Director of Athletics Alan Haller and women's basketball head coach Suzy Merchant have come to a mutual decision that Merchant will step down as the program's head coach, effective immediately. Associate head coach Dean Lockwood will serve as interim head coach while a national coaching search is conducted.

"We are grateful to Coach Suzy Merchant for her contributions to Michigan State women's basketball and Spartan Athletics over the last 16 seasons," Haller said. "We appreciate everything Coach Merchant has meant to our community. Her two Big Ten titles and 10 NCAA Tournament appearances provided lasting memories. Beyond the team's oncourt success, she invested considerable time and energy into our local community as a leader and a role model for young people."

Merchant ended her tenure with a record of 327-186 at MSU and an overall career record of 528-306. She captured two Big Ten titles (2011, 2014), earning Big Ten Coach of the Year honors in 2011. Under Merchant, the Spartans reached the NCAA Tournament 10 times, including advancing to the Sweet Sixteen in 2009.

In 16 seasons under Merchant, 52 Spartans have earned All-Big Ten recognition and 76 have been
