#### Johnson Publishing Company, the ex-publisher of Ebony and Jet magazines, files for bankruptcy

Johnson Publishing Co., which launched Ebony and Jet magazines and was once one of the nation's largest and most successful black-owned businesses, has filed for Chapter 7 bankruptcy.

Its magazines were defined by its photography and articles about African Americans, from doctors to lawyers to celebrities. They gave visibility to a community and a culture that had generally been overlooked by national magazines and other mainstream media. The company sold the magazines in 2016, meaning they will not be affected by last Tuesday's filing.

"This decision was not easy, nor should it have been," the company said in a statement. "Johnson Publishing Company is an iconic part of American and African American history since our founding in 1942, and the company's impact on society cannot be overstated."

The brand pointed to several "factors outside of the company's control" for its financial position. The buyer of the company's media division hadn't made its required payments, it said. Johnson Publishing's cosmetics business, Fashion Fair, struggled to keep up with online competitors, and one of its largest retailers fell into bankruptcy. And it said it had to pay for a recall that stemmed from "quality issues" from one of its manufacturers.

"In short, Johnson Publishing Company was caught in a tidal wave of marketplace chang-

es and business issues which, despite exhaustive efforts, could not be overcome," the company said.

In filing for liquidation, Johnson Publishing listed assets of between \$10 million and \$50 million. It gave the same range for its liabilities and listed more than 200 creditors. Ebony and Jet have been owned by the Texas-based equity firm Clear View Group since 2016. Ebony Media Operations, which includes the Ebony print magazine and website, as well as the online-only Jet publication, said it could not comment on the bankruptcy filing. Since selling the brands, Johnson Publishing has concentrated on its cosmetics division and archives.

Ebony debuted in November 1945, pledging to "mirror the happier side of Negro life — the positive, everyday achievements from Harlem to Hollywood. But when we talk about race as the No. 1 problem of America, we'll talk turkey," the Chicago Sun-Times reported. Jet came along six years later. Both publications regularly reported on African American success stories but also confronted pervasive racism in the United States. Ebony's first issue included an editorial that called for equal employment opportunities after World War II, according to the Sun-Times.

"The Negro soldier and sailor want to come home to an America that has wiped out the 'white supremacy' practices which meant the downfall of Hitlerism in Germany," the editorial said. "They want to come home to a United States where a job no longer has a color."

In 1955, Mamie Elizabeth Till-Mobley — whose 14-year-old son Emmett Till was abducted, tortured and killed that year for reportedly offending a white woman in Mississippi — called on Ebony and Jet to show the world what had been done to her son. Jet printed a photograph of the Chicago boy's body in his coffin. Historians point to that decision as a focal point in the civil rights movement.

The company's founder, John H. Johnson, was the grandson of slaves and became the first African American to make the Forbes List of the 400 Richest Americans, NPR re-

ported. Johnson started out with a \$500 loan borrowed against his mother's furniture, according to the <u>Sun-Times</u>. His daughter told NPR that in order to buy one of his company's offices, he brought a white man to be "the face of the purchase."

"My father proceeded to act like he was just a janitor so he could just walk through the building and take a look at it," Linda Johnson Rice, the company's current CEO, said at the time

Johnson initially steered away from political issues, said Kinohi Nishikawa, a professor of English and African American Studies at Princeton University. While mainstream media covered black communities during times of protest or violence, Johnson wanted to offer the stories that "no one else covered," such as black beauty pageants, entertainers who were kept out of white-only venues and other aspects of black social life. "My father proceeded to act like he was just a janitor so he could just walk through the building and take a look at it," Linda Johnson Rice, the company's current CEO, said at the

Johnson, who was awarded the Presidential Medal of Freedom in 1996, died in 2005 at age 87. His obituary in the Sun-Times described him as "the man who turned Ebony into gold." Former president Bill Clinton was among 2,000 mourners at his funeral. President Barack Obama, as a senator from Illinois, said the pages of Ebony and Jet filled a void. They showed young black men that their fates did not hinge on "some menial job or getting involved in crime," and that "strong, capable black men were out there." "When I was growing up, basically the only black men on television were criminals or Flip Wilson dressed in drag as a character called Geraldine," Obama said. After Johnson's death, the Rev. Jesse Jackson told the Chicago Tribune that Johnson's lasting contribution was that he "put a human face on black people." He "gave us our first mirror to see ourselves as a people of dignity, a people with intelligence and beauty," he said. Article courtesy of Rachel Siegel of the Washington Post

#### Slotkin to Devos-It's to Meet with Nassar Victims

Washington — Freshman U.S. Rep. Elissa Slotkin is urging Education Secretary Betsy DeVos to meet with sexual assault victims of Larry Nassar to help DeVos' decision-making as she revises federal guidelines for campus sexual misconduct policies.

Slotkin's district includes East Lansing and Michigan State University, where the now disgraced Nassar was a sports doctor.

The Holly Democrat said she's met with at least a dozen of his victims and was headed to Lansing on

Thursday evening speak to more of them. "She is attempting to make changes to Title IX that really take us in the opposite direction and reject all the lessons we should be learning from the experience at Michigan State with Larry Nassar,"

"If she's going to go ahead and make these fundamental changes to Title IX that are going to impact hundreds of thousands of folks, then she should have a conversation with the very people that Title

Slotkin was referring to DeVos' department revising federal guidelines for how institutions investigate sexual assault allegations under Title IX of federal civil rights law.

DeVos, who is from the Grand Rapids area, has previously met with students falsely accused of sex-

ual misconduct, as well as advocates for sexual assault victims.

DeVos has criticized rules established by the Obama administration and said her proposal is meant in part to be more fair to students who are accused of misconduct, saying one person denied due process is one too many.

"Given how impactful these meetings have been for me, I urge you to meet with survivors of sexual assault on college campuses, including MSU," Slotkin wrote in a Thursday letter to DeVos.

"I believe that your understanding of important issues will be incomplete if you do not spend time with the women who have survived this systemic abuse and can best inform you how to prevent it

In addition to the letter. Slotkin also submitted a public-records request to the Education Department to confirm whether DeVos has actually ever met with any campus sexual assault victims, she

"None of the folks in the survivor-advocate community that I've met with have met with her. They've never had a request from her," Slokin said.

"These are folks who are now in leadership and advocacy positions for organizations and for the state of Michigan that put them in a really great position to speak on behalf of the larger survivor community.

"Particularly since we're all Michiganders, it struck me as strange that I hadn't heard of one survivor who had actually spent any time with her," Slotkin added. "I'd be happy to be wrong." A spokeswoman for DeVos did not respond Thursday to a message seeking comment.

The department previously said it's reviewing comments on the proposed Title IX changes.

"The tragic situation at MSU involving Larry Nassar is further proof that the current Title IX frame-

work has failed far too many students and shows that the prior administration's policies have not worked," DeVos spokeswoman Liz Hill said in February.

Nassar, who also was a sports doctor for USA Gymnastics, is serving what amounts to life in prison after admitting to sexually abusing girls and women under the guise of medical treatment for dec-

Slotkin said she met this week with Title IX experts and plans to introduce legislation to put in place protections that would "override" the Title IX revisions should they go through.

Her guest for President Donald Trump's State of the Union address in February was Amanda Thomashow, who filed the first Title IX complaint against Nassar in 2014.

Slotkin noted that MSU wouldn't have had to investigate Thomashow's complaint under the Education Department's proposed guidelines. That's because colleges would have to investigate only if the alleged incident occurred on campus or in other areas overseen by the school. Thomashow saw Nassar in an office across the street from campus.

The proposal also says accused students must be able to cross-examine their accusers, albeit through a representative. Slotkin worries this would "retraumatize" victims, she said.

"The proposed changes would mean the young women at universities would have less access to protections than someone in a traditional workplace like their parents," Slotkin said. "That is just backwards." "I want to have a person to person conversation in the hopes that she rethinks and revises some of her proposed changes." Slotkin is set to meet with DeVos in early

"I want to have person-to-person meeting with her and appeal to her Michigander to Michigander, and make sure she knows what these proposed changes mean to people at Michigan State and the surrounding community," Slotkin said.

# Tiger Woods, in a Stirring Return to the Top, Captures the Masters at 43

AUGUSTA, Ga. — Tiger Woods completed a comeback from personal and professional adversity on Sunday, capturing his fifth Masters title and his 15th major tournament with a victory that snapped a decade-long championship drought and instantly returned him to the top of the sports world. It was a monumental triumph for Woods, a come-frombehind victory for a player who had had so much go wrong on the course and off after his personal life began to come

2009. As such, it was only fitting that after he walked off the 18th hole on Sunday, his one-stroke victory secure, his path to the official scoring office was gridlocked with well-wishers, including many of the golfers he vanguished over four grueling days at Augusta National Golf

Woods triumphed in almost

stoic fashion, playing with shrewdness and determination over the final stretch of holes while the other players who were grouped with him on the leaderboard took turns succumbing to the pressure of trying to win the Masters.

And although Woods did bogey the final hole, he did so with a two-stroke lead, victory in sight and the knowledge that he could give one of those strokes back and still win the tournament. Only when he tapped in his final putt did Woods let loose with a joyous shout that revealed how much

At 43, Woods became the second-oldest winner of the Masters, behind Jack Nicklaus, who won here in 1986 at age 46 and who holds the record for victories in major tournaments, 18. And Woods's victory

immediately reverberated beyond golf and, for that matter, sports. The win even led to a rare moment of agreement between President Trump and former President Barack Obama. "What a fantastic life comeback for a really great guy!" the President said on Twitter. "To come back and win the Masters after all the highs and lows is a testament to excellence, grit and determination," Obama posted.

#### Woods Navigates Through a Traffic Jam

Francesco Molinari entered the final round of the Masters alone in the lead by two strokes at 13 under. He stayed atop the leaderboard by himself until the last group — Molinari, Tiger Woods and Tony Finau — got to the 12th tee. At which point, Molinari proceeded to double bogey the hole and set up a wild finish in which six golfers at one point or another held at least a share of the lead. (Woods, Molinari, Xander Schauffele, Patrick Cantlay, Brooks Koepka, Dustin Johnson). There was briefly a five-way tie for first until Woods took sole possession of the lead for good at the 15th hole, where he birdied and Molinari made another double bogey. # THE REALS OF JUSTICE

Immigration – I'm an immigrant. What does that mean for me?

There's talk almost every day in newspapers, on the news and on the radio about immigrants and birthright citizenship. What does that even mean? Birthright citizenship originated in English common law and the U.S. followed that law, guaran-



teeing birthright citizenship to people born in the U.S. That's means if you were born in the U.S. you are a citizen of the U.S. But that was challenged by people who wanted the descendants of slaves excluded from U.S. citizenship. The infamous Dred Scott U.S. Supreme Court decision which denied birthright citizenship to black people regardless of whether or not they were free or enslaved caused Congress to create section 1 of the 14<sup>th</sup> Amendment, "All persons born or naturalized in the U.S. and subject to the jurisdiction thereof, are citizens of the U.S. and of the State wherein they reside." If you're an immigrant, keep your immigration paperwork in your residence and commit you're A# (alien registration number) to memory. It's always advantageous to meet with an immigration attorney to determine if you're eligible for immigration status. A U.S. citizen can't be deported. So, if you're a permanent resident, naturalizing would be an excellent choice. If you've children obtaining dual citizenship for them is a good option. Regardless of status, your children may be eligible for food assistance or Medicaid benefits (generally there's a 5 year waiting period for Medicaid benefits but not for food assistance). All children regardless of immigration status can attend a free public school. In Michigan a non-citizen without legal presence can't obtain a driver's license. Always consult an attorney before giving information about your immigration status to a government agent. If there is a need to give your name always provide your full name. If you give a false or partial name and get detained family or loved ones may not be able to find you. Law enforcement can't come into your residence without your permission unless they've a warrant signed by a judge. If you're pulled over on a traffic stop after showing proof of insurance and registration, if you have documents that show you can lawfully be in the U.S., keep them with you and show them to the officer. Failure to do so could lead to an arrest.

Never sign any paperwork you don't understand. You should only sign documentation after consulting with an attorney. If you're detained you've the right to remain silent and should contact an immigration attorney. You should also contact your embassy and/or consulate.

If you are and immigrant and charged with a crime consult with an immigration attorney before entering any plea. A criminal conviction can have huge consequences including
