

Why is it so Important to Vote?

If your friends say, "My vote doesn't count," or, "Politics are dirty," it's no wonder. Many forces profit from the unequal pay and status of women, and ever since the civil rights movement and the women's movement created a new majority, they have been trying to convince us that our vote doesn't matter.

You may also be discouraged because voting lines are long, polling places far away, and responsibility for kids and jobs makes voting difficult. Some state officials also create barriers of voter identification — especially for the poor, voters of color, students, and other forces of change. That's part of the reason that voter turnout in this country is lower than in, say, India, with all its problems of poverty and illiteracy. In fact, our country makes voting more difficult than any other democracy.

In non-presidential years like this one, turnout is even lower because the media tend to focus on the White House. This creates the very real danger that the majority of Ameri-

cans — who believe that women, not the government, should make reproductive decisions about our own bodies — will let unrepresentative anti-choice state legislatures go right on shutting down clinics, as in Texas and Mississippi. Also many or most state legislatures will go right on using our tax dollars to support profit instead of equal pay, and restricting themselves into perpetuity — including in Washington.

All this is why we must not only vote but be willing to fight to vote — not only for who goes to Washington, but also for our school board and state legislature. #CosmoVotes and many other websites will give you the facts so you can vote for representatives who vote for you. I want to tell you a story.

At the beginning of the 1980s, I went to Missouri to campaign for Harriett Woods, then the only Democratic woman to run for U.S. Senate. She was a great candidate, and her path into politics had been so improbable that no one could have made it

up. As a mother of two young children, she complained about a noisy manhole cover that woke them up every time a car rolled over it in her otherwise quiet street. After getting nowhere with the city council, she circulated a petition to close the street to cars. It worked. This success led her to run for the city council. She won, served eight years, got appointed to the state highway commission. Then she ran a successful race for the state legislature, and was re-elected there too. This also made her the much-loved host of a local television show, and a popular candidate statewide.

Still, when the Democratic Party was choosing a candidate for the U.S. Senate primary, it backed a well-to-do guy with no political experience except writing checks. After all, no woman had ever won a statewide office in Missouri. However, Woods turned out have something more important than her party's blessing: community support and volunteers. DETROIT, Mich. — On July 22, 2019 Governor Gretchen Whitmer held a ceremonial signing for House Bill 4060 designating the portion of the M-10 freeway between Livernois and I-94 in Detroit as the "Aretha Franklin Memorial Highway."

"Aretha Franklin was an American icon whose musical contributions-built Michigan into the state it is today," said Gov. Whitmer. "She started her career right here in Detroit, but her influence has reached every corner of the world. I'm honored to be able to dedicate a portion of the M-10 freeway to remember Aretha, to celebrate her life, and to honor everything she did for this city and our state."

"This is a special day in Michigan's history as we designate this memorial highway to the first female African-American artist-activist ever to receive this distinctive honor in the state's history," said Rep. Leslie Love (D-Detroit). "In the tradition of great artist-activists like Nina Simone, Lena Horne, Ruby Dee and Miriam Makeba, how befitting it is to the memory of the Queen of Soul, Ms. Aretha Franklin, who not only gave us hits like 'Freeway of Love,' but who also donated her talent in 1988 for an anti-drinking and driving PSA campaign, as well as to other social justice and civic causes. I connect with Ms. Franklin, and like her, I am an artist-activist and a member of the Divine 9, and I felt compelled to see this happen."

HB 4060 was introduced by Representative Leslie Love and passed in the Michigan Legislature on June 20, 2019.

THE REALS OF JUSTICE

BAIL

What is bail, who gets to say how much it is and if one gets it? Bail is a deposit of security for the release of a person who is incarcerated for allegedly committing an offense and who is awaiting trial. Bail is to secure the person's appearance in court. However, "No person charged with treason or murder shall be admitted to bail if the proof of his guilt is evident or the presumption great." Michigan Compiled Laws (MCL)765.5. The courts are to follow the Michigan constitution in which "excessive bail shall not be required." Money bail is excessive if it "is in an amount greater than reasonably necessary to adequately assure that the accused will appear when his [or her] presence is required." People v. Edmond, 81 Mich App 743, 747-748 (1978).

There are different types of bail, which include secured money bail and surety bonds. But in certain cases, for example, child support cases, if a person is arrested for a bench warrant for failure to pay child support, the person must deposit a cash bond of no less than \$500 or 25% of the arrearage, whichever is greater. And at the court's discretion it may set the cash bond at an amount not more than 100% of the arrearage and add to that amount the court costs.

MCL 765.6a requires a cash bond or a surety other than the applicant if the applicant is charged with a crime alleged to have occurred while on bail by a bond personally executed by him; or has been twice convicted of a felony within the preceding 5 years.

The court must consider and make certain findings as to each of the following:

The seriousness of the offense charged.

The protection of the public.

The previous criminal record and the dangerousness of the person accused.

The probability or improbability of the person accused appearing at the trial of the cause.

Frequently people are given a 10% bond by the court. This means the person may post bail by a surety that is a quarter of the full bail and executed by a surety that is approved by the court. The court often puts in place various conditions to reasonably ensure the safety of the public and ensure the appearance of the person to future court hearings. Such conditions could be that the person not commit any new crimes, not leave the state without permission of the court, not use alcohol or other controlled substances without a prescription, comply with a curfew, seek or maintain employment, not possess a firearm and any other conditions the court deems appropriate. If a person is charged with domestic violence or an assaultive crime the court can order the person wear a tether as a condition of the release. The cost of wearing a tether is the responsibility of the person and is not paid for by the court.

Recently across the U.S. and here in Michigan there has been a huge push for criminal justice reform as it relates to bail. Many people who are incarcerated and don't pose an undue danger to the community often can't afford to post bail on low level offense are in jail for unnecessarily long time periods. There's a push nationally for making bail in an amount that people can afford to post no matter what their income. Statistics have shown that in the U.S. more people of color and poorer Americans can't afford bail and they're left in jail while awaiting trial. For some families it is a difficult choice they face when deciding if they should pay a bail bondsman to get their family member out of jail because the fee a family has to pay a bail bondsman is non-refundable. This means even if the case ends up with the charges being dismissed the money paid to the bondsman will not be returned to the family.

The current bail system in the U.S. has created a higher jail population and longer time periods of incarceration. The bail system deserves a look at in terms of making the system fair & just for everyone not just for those who have money.
