

COMMUNITY REINVESTMENT ACT

The Community Reinvestment Act (CRA), institutions for CRA compliance, and take this information into consideration when approving applications for new bank branches or for mergers or acquisitions (Section 804.) Enforcement The law, however, emphasizes that an institution's CRA activities should be undertaken in a safe and sound manner, and does not require institutions to make high-risk loans that may bring losses to the institution. An institution's CRA compliance record is taken into account by the banking regulatory agencies when the institution seeks to expand through merger, acquisition or branching. The law does not mandate any other penalties for non-compliance with the CRA.

HISTORY OF FAIR HOUSING MONTH
 April is the month when we celebrate National Fair Housing Month. In this month we feel grateful for the Fair Housing Act that was passed on April 11, 1968. This law was designed to protect Americans from facing discrimination in selling or buying houses. It is also a basic human concept, and entitlement for people. As a community, we have the right to be free of any form of discrimination. In our communities, people belonging to diverse backgrounds should be warmly welcomed as our

agencies that conduct examinations for CRA compliance. These agencies are the Federal Reserve System (FRB), the FDIC, and the Office of the Comptroller of the Currency (OCC). In 1981, to help achieve the goals of the CRA, each of the Federal Reserve Banks established a Community Affairs Office to work with banking institutions and the public in identifying credit needs within the community and ways to address those needs. Information about the CRA ratings of individual banking institutions from the three responsible agencies (Federal Reserve, FDIC, and OCC), is publicly available from the website of the FFIEC. These ratings were first made available by the Clinton administration to enable public participation and public comment on CRA performance. In addition to the regulatory framework in place, each federal financial supervisory agency's Inspector General performs regular audits on any regulatory changes made to see if the intended goals are actually being fulfilled

History The original Act was passed by the 95th United States Congress and signed into law by President Jimmy Carter on October 12, 1977 (Pub.L. 95-128, 12 U.S.C. ch. 30). The CRA was passed as a result of national pressure to address the deteriorating conditions of American cities—particularly lower-income and minority neighborhoods. Community activists, such as Gale

Original act The CRA followed similar laws passed to reduce discrimination in the credit and housing markets including the Fair Housing Act of 1968, the Equal Credit Opportunity Act of 1974 and the Home Mortgage Disclosure Act of 1975 (HMDA). The Fair Housing Act and the Equal Credit Opportunity Act prohibit discrimination on the basis of race, sex, or other personal characteristics. The Home Mortgage Disclosure Act requires that financial institutions publicly disclose mortgage lending and application data. In contrast with those acts, the CRA seeks to ensure the provision of credit to all parts of a community, regardless of the relative wealth or poverty. In a 2003 research paper,

economists at the Federal Reserve could not find clear evidence that the CRA increased lending and home ownership more in low income neighborhoods than in higher income ones. A 2008 Competitive Enterprise Institute study resulted in a similar finding. Former Federal Reserve chair Ben Bernanke has stated that an underlying assumption of the CRA – that more lending equals better outcomes for local communities – may not always be true, pointing to “recent problems in mortgage markets”. However, he notes that at least in some instances, “the CRA has served as a catalyst, inducing banks to enter under-served markets that they might otherwise have ignored”

The Woodstock Institute, a Chicago-based policy and advocacy nonprofit, found in an analysis of 1996 Chicago-area survey data that low income areas still lagged behind in access to commercial loans. Most small business loans made by CRA regulated banks went to higher income areas; 16.6% in low-income areas, 18.4% in low- and moderate-income tracts; 21.8% in middle-income areas and 23.1% in upper-income areas. In a 1998 paper, Alex Schwartz of the Fannie Mae Foundation found that CRA agreements were “consistently successful in meeting their goals for mortgages, investments in low-income housing tax credits, grant giving to community-based organizations, and in opening (and keeping open) inner-city bank branches. In a 2000 report for the US Treasury, several economists concluded that the CRA had the intended impact of improving access to credit for minority and low-to-moderate-income consumers. In a 2005 paper for the New York University Law Review, Michael S. Barr, professor at the University of Michigan Law School, presented evidence to demonstrate that the CRA had overcome market failures to increase access to credit for low-income, moderate-income, and minority borrowers at relatively low cost. He contends that the CRA is justified, has resulted in progress, and should be

continued. Speaking to the February 2008 Congressional Committee on Financial Services hearing on the CRA, Sandra L. Thompson, Director of the Division of Supervision and Consumer Protection at the FDIC, lauded the positive impact of CRA, noting that, “studies have pointed to increases in lending to low- and moderate-income customers and minorities in the decades since the CRA's passage.” She cited a study by the Joint Center for Housing Studies at Harvard University, that found that “data for 1993 through 2000 show home purchase lending to low- and moderate-income people living in low- and moderate-income neighborhoods grew by 94 percent – more than in any of the other income categories”
 In his statement before the same hearing, New York University economics professor Larry White stated that regulator efforts to “lean on” banks in vague and subjective ways to make loans is an “inappropriate instrument for achieving those goals”. In a world of national banking enterprises, these policies are more likely to drive institutions out of neighborhoods. He stated that better ways to accomplish the goals would be vigorous enforcement of anti-discrimination laws, of antitrust laws to promote competition, and federal funding of worthy projects directly through an “on-budget and transparent process” like the Community Development Financial Institutions Fund. According to a 2012 study “credit markets enabled a substantial fraction of Hispanic families to live in neighborhoods with fewer black families, even though a substantial fraction of black families were moving to more racially integrated areas. The net effect is that credit markets increased racial segregation”.

Politico has reported that the Community Reinvestment Act may sometimes push poor people out of their own neighborhoods by facilitating investment by outsiders.



Gov. Whitmer signs "Building Michigan Together Plan"

Governor Gretchen Whitmer signed a \$4.7 billion bipartisan infrastructure spending bill into law Wednesday.

It designates nearly \$2 billion of that money for water-related priorities like clean drinking water and safe dams.

Whitmer said it will help prevent future lead-service-line-related issues like those seen in Flint and Benton Harbor.

"When the water's treated, when it's maintained, it's safe to drink. However, we know that it's important that we continue our work to replace these lines. So, these resources will go a long way toward making sure that we're protecting people and the quality of their drinking water," Whitmer said at a bill signing press conference in Grand Rapids.

The law, dubbed the "Building Michigan Together Plan," uses over \$4 billion of federal money. Whitmer said many other midwestern states have al-



ready spent the money they received. "Every day that these dollars aren't appropriated has an opportunity cost with it. We see inflation continue to eat more of what we're able to do with these dollars. And certainly, workforce is another complicating factor," Whitmer said.

According to the state budget office, Whitmer said, the state still has about \$2 billion left to allocate.

Whitmer said more money from a federal infrastructure package will start arriving in May.

Whitmer's office highlighted several spending areas in the plan, including:

- \$1.1 billion for drinking water infrastructure
- \$380 million in COVID-19 rental assistance
- \$250 million for state parks and trail infrastructure
- \$200 million for local parks and trail infrastructure

\$322 million from the Federal Coronavirus Local Fiscal Recovery Fund for local governments \$251 million for broadband service grants State Sen. Winnie Brinks (D-Grand Rapids) said she's excited about the ways her district plans to use that parks money.

"Here in Grand Rapids, we've been dreaming, planning, and working to reinvent our relationship with the river that defines our city by restoring the rapids and creating a riverfront corridor that invites us to interact with the river and each other in whole new ways," Brinks said.

Besides allowing for the building out of a greenways trail stretching along the Grand River from Lowell to Lake Michigan, the money would also fund broadband expansion efforts in the state.

Speaking from the White House Wednesday, Lt. Gov. Garlin Gilchrist described the funding of broadband grants and the Michigan High-speed Internet Office as transformative for the state's communities.

"[It] will enable us to target those investments in the communities that need the most, to support the innovators in Michigan who are building new networks to connect new communities. It'll support those innovators who are building partnerships to make internet access more affordable," Gilchrist said.

Whitmer created the Michigan High-speed Internet

March 31 is Cesar Chavez Day in Michigan.





Nia Clouden Named Associated Press Honorable Mention All-American

The senior guard earns her first All-American

EAST LANSING, Mich. -Michigan State women's basketball senior guard Nia Clouden was named to the Associated Press honorable mention All-American team, as announced by the AP on Wednesday.

Clouden's honor is the 10th AP All-America accolade in program history and the first since Tori Jankoska during the 2016-17 season.

She joins Lindsay Bowen (2004-05), Kristin Haynie (2004-05), Liz Shimek (2004-05, 2005-06), Allyssa DeHaan (2009-10), Kalisha Keane (2010-11), Aerial Powers (2014-15, 2015-16) and Jankoska (2016-17). Powers

and Shimek are the only MSU players to earn multiple All-American accolades. Overall, MSU has had eight different players named AP All-Americans.

Clouden, an Owings Mills, Maryland, native ended her storied Michigan State career second in career scoring with 1,882 points, behind all-time leading scorer Jankoska (2,212). Her 601 points scored this season were fourth all-time in MSU history. She is currently fifth in the Big Ten in scoring, averaging 20.0 points per game, which also stands 20th in the nation. Clouden is also fifth in the country in free throws, making 192 this season.

The resilient Clouden started every game

during her four-year career. Her 117 career starts were seventh in MSU history. She also captured All-Big Ten honors four-straight seasons. On Dec. 20, Clouden broke the Michigan State single-game scoring record with 50 points against Florida Gulf Coast.

Michigan State ended an injury-plagued season 15-15 this season, advancing to the quarterfinals of the Big Ten Tournament.



J P MORGAN REVEALS THE LATEST PART OF ITS \$30 BILLION COMMITMENT TO SUPPORT BLACK AND BROWN COMMUNITIES

On Thursday, JPMorgan announced a new wave of investments as part of its \$30 billion commitment to lift up Black, Latinx, and other underserved communities. Latinx is a gender-neutral alternative to Latino or Latina to describe people of Latin American descent. The plan, which was announced in October of last year, appears to be the largest US corporate commitment to racial equity in the wake of George Floyd murder, according to Insider research. The latest round will focus on Black and brown entrepreneurs and small business owners, according to the financial giant.

“We look at diversity and inclusion as a business, Brian Lamb, JPMorgan global head of diversity and inclusion, told Insider. “We want to drive sustainable change.”

The firm said it would commit \$350 million to support underserved small businesses and an additional \$42.5 million to its “Entrepreneurs of Color Fund,” a program that supports Black and brown founders. Black-owned businesses were more than twice as likely as their white counterparts to have closed during the pandemic, according to an August 2020 national study by the New York Fed. Some 41% of Black-owned businesses closed, and 32% of Latinx-owned businesses closed. Meanwhile, white-owned busi-



nesses fell by just 17%. In addition, JPMorgan will be opening new branches, called “Chase Lounges,” in underserved areas including Harlem, New York, Chicago, and Atlanta. These

branches will have resources for entrepreneurs looking to start or grow their companies. The news follows JPMorgan’s announcement from earlier this week that it would invest \$40

million in minority depository institutions (MDIs) and community development financial institutions (CDFIs). MDIs and CDFIs provide financial services in communities that are often underserved. In October, the firm said it would commit \$8 billion to help 40,000 Black and Latinx households access mortgages. The firm said it will help an additional 20,000 achieve lower mortgage payments by providing up to \$4 billion in refinancing loans over the next five years. The mortgage industry is riddled with racism. Lenders deny mortgages for Black applicants at a rate 80% higher than that of white applicants, per 2020 data from the Home Mortgage Disclosure Act. The firm is also tackling affordable housing. Over the next five years, JPMorgan said it will finance 100,000 affordable rental units by providing \$14 billion in new loans and equity investments, among other efforts. According to the National Low Income Housing Coalition, Black, Hispanic, and Native American households are more likely than white households to be low-income renters, meaning there is a severe lack of affordable homes available to them.

“We’re going to track and report on our progress towards these commitments and ultimately hold our most senior level leaders accountable to the progress,” Lamb said.


