ANNIVERSARY OF THE CIVIL RIGHTS ACT OF

Title VI at 57: Commemorating the Passage of the Civil Rights Act of 1964 July marks the fifty-seventh anniversary of the Civil Rights Act of 1964, a landmark law passed at the height of the modern civil rights movement and amid entrenched racial discrimination and massive resistance to desegregation. The law came a century after our country fought a war to end slavery, whose vestiges were then codified by Jim Crow and conserved by the de jure protection of separate but unequal spaces. Put simply, the Civil Rights Act's passage in 1964 was not an end to the struggle, it was a new beginning.

President Lyndon B. Johnson signed the Civil Rights Act into law, and the building that houses the Department of Education is named after him—a reminder that the civil rights movement has deep roots in America's schoolhouses and campuses.

Title VI of the Civil Rights Act is especially important within the Office for Civil Rights (OCR) and the Department, as it applies to elementary, secondary, and postsecondary schools in all 50 states, the District of Columbia, Puerto Rico, and U.S. territories. The law prohibits recipients of Federal financial assistance from discriminating based on race, color, or national origin both in and outside of the classroom.

For almost six decades, OCR has enforced Title VI and its implementing regulations in instances where recipients' unlawful discrimination has taken the form of different treatment of individuals and disparate impact on groups of people. This work is fully part of broader efforts in OCR and across the Department to ensure equal opportunity for students who experience overlapping forms of discrimination based on race, color, national origin, disability, age, and sex, including sexual orientation and gender identity. As Secretary Cardona says, all means all, and we are laser focused on standing with every single student.

The words— "free from discrimination"— are both a foundation and a minimum of what our nation's students deserve and should expect from their educational experience. And yet the fight to protect that foundation is as important now as it ever has been. While progress has been made, we know from OCR's Civil Rights Data Collection that stark racial and ethnic disparities remain in the administration of school discipline, for example, and that far too many schools are racially isolated, inequitably resourced, and do not offer equal access to programs that allow students to succeed.

As President Biden stated in his *Executive Order On Advancing Racial Equity and Support for Underserved Communities Through the Federal Government*, "advancing equity, civil rights, racial justice, and equal opportunity is the responsibility of the whole of our Government." It is a solemn responsibility, and I am proud to be part of a Department that is wholly committed to its execution, in letter and in spirit. Here are some highlights from OCR's ongoing work to advance racial equity:

COVID-19's Impacts on Students and Schools. In June, we issued *Education in a Pandemic: The Disparate Impacts of COVID-19 on America's Students*, which explores how the impacts of COVID-19 are falling disproportionately on students who went into the pandemic with the fewest educational opportunities. Many students who experience the pandemic's harshest effects are from marginalized and underserved communities, with early research showing disparities based on race, ethnicity, LGBTQ+ identity, and other factors.

Discipline in PreK-12 Schools. We are currently soliciting information from the public on the administration of school discipline to determine what type of guidance to schools is necessary to ensure the nondiscriminatory application of discipline practices—please consider sharing your insights. This request

follows our earlier national convening on examining disparities in school discipline hosted by OCR and the Civil Rights Division of the U.S. Department of Justice, which focused on strategies for addressing disparities in school discipline and promoting positive school climates.

Harassment of Asian American and Pacific Islander Students. In May, during Asian American and Pacific Islander Heritage Month, we issued a Dear Educator Letter to remind schools of their obligation to address harassment of students because on their race, color, or national origin, including harassment of Asian American and Pacific Islander students. OCR also released a fact sheet, *Confronting COVID-19-Related Harassment in Schools*, jointly with DOJ, to provide students and families information about the role that ED and DOJ play in protecting students' civil rights.

Civil Rights and School Reopening. OCR's Questions and Answers on Civil Rights and School Reopening in the COVID-19 Environment addresses schools' responsibilities to respond to harassment based on race, color, and national origin, including during remote instruction, to ensure against discriminatory use of discipline, and the responsibility of school districts to ensure against significant racial disparities in access to particular education resources or patterns of racial inequality across a variety of resources, highlighting OCR's earlier guidance on resource comparability.

As we take time today to mark the anniversary of the Civil Rights Act, we also honor the heroes, both known and unknown, who fought for the rights that the law enshrines. And we acknowledge that the fight continues; that the promise of equal opportunity, while closer than it was 57 or 157 years ago, remains unfulfilled. Lansing City Clerk Chris Swope's Office Gearing Up for August 3rd City Primary Election

Extended Hours on Wednesdays & the Weekend prior to Election Day
Voter Registration available until Election Day at City Clerk's Offices

Lansing – The South Washington Election Unit is open to Lansing City voters for walk-in early voting and voter registration for the **August 3rd City Primary Election**.

Located at 2500 S. Washington, the Election Unit offers free parking, a 24-hour secure drop box, and is conveniently located on CATA Route #2. Walk-in early voting will be available at the Election Unit from June 24th until Election Day at the following times:

Monday –Friday	8 am – 5 pm
Wednesday	8 am – 7 pm
Monday, July 5 th	CLOSED
Monday, August 2 Only	8 am – 4 pm (due to state law)

In addition to regular hours, the Election Unit will be open on the following weekend day:

Saturday, July 31 st	11 am – 5 pm
Sunday, August 1 st	11 am – 5

Walk-in absentee voting is also available at the Clerk's City Hall Office, located on the 9th floor of City Hall at 124 W. Michigan Avenue. Please be aware that all City Offices will be closed on Monday, July 5th.

There are two exceptions in Michigan election law which restrict early voting. On the day before the election, no absentee ballots can be issued after 4 p.m. except in an emergency situation. Also, on Election Day, absentee ballots can only be issued to people registering to vote on Election Day.

Voters may download the form to request an absentee ballot, check on the status of their absentee applications, and view the list of candidates with their contact information at lansingvotes.com. Absentee voters who want to skip the required postage when returning their ballots may use one of fifteen secure drop boxes.

Thomas Wilcher Named Michigan State Football Director of Community and High School Relations

EAST LANSING, Mich. – Michigan State head football coach Mel Tucker has named Thomas Wilcher the program's Director of Community and High School Relations.

Wilcher will build and coordinate relationships with key groups in the state of Michigan to enhance the reach and engagement of Spartan football in the community. He previously spent the past 24 years as the head football coach at Detroit Cass Technical High School in Detroit, winning three state titles (2011, 2012, 2016), while teaching physical education. He also coached the boys' track and field team and won three Class A state championships (1994, 1995, 1996) along with two Division 1 runner-up finishes (2001, 2002). Wilcher was inducted into the Michigan High School Football Coaches Association Hall of Fame in 2018 and was named the Detroit Lions Michigan High School Football Coach of the Year in 2011 and the Michigan High School Coaches Association Coach of the Year in 2017.

"I'm excited to announce the hiring of Thomas Wilcher as our Director of Community and High School Relations," said Tucker. "I've known Coach Wilcher for nearly 20 years. His experience coaching, teaching and mentoring youth throughout his entire career have had a tremendous impact on students in Detroit who have gone on to make a difference in the state and across the country. Our program is looking to have an expanded presence in the community and Thomas is the perfect person to maintain and strengthen strategic partnerships for Michigan State football."

While at Cass Tech, Wilcher led one of the top football programs in the state of Michigan, guiding the Technicians to three Division 1 state championships (2011, 2012, 2016), 13 straight playoff appearances, including eight consecutive appearances in the state semifinals from 2010-17, and a record of 120-21 since 2010 (.851). He helped develop eight NFL Draft picks (Vernon Gholston, Joseph Barksdale, William Campbell, Jourdan Lewis, Lano Hill, Mike Weber, Donovan Peoples-Jones, Michael Onwenu), the most of any high school in the state of Michigan since 2006, along with numerous college prospects at the FBS level. His 2016 team finished the season 14-0 and ranked No. 14 in the final MaxPreps national high school football rankings.

A native of Detroit, Wilcher was an exceptional athlete at Detroit Central High School. He won seven state track and field championships (1980: mile relay; 1981: mile relay, 440 relay, 120 high hurdles; 1982: 400 relay, 300 long hurdles, 110 high hurdles) in addition to three team state titles; was a two-time Michigan High School Track and Cross-Country Athlete of the Year; set state records in the 110-meter and 120-meter-high hurdles; and was a Junior Olympics champion in the 110-meter hurdles. He also was an all-state and All-American tailback on the football team and garnered all-city swimmer honors. He still holds the MHSAA state record in the 110-meter-high hurdles (13.6 seconds) and the now-retired 120-meter-high hurdles.

Gun Violence

Lansing should require weapons being transported be locked in the trunk of the car.

Lansing should require insurance on guns.

Lansing should ensure public transportation is available to take residents to entertainment sites.

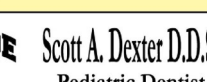
