## ELECTION SPECIAL EDITION

### Voting in Person available now for Lansing City General Election

Extended Hours on Wednesdays & the Weekend prior to Election Day  
Voter Registration available until Election Day at City Clerk's Offices

Lansing – The South Washington Election Unit is now open to Lansing City voters for walk-in early voting and voter registration for the November 5th City General Election. Two at-large (city-wide) Council positions and the First and Third Ward City Council seats are on the ballot.

Located at 2500 S. Washington, the Election Unit offers free parking, a 24-hour secure drop box, and is conveniently located on CATA Route #2. Walk-in early voting will be available at the Election Unit until Election Day at the following times:

Mon., Tues., Thurs. & Fri.	8 a.m. – 5 p.m.
Wednesday	8 a.m. – 7 p.m.
Monday, Nov. 4 Only	8 a.m. – 4 p.m. (due to state law)

In addition to regular hours, the Election Unit will be open on the following weekend days:

Saturday, Nov 2	10 a.m. – 2 p.m.
Sunday, Nov. 3	Noon – 4pm

Early voting is also available at the Clerk's City Hall Office, which is located on the 9th floor of City Hall at 124 W. Michigan Avenue during regular office hours.

There are two exceptions in Michigan election law which restrict early voting. On the day before Election Day, no ballots can be provided after 4 p.m. except in an emergency situation. Also on Election Day, absentee ballots can only be given to people registering to vote.

Voters may download the form to request an absentee ballot, check on the status of their absentee applications, and view a list of candidates with their contact information at [lansingmi.gov/clerk](http://lansingmi.gov/clerk). Absentee voters who want to skip the required postage when returning their ballots may use the 24-hour secure drop boxes, which are located in the parking lot at the South Washington Election Unit and on the sidewalk outside City Hall.

Lansing City Clerk Chris Swope is encouraging everyone to sign up to be placed on the automatic application list to vote at home for future elections. Voters may request to be added to this list by contacting the Clerk's Office at (517) 483-4131 or visiting [lansingmi.gov/clerk](http://lansingmi.gov/clerk).

There is no longer a deadline for voter registration. From October 22 through Election Day, a Lansing citizen can come to either location of the Clerk's Office with proof of residency, register, and vote all in one visit. Alternatively, a citizen may take their ballot with them or vote in their precinct; available options depend on which day they come in, per state law and the new constitutional amendment.

Other changes to election law include: voter registration up to, and including, Election Day; straight ticket voting in partisan general elections; automatic voter registration when applying for, updating, or renewing a driver's license or state-issued personal identification card; election results audits; and more.

"With every voter having the option to either vote at home or vote in person over the coming weeks," said Lansing City Clerk Chris Swope. "we already experienced increased participation in the August Primary. We want all voters to be aware of their options and eliminate barriers to full participation in the democratic process."

### 100 Black Men National Scholarship Program

The mission of the 100 Black Men of America, Inc. is to improve the quality of life within our communities and enhance educational and economic opportunities for all African Americans.

The organization's national scholarship program is operated at the local level through their 100 Black Men chapter network.

The program provides scholarships to national applicants. The award is only open to 100 Black Men mentees, Collegiate 100®, or affiliates who are graduating high school seniors or college undergraduates enrolled full-time in an accredited post-secondary institution. Applicants must be:

- Be a 100 Black Men Chapter mentee or affiliate as verified by the local Chapter
- Be a U.S. citizen or permanent U.S. resident
- Currently or planning to be enrolled in the Fall semester of 2019-2020 academic year as a full-time undergraduate student
- Maintain full-time status during entire

2019-2020 academic year

- Have a minimum 2.5 GPA on a 4.0 scale
  - Selected applicants will be qualified mentees or affiliates with a proven financial need
- Scholarships are awarded to eligible applicants who demonstrate they have a significant gap in the financial resources needed to pay for their post-secondary/college education. Upon completion of the evaluation, selection and award determination process, 100 Black Men Chapters and the scholarship recipients will be notified via email. ## MoneyWalk 414:

### Debt Bondage vs Debt Freedom and Wealth

This program will help you undo financial bondage.

The vast majority of investors earn far less than what the markets return over time due to (1) poor spending and investment habits largely due to the desire to have every iota of material things they can spend and borrow to get and (2) fear displayed in down markets which cause them to never invest or to pull their investments out of the market. The few people who tend to do much better are long-term investors with diversified portfolios that do not follow the above example and who generally avoid investment expenses higher than one-half percent annually. The long-term average for the stock market has been about 11% since 1926 and has no twenty or more consecutive year period that experienced a loss. However most people earn less than 4% on average some experience huge losses because of the above noted desire and fear and thus fail to work a plan to get out of debt and use a good stewardship platform to help build wealth that serves them, their family, and others. Debt-freedom is the believer's heritage from the LORD that He empowers you to live in and prosper from so you can be all He made you to be. Most financial pundits lead people down a path that keeps them broke and subject to foreclosure, bankruptcy, and repossession because the behavioral nature of failing to see the wisdom in debt-freedom leads people to take on more and more debt over time because they really do not see it as a problem. In fact, we come into contact with many who are broke and busted who talk about eliminating stress, pressure, depression, and trouble caused by debt by trying to borrow more to pay off their pain causing debt. Somehow, they think new debt (credit cards, personal loans, and such) and salesmen who peddle it are going to treat them better than they have in the past.

Let's not even mention the fact that people who have no aversion to debt do not control their impulses, which usually moves them to get more house than they can truly pay for without problems down the road including pain from the debt-based purchases they will to get all the things for the house as quickly and as often as they can.

It has not been uncommon for me to see people jumping around from house to house every five to seven years building no home equity and no wealth and buying many new furnishings for those houses



even more often than that - all on debt. All the while they are putting very little, if anything, into investment accounts (Roth IRA, 401k, 403b, brokerage accounts, etc.) that would help them greatly in future years

when they really need the assistance. This behavior often carries over into the use of debt to pay for over-the-top vacations and excessive activities for their kids (sports leagues, dancing, you name it).

Most of them get so used to having debt that they don't even look for better or lower cost alternatives because their use of debt has become a habit they dare not eliminate because it means they will not get things they want when they want them. Much of the getting is not good for them long-term because it is focused on getting things with depreciating value, low liquidity, and/or when their financial situation, if measured, shows they should not be trying to pay for right now.

Believe and employ God's instruction in the bible rather than man's instruction based on worldly habits. Follow His dream for your spiritual and financial fruitfulness versus the American Dream, pay off your debts including mortgages as quickly as possible, seek to stay that way, allow your financial plan (budgeting and debt-freedom) to be one that allows your disposable income to be the engine that will build wealth for the future through the God-given eighth wonder of the world - long-term compound interest and exponential growth.

### Lansing Reaches Agreement on Police Contract

Agreement Addresses Legacy Costs

**(LANSING)** - The City has reached an agreement with the Capital City Labor Program (CCLP) union for a multi-year, competitive collective bargaining agreement for the Lansing Police Department (LPD). The terms of the agreement were ratified by the CCLP supervisory and non-supervisory units at the end of last week, and Lansing City Council approved the terms Monday evening. This agreement is the result of hard work by both our police unions and city bargaining teams.

The agreement would keep LPD officers' wages competitive and help the City seriously address its long-term legacy costs. The agreement eliminates retiree healthcare benefits for new police officers hired after November 1, 2019. Those officers will receive a retiree healthcare savings account instead.

Additionally current officers eligible for retiree healthcare benefits will have the option to opt into a retiree healthcare savings account. Finally, eligible officers retiring after July 1, 2020 will have healthcare that mirrors active officers. All of the negotiated changes are critical for the City in dealing with short and long-term legacy costs.

"I am thrilled that the City of Lansing and our police officers have come to an agreement that shows financial appreciation for our law enforcement while also assisting the City in addressing future unfunded liabilities and legacy costs. These are both critical for Lansing's future," Mayor Andy Schor said. "These changes to retiree health care are significant, and they allow us to continue to provide important benefits for our police officers in a way that is more affordable for the City. Thank you to our police officers for working with us to make these important changes and for all of the work they do to make Lansing a great city."

The agreed upon changes will go into effect immediately.

## 2020 Toyota RAV4 TRD Off-Road: First Look



**Equipped to tackle rough ground and severe snow comes with many safety features as standard On sale fall 2019**

The 2020 Toyota RAV4 TRD Off-Road Opens in New Windowtakes a best-selling compact crossover/suburban warrior and turns it into a terrain-conquering hero. The basic vehicle is the RAV4 in Adventure trim, but then the engineers at Toyota Opens in New Window Racing Development (TRD, the company's performance division) brought in some new ideas along with expertise gained through rally racing a version of the RAV4.

### What is TRD's Input?

It's much more than a cosmetic overhaul, but it should be said that this RAV4 looks like it really means business, with the distinct grille, front and rear fascias, cladding on the rocker panels, rear spoiler, high-rise roof rails and 18-in alloy wheels finished in matte black. The interior is similarly rugged, with TRD badges on the hard-wearing simulated leather upholstery (further enlivened by contrasting red stitching) and all-weather mats. The suspension has been re-worked with twin-tube shock absorbers and new springs tuned especially for off-road work. The tires are Falken Wildpeak A/T (all-terrain) and rated for Severe Snow. They were developed in conjunction with TRD.

### What's Under the Hood?

The 2020 Toyota RAV4 TRD Off-Road has the same engine as the rest of the range, a 2.5-liter 4-cylinder unit that generates a meaty 203 horsepower. It's linked to an 8-speed transmission and a torque-vectoring all-wheel-drive system (where the system can send power to different wheels for optimum traction and more precise cornering lines) is standard in this model. The RAV4 TRD Off-Road has a tow rating of 3,500 pounds. Also included is Multi-Terrain Select, allowing the driver to scroll between different modes, such as Mud & Sand, Rock & Dirt, or Snow.

### What Else?

Like most Toyota vehicles, this model has an array of advanced driver aids. Included here is adaptive cruise control, lane-tracing assist/lane-departure warning with steering assistance, forward-collision warning with pedestrian detection, road sign recognition and automatic high beams. Blind spot monitoring with rear cross-traffic braking is another standard feature in the 2020 RAV4 TRD Off-Road, along with a 7-in infotainment touchscreen and Apple CarPlay.

### When Does It Go on Sale and How Much Will It Cost?

The 2020 Toyota RAV4 TRD Off-Road arrives fall 2019. Pricing will be announced closer to that time.
