FREEDOM is on the ballot this November.

Our elections are secure, accurate and fair. Thousands of Republican, Democratic and independent election clerks, staff and volunteers make sure this is true every election. They follow the law and adhere to strict security protocols to make Michigan’s elections system among the strongest and most secure in the nation. The people who say otherwise want to convince you not to vote, or not to believe in any election they or their preferred candidate doesn’t win. Don’t be fooled into giving up your constitutional right to vote and have your vote count. Inform yourself about Michigan elections so you know the truth.

Election Law Implementation at Polling Places and Counting Boards

Michigan elections are among the strongest and most secure in the nation. False information about elections is dangerous to our democracy. Fact Checks provide factual information so all Michiganders can have faith in our elections.

Michigan election law authorizes the Secretary of State to issue instructions for the conduct of elections and registrations, including advising and direct-

ing local election officials and publishing a manual of instructions. The Michigan Election Administrators Manual was drafted more than a decade ago and has not changed significantly since then. Michigan’s elections are administered by the state’s 1,520 township and city clerks, who follow both the law and instructions in the Administrators Manual. The law gives clerks and the election inspectors they hire the authority to maintain peace, regularity and order at polling places and absentee ballot counting boards, and the Administrators Manual therefore requires election challengers to interact with a challenger liaison, as that is an efficient and consistent procedure for resolving challenges while maintaining order. Similarly, clerks and election inspectors have the authority to eject challengers who repeatedly disobey they law and issue challenges that are impermissible under the law.

The law also protects the voter’s right to a secret ballot, which is why the Administrators Manual prohibits the use of cameras and recording devices in polling places and counting boards. Voters are allowed to take a photo of their ballot while in the voting booth, if they do so without photographing anything in addition to the ballot. At the clerk’s

discretion, media organizations may be allowed to record quick panning shots of polling places as long as they do not capture personal information of voters. **Absentee ballot drop boxes are secure and convenient for voters**

Absentee ballot drop boxes provide a convenient and secure way for voters to return their absentee ballots to their local clerk, and township and city election clerks have accepted absentee ballots in drop boxes for many years. The state Legislature codified the practice in 2020 by passing [legislation](#) with bipartisan support to ensure drop box security. That was the first statewide election cycle in which all Michigan voters had the right to vote absentee – following a 2018 voter-approved constitutional amendment. Also, in 2020 all Michigan clerks had access to federal funds to use for drop boxes.

All videos suggesting drop boxes were used to commit election fraud in Michigan have been debunked for lack of evidence and understanding of Michigan election law. For example: In a video where a person is shown possibly bringing and signing more than one ballot to a drop box, they can legally be returning ballots for voters who are family members or members of their household, or voters who have a disability or otherwise need assistance. If so, the signature of the person bringing the ballot

is required in addition to the signature of the voter. Further, all absentee ballot envelopes are checked to ensure the signature of the voter matches their signature the clerk has on file with their voter registration. In a video where a person is shown possibly transporting blank absentee ballots, they can be delivering them to satellite clerk offices for voters to use, or to an absentee counting board to duplicate military ballots that come in from overseas and need to be put on different paper to go through a tabulator.

Where a U.S. Postal Service employee is shown possibly putting absentee ballot applications or ballots into a drop box, this is a normal and legal activity, as USPS workers are required to expedite the return of election mail either by delivery to the clerk’s office or drop box.

Certification

The bipartisan boards of canvassers at the county and state level are required by law to affirm the will of the people as demonstrated by the number of votes cast for each candidate in an election.

Following the 2020 general election, the boards of canvassers in all of Michigan’s 83 counties, as well as the board of state canvassers, certified the results.

Each board is comprised of two Republicans and two Democrats. Michigan law provides the coun-

ty canvassers 14 days to examine everything that transpired in the elections in jurisdictions in their counties, and then certify the results and election. The state board of canvassers subsequently must vote to certify all the county elections. If canvassers were to encounter any evidence of fraud, they would need to report it to law enforcement. Following the 2020 election, no canvassers reported any fraud or other illegal activity occurred.

The Board of Wayne County Canvassers initially deadlocked 2-2 in its vote to certify, but later in the same meeting, members voted 4-0 to certify. The initial vote was taken after some canvassers expressed concern about precincts that were out of balance in Detroit. However, out-of-balance precincts are common in Michigan and across the nation. They essentially represent clerical errors where the number of people who were checked into each poll book doesn’t exactly match the number of votes counted or ballots submitted. There are many reasons this can occur: for example, a voter being checked in at the right polling place but the wrong precinct, or a voter checking in but leaving with their ballot if they decide not to vote. In fact, at least 72% of all Detroit precincts were balanced

or explained, compared to just 42% in 2016, when both the boards of county and state canvassers certified the election.

Are Minorities Underrepresented in STEM?

In short, the answer is yes. According to the National Science Foundation, the STEM workforce is 89% white and 72% male, while the overall workforce is 78% white and 53% male. Preliminary 2020 U.S. Census data shows that the United States is diversifying more rapidly than expected, with nearly four of 10 Americans identifying with a race or ethnic group other than white. The STEM workforce does not reflect this increasing diversity. This is a major issue for STEM fields, and particularly for the tech industry. We are going to take a closer look at underrepresentation in the tech field and explore this topic further.

What are underrepresented minorities in tech? The National Center for Science and Engineering Statistics defines an underrepresented minority as three racial or ethnic minority groups (Black or African Americans; Hispanics or Latinos; and Native Americans or Alaska Natives) whose representation in science and engineering education or employment is smaller than their representation in the U.S. population.

When looking at who is considered an underrepresented minority, it is important to keep in mind that the term “underrepresented minority” is a general umbrella used most often in educational or research settings. The specific circumstances and factors that lead to underrepresentation are unique to each group. So we will refer to these groups individually as much as possible throughout this piece instead of focusing on the umbrella term that might misrepresent their unique barriers.

How diverse is the tech industry? Looking at diversity in the tech industry statistics, the answer is clear: the tech industry has a big issue.

While reading this section, keep in mind the population segments in the United States:

- 13.4% – Black
- 18.5% – Latinx
- 1.3% – Native American/Alaskan Native
- 0.2% – Native Hawaiian/Pacific Islander


Looking at Black computer science graduates, we see the lack of diversity represented starkly. According to the U.S. Census, Black Americans comprise 13.4% of the general population. Duke University looked at computer science graduates between 2011 and 2018 and found that Black students made up only 3% of the graduating classes. Federal data shows that from 2017 to 2019, only 8.6% of computer science graduates were Black.

Computer science also has one of the lowest percentages of female degree recipients. In fact, only 19.9% of computer science undergraduate degrees were awarded to women in 2018, despite 50.8% of the population being women.

Intersectionality is important to examine as well. Women earn 21% of all doctorates in computing;

less than 5% are awarded to Black, Latinx, Native American/Alaskan Native, or Native Hawaiian/Pacific Islander women, however.

Big tech companies began publishing annual diversity reports in 2014, but the numbers have not moved much since that time. For example, Black workers represented 3% of Facebook’s workforce in 2014 and that number has only increased to 3.8% over



the time of reporting. Women have moved up as a higher fraction of the workforce, with Google and Facebook’s percentage of female workers in 2014 hovering around 15%, increasing to 23% at the beginning of 2019.

Google’s 2020 annual diversity report did show some improvement, although not enough to be able to claim parity—5.5% of employees identifying as Black or Black and any other race, and 6.6% identifying as Latinx or Latinx and any other race. 32.5% of employees identified as women. This is not an isolated case, as industry peers show similarly skewed statistics. Amazon and Apple had slightly higher proportions of Black and Latinx employees due to the retail and warehousing units where these communities have greater representation in these companies.

Why diversity in tech is important

Diversity in the tech industry can sometimes seem like a nice buzzword or pat-yourself-on-the-back type of goal for businesses to achieve. However, building inclusivity and diversity into the tech industry is necessary and beneficial for all parties. Here are a few of the many reasons why diversity in tech is important

Homogenized Workers = Homogenized Products

The real world is a diverse place. If your team is composed of people who all look the same and come from similar backgrounds, then they will most likely build a product that is targeted for people who look like themselves. To create products that work for everyone, it’s necessary to include input from a diverse range of people.

Increased Profits

One global survey found that when profitable firms moved from no female leaders to 30% representation, there was a 15% increase in the net revenue margin. Gender diversity leads to increased profits, and diversity in general is simply good for your bottom line.

Creative & Quick Solutions

Diverse teams bring together a range of different knowledge bases. They are able to provide perspectives that can help solve problems in innovative ways quicker than groups who share similar perspectives and backgrounds. In fact, a diverse team is able to identify and solve issues that a homogenized team would overlook. Diverse teams provide better outcomes.

Customer Connection

Software is used by humans, and these end-users of these products are a diverse group of people. Diverse teams tap into their own knowledge bases and create products that all customers can connect with. Why is there a lack of diversity in the tech industry? For example, one study done by Gallup and Google in collaboration found that structural barriers such as limited access and exposure to computer science create disparities. This study found that Black students are less likely than white students to have classes dedicated to computer science at the school they attend (47% vs. 58%, respectively), and that Black (58%) and Hispanic (50%) students are less likely than white students (68%) to use a computer at home at least most days of the week. The social barriers include issues with the perception that computer science is a field for white men and found that female students are less likely than male students to be aware of computer science learning opportunities on the Internet and in their community. How do we solve the lack of diversity in the tech industry?

While there are no easy answers, there are specific actions that can, and should, be taken. 

Voting at the Polls

Do's and Don'ts

- Do:** Check your registration and find your polling place at Michigan.gov/Vote. If your registration is not up to date, visit your clerk's office immediately with proof of residency.
- Do:** Bring photo identification with you. If you do not have photo ID, you will need to sign a statement before voting.
- Do:** Request use of the Voter Assist Terminal. if you have a disability or would prefer to use it.
- Do:** Maintain the secrecy of your ballot. Keep your ballot in its secrecy sleeve, except when voting, and then up until the time you feed it into the tabulator.
- Don't:** Speak to anyone who says they are a poll watcher or challenger. They are not allowed to speak to voters. Report violations to an election worker immediately.
- Don't:** Leave the polling place without voting. The law requires that anyone in line by 8 p.m. be allowed to vote.
- Don't:** Allow anyone else to cast your ballot for you. It is your ballot and you must place it into the tabulator.

Report any voter intimidation, harassment or coercion you witness.

Foster Community Center Opens A Pop-Up Satellite Clerk's Office for Voter Registration And Early Voting



LANSING, MI —Lansing City Clerk Chris Swope, Mayor Andy Schor, , Ingham County Clerk Barb Byrum, Eastside Neighborhood Organization President Nancy Mahlow, and Lansing Branches Head Librarian Melissa Cole opened the “Pop Up Satellite

Lansing City Clerk’s Office at the Foster Community Center, 200 N Foster Ave., with a ribbon cutting ceremony and tour of the one-stop location for voter services for city residents.

At the Foster Center Lab Room 110, Lansing City voters will be able to register to vote, pick up an absentee ballot, or receive a replacement ballot for a spoiled or lost absentee ballot. The “Pop-Up” Office will be open 1:00 p.m. to 6:00 p.m. Monday through Friday until November 6th, stop issuing ballots at 4:00 p.m. on November 7th, and be open Election Day from 7 a.m. – 8 p.m.

“The opening of this Pop-Up Office coincides with the requirement that all new voter registrations must be in person from October 25 thru Election Day,” said Lansing City Clerk Chris Swope. “There is no voter registration deadline in Michigan. However, the process does change from online to in-person with proof of residency. I also want to thank the Capital Area District Library for sharing their Foster Lab Room for two weeks so that we can provide this additional option.” Newly registered voters may also vote in the same visit when they provide proof of their residency, even in electronic form. They also have the option of receiving a receipt and vote at their precinct on Election

Day.

The other Clerk’s Office include the South Washington Elections Unit in the back of the building at 2500 South Washington with weekend hours from 10 a.m. – 6 p.m. on October 29th, November 5th and 6th, and Lansing City Hall with traditional hours from weekdays 8 a.m. – 5 p.m.

With the addition of the Red Cedar Development, housing hundreds of Michigan State University and Lansing Community College students, the Foster Community Center offers a convenient option for thousands of new residents and makes voting more accessible to a larger portion of the community.

“I am excited for the increased opportunities being provided for city of Lansing voters, said Mayor Andy Schor. “The Eastside has an influx of new voters due to successful development projects and increased housing options, and now they will have an easy option to vote here at Foster. Lansing is proud have several voting locations to choose from that will make voting easy for our residents and minimize wait times at any location.”

EAST LANSING - Michigan State's football team scored a pair of overtime touchdowns to beat Wisconsin, 34-28, and end a four-game losing streak at Spartan Stadium here October 15.

The Homecoming victory came just in time to give the Spartans hope in their Saturday, October 29 nighttime visit to the Michigan Big House.

After experiencing a bye week, the Spartans will be a bit healthier with two experienced graduate students, Xavier Henderson and Jacob Slade slated to see their second game action of the season. The pair had been out injured all season and saw their first significant time against Wisconsin.

Henderson, the most experienced defender on the team who calls signals and leads communications, got dinged and left the game early, but returned in

the second half and overtime. He finished with five tackles, four unassisted and one for a three yard loss. Slade was the top defensive interior lineman. Having them back and rested after a game's action should give the Spartans badly needed help.

The Spartans enjoyed some defensive success in the Wisconsin victory, and hope to build upon that. They employed a 4-3 defensive formation and are expected to continue to use that alignment against the Wolverines.

Jacoby Windmon, a transfer linebacker from University of Nevada Los Vegas, moved from defensive end, where he had been stationed all season, back to linebacker. Windmon led all tacklers against Wisconsin with 11, had an interception, and caused the fumble the MSU recovered to set up the winning overtime touchdown.

Quarterback, Payton Thorne connected with wide receiver, Jayden Reed for a touchdown in the second overtime to earn the Wisconsin victory. Reed hit Keon Coleman with a 25-yard touchdown pass to put MSU ahead 28-21 in the first overtime before Graham Mertz hit Chimere Dike with a 25-yard pass to send it to the second overtime.

The victory gives the Spartans an opportunity to turn their season around. A victory would even the season record at 4-4, and put MSU back on track to posting a winning season. A loss would give MSU five losses with just four games left in the season.

A loss by Michigan would all but ruin the Wolverine's season.

No doubt about it. This game in Ann Arbor is not just another football game.


