1. Telephone: Old School Landline: 303-823-5677 (No texting; you may reach a live person or answering machine).
2. Text: 720-310-5648 Google Voice: Text message only; no Voice Mail
3. Website: Visit: [www.fri-rentals.com](http://www.fri-rentals.com) to review and download leasing documents
4. Showings: Scheduled in advance; requires 24 hr. notification of current residents.
5. Rental Application Fee: \$42 per person (e.g., 3 residents = \$126.00) (bank check or money order; no cash)
6. Reference Check: Rental Applications: Submit Applications, Fee, and copies of current Drivers License or Passport.
7. Make checks out to: Fountain Ridge Investments
8. Lease Signings: Earnest Money Deposit (becomes the Security Deposit) is required at the lease signing (equal to 2x monthly rent)
9. The EMD must be a Cashier's Check (no personal bank checks, money ordered, or cash accepted)
10. Changes to the lease once signed are subject to an Administrative Fees of \$250.00 (per person)
11. Rents are paid by direct deposit: Due and payable on the 25th of month prior to month applied.
