NEW!! Judges Choice Awards - Top Dog and Reserve

Bring us your Master Superstars!

The Judges Choice Awards are new to Arizona Earthdog and are not associated with AKC titles or points. It will be an award only offered to Master Level qualifiers. All Master Earthdog entries are eligible. The owner must check the box for JCAward on the entry form to be included for consideration. ***There is no additional charge!*** If you do not check the box, your dog will not be assessed for this category. Master Earthdog entries will be judged on a regular Pass/Fail according to the AKC regulations for the class and all Qualifiers will receive Qs on their AKC records. A Qualifying dog's Passing performance will be scored for what

behaviors the judge feels are above the requirements for a Pass (minimum standards for the class under Chapter 4, Section3). If the dog does not Q, they will not be considered for or receive a JCAward score. A standardized score sheet will be used listing the requirements of Master Earthdog test, each element will have a standard 3 for Pass. If the judge feels they have exceeded this element, they can score their performance up to a maximum of 10 points. The 3 Master judges for the weekend have agreed to score dogs towards the Judges Choice Award. Ties will be decided by a consensus of the judges.

NOTICE TO EXHIBITORS

- To participate, dogs must be at least 6 months old. Dogs can be spayed, neutered, have limited registration, FSS, PAL, and ILP dogs of eligible breeds may participate. A dog of an eligible breed with an acceptable foreign registration number is eligible subject to Chapter 11, Section 1 of the Dog Show Rules.
- Dogs ineligible for entry* include deaf or blind dogs and dogs owned/co-owned by the test judge or family. Bitches in season shall not be eligible.
- Entry fees will not be refunded for bitches in season.**

Arizona Earthdog Club offers a ribbon to each dog that earns a qualifying score in a class. Rosettes will be offered to any dog that finishes a title. If an EE title is earned at these events, a new title ribbon is available. Dog toys as well as whistles will be offered to each dog that qualifies. A piece of dachshund memorabilia is offered to each dachshund that qualifies in a regular class. Donated by Fernande Hasert Kuykendall.

No food or treats are allowed in rings or den areas. Pre-packaged snacks and water will be available at this event. There are restaurants within a 10-minute drive from the Equestrian center, or you can bring your own lunch and snacks. No shade is available at the Trial area; BRING shade for you and your dogs.


