Credential Engine

1. **Participation Opportunity:** Credential Engine's CTDL team completed the Credential Type Focus Group and a public webinar that shared the CTDL Credential Type Terms Proposal. While CTDL already defines many credential classes issued by providers, it does not yet support full descriptions of formally defined credential types embedded in qualification systems. This proposal aims to close that gap. The public comment period concludes May 23rd. 2. **Participation Opportunity:** CTDL currently supports over 10,000 published [Transfer Value Profiles](#)—including information on credit recommendations and credit transfers accepted. However, it does not yet describe the policies, agreements, and criteria that govern whether and how prior learning is accepted. To address this gap, Credential Engine is convening a global, time-limited task group starting in June to expand CTDL by making this essential information transparent, connected, and reusable—supporting successful learn and work pathways for all. 3. **Participation Opportunity:** Credential Engine invites organizations to participate in a focused, collaborative pilot launching in ~June/July 2025 to advance the transparency, comparability, and interoperability of qualifications data globally. In partnership with the [Groningen Declaration Network \(The GDN Network\)](#), [South African Qualifications Authority \(SAQA\)](#), [American Association of Collegiate Registrars and Admissions Officers \(AACRAO\)](#), and other key stakeholders, this Qualifications Frameworks (QF) Publishing Pilot will demonstrate how [regional and national qualifications frameworks](#), related credentials, and information that supports quality assurance can be structured as linked open data using the Credential Transparency Description Language (CTDL). 4. **Info Sharing:** Credential Engine and the South African Qualifications Authority (SAQA) have partnered to explore global credential transparency beginning with a proof of concept (POC) using CTDL linked, open data structure. This POC will publish qualifications frameworks (QF) at a granular level to support mappings between their progression levels, credentials and their alignments to QF progression levels, quality assurance, and potentially outcomes metrics.
