

PASSAGE OF LEGISLATIVE BILL 1011

On April 7th 2022, Legislative Bill 1011 was approved on a 42-3-4 vote by Nebraska's elected representatives. LB-1011, among other things, will provide a permanent 15 percent provider rate increase for DD providers. This increase will continue to ensure the State will have adequate resources available to provide community based treatment to individuals and avoid unnecessary institutionalization. The passage of this bill can be seen as a reflection of how the community values the services ABLED, Inc. and its partners provide, and most importantly, the value of the lives of people these services are meant to serve.

THE NEBRASKA OLMSTEAD PLAN

The term "Olmstead Plan" derives from the Supreme Court's 1999 ruling in Olmstead v. L.C., which held that the Americans with Disabilities Act (ADA) prohibits the unjustified institutional segregation of individuals with disabilities. Specifically, the court concluded that public entities must provide community-based services—as opposed to institutionally-based services—to persons with disabilities. Nebraska's Olmstead Plan is a framework designed to provide a solid structure for a flexible plan to ensure laws, regulations, and future planning are consistent with the principles of the Olmstead decision.

- 1. Person— and family-centered approaches.
- Ensuring the safety of, and an improved quality of life for people with disabilities
- 3. Services that are readily available, at locations accessible to individuals in need and their families
- 4. Supporting individuals to live a meaningful life in the community they choose






The Lincoln Haymarket Farmers
