She writes and maintains behavior protocols in safety plans. She is available for behavior consultations. A conference room is available for meetings or training.

## WHAT'S GOING ON AT DHHS

## PROPOSED SHARED LIVING CHANGES

DHHS continues their work to draft changes for Shared Living services. The final policy update is scheduled to be announced next month with changes effective Jan 1. Previously proposed changes included:

- 1. SLPs would no longer be allowed to provide day services for the participant living in their home.
- 2. School age students may have different rules.
- 3. Agency would complete two SLP home visits per month for advance or higher. One home visit required for all other tiers.
- 4. SLP contracts would pay a flat rate such as 80/20.
- 5. No more than two participants in an SLP home.
- 6. Only one participant in an SLP home for advanced tier and higher.
- 7. No awake overnight service authorization in an SLP home.
- 8. No SLPs allowed for staffing greater than 1:1.

Certain changes to SLP services may be grandfathered. Grandfathering would ends when someone moves in or out, or if staff changes agencies.

We will keep everyone posted of the final policy changes. We will work together with each team to make arrangements to ensure all participants receive the highest quality services.

## **CORRECTIVE ACTION PLAN (CAP)**

CMS approved Nebraska's Corrective Action Plan on Jun 26, 2023. The CAP will allow Nebraska additional time to demonstrate compliance with the Final Settings Rule for settings under heightened scrutiny.

- Settings providing inpatient treatment.
- Settings adjacent to a public institution.
- Settings with the effect of isolating people.

### **GUARDIANSHIP IN NEBRAKSA**

## LB376 FAMILY SUPPORT WAIVER

DHHS is developing a new waiver. This will be a Medicaid Home and Community-Based Services Waiver with developmental disabilities eligibility requirements.

The intent of the waiver is to help eliminate unmet needs for children ages birth to 21 years in Nebraska. The new waiver will serve up to 850 children with developmental disabilities. Each participant will have a maximum annual budget of \$10,000.

The 30-day public comment period is from July 28 through August 27, 2023.

Upon approval by CMS, this waiver would go into effect January 1, 2024.



# 2 CORINTHIANS 1:3

"Blessed be the God and Father of our Lord Jesus Christ, the Father of mercies and God of all comfort"

Paul often begins his letters by giving thanks to God for those to whom he is writing, as well as praying for them in some way. His letter in 2 Corinthians is different. Instead, he begins by focusing on God's comfort to those who experience affliction.

He starts out by offering praise to the God and Father of our Lord Jesus Christ. Paul often focuses his prayers on God the Father, something possible only through personal faith in Christ the Son, who is our Lord. (John 14:6)

Because God stands in the position of judge over all people, He is also the source of all mercy. Instead of executing judgment on all who deserve it—which is all of us—He freely gives His mercy to those who come to Him through faith in Christ (John 3:16-18). Paul understands that in the middle of our suffering and affliction, believers must remember that God has given us mercy and will continue to do so.

He is also the God of all comfort. Christians do not run *from* God to seek relief from their pain; they run *to* Him as the source of comfort. God's comfort is a major theme of 2 Corinthians.

Some form of the word translated comfort, *paraklesis* in the Greek, appears 29 times in this letter. The idea of the word is more than just momentary relief from pain; it also involves encouragement and strengthening.

God's comfort allows us to quit striving in our own strength against suffering and affliction and to rest, to be strong, in His strength.
