

DD Funds To Reduce Employee Turnover and Increase Tenure

On May 2, 2023, Director Tony Green notified DD Providers of an upcoming onetime stabilization payment. We thank the members of the Nebraska Association of Service Providers (NASP) for bringing awareness and their work at the Capitol.

DD agency providers will receive the one-time payment in June 2023 to be tiered by the amount of payments provided in CY2022 and will total \$18 million. ABLED's share will be a very small percent of the \$18M. As stated in the provider payment memo, "the purpose of the payments is to stabilize active independent providers and increase the DD agency provider's ability to hire and retain staff."

ABLED has been very blessed not to have a shortage of high quality applicants wanting to work for us. We do not plan to have a program to attract additional applicants.

ABLED and other agencies are required to submit metric reports to DHHS by the assigned due dates. We will need to reduce employee turnover and increase staff tenure over the next year. DHHS will measure our performance at the end of 2023 and again in June 2024 to see if we met the required metrics. Should the required metrics not be met, the department would retain the ability to collect the provider payment funds back.

DHHS will need to provide some clarification and additional details before we can finalize our plans to disburse funds. Tentatively, ABLED is considering to pay our employees a bonus at the end of the year and again on the July 2024 payroll. At this time it appears SLPs are not included as beneficiaries of the payment unless they are also DSPs.

Employees must remain employed and be in good standing per the Employee Acknowledgment to receive the bonus. The payments will be based on length of service and earnings. Employees with longer tenure will receive more.


A miniature golf course decorated in a tropical theme with over 40 realistic dinosaurs and featuring two 18-hole courses.
