However, it is important you submit a copy of your insurance card (front and back), as well as your lab order. (orders must be signed by a physician with DX codes provided) The preferred laboratory where your specimens will be delivered and processed will need this information to bill your insurance for laboratory testing. Lab order requisitions, and insurance information can be submitted via fax, download, or email.

Lab results are sent directly to the ordering provider by the preferred laboratory. If you have any questions or concerns related to your pending lab results, please contact your provider's office.

Way Out West Mobile Phlebotomy LLC is not responsible for any errors that may occur after being delivered to the preferred laboratory/courier.

Please be advised that Way Out West Mobile Phlebotomy LLC is not responsible for any outstanding balances you may have with the preferred laboratory your specimens will be processed at. Laboratories do have the right to decline the specimen of a patient that may have an outstanding balance.

Please be considerate. In the event an appointment needs to be cancelled, Way Out West Mobile Phlebotomy LLC needs to be given an 8-hour notice prior to scheduled appointment. This is to avoid any rescheduling fees. Please make sure to Prepare for your blood work. If you are uncertain of fasting or have any questions about preparing for your lab work, please reach out to your providers office. Any special instructions need to be clarified prior to making an appointment with Way Out West Mobile Phlebotomy LLC.
