Approval of Agenda: Motion by Moore, Seconded by Stemaly.

Motion by Moore, Seconded by Overley to approve November 12, 2020 minutes, carried. No December minutes as the meeting was canceled.

Tommy updated us on Calhoun Co9unty Road Commission. He proposed at their last meeting that if the townships don't like the cost from the county that the townships should have the option of getting their own contractor.

James Escamilla, president of Bryce, discussed the township withholding payment due to Cost Overrun changes that were made to the renovation of the Fire Hall due to errors in the drawings. Jim said one of the Change Order notice was an error on the part of a 3rd party contractor that gave Bryce the information. He also stated that the original drawings were for a projected \$2,000,000.00 new building and that it ended up being changed to a \$900,000.00 renovation project, and due to these changes, there as some work that was done that we were not charged for.

Motion by Stemaly, Seconded by Overly to approve paying Byce the \$12,000.00 and not withhold payment for the Change Order expenses.

Audit will be discussed at next meeting and we plan on keeping the budget the same, which we will review at the annual budget meeting. Our estimated township income will \$2581.77 per year for the county parks millage. There has been interest expressed for these.
