Board of Trustee Minutes for July 8, 2021

Call to Order: 7:00 pm

Quorum was determined with the following members present: Overley, Moore, Zadigian, Thomas & Stemaly.

Approval of Agenda: Motion by Moore, support by Stemaly.

Motion by Moore, support by Stemaly, with correction to approve June 10, 2021 minutes, carried.

Motion by Moore, support by Thomas to issue conditional use permit for Pallet Construction and Sawmill with amended hours for shipping and receiving to Rudy Schwartz to 7am – 7pm.

Public Comments: Dustin Danke would like the Amish to put a fence up around their property to keep the noise down from their pallet and sawmill construction. The Amish offered to insulate their shop to help keep any noise down. Dustin Danke also stated that he heard someone state that the Amish were bribing the counsel so they would approve the Conditional Use Permit.
