



## PUPPY PICK-UP EXTENDED BOARDING POLICY

Potential buyers are expected to pick up their puppy within 3 days of pick-up date (decided by breeder). If they are not able to and would like an extension of the pick-up date, please fill out all information below and sign. All pending fees are due in full along with this signed contract.

### 1. Boarding

If the puppy remains with the breeder beyond the standard pick-up window, an extended boarding fee of \_\_\_\_\_ per night will apply until the day of pick-up.  Initials: \_\_\_\_\_

### 2. Payment Requirements

All boarding fees must be paid upfront alongside the remaining balance due for the puppy, based on the agreed pick-up date.  Initials: \_\_\_\_\_

### 3. Care Provided During Boarding

The breeder will provide normal daily care, feeding, and basic socialization during extended boarding.

### 4. Veterinary Care

If the puppy requires veterinary treatment for any reason during the extended boarding period, all costs are the responsibility of the Buyer. These must be reimbursed in full before the puppy is released.



## 5. Failure to Pick Up Puppy

If the puppy is not picked up by the final agreed-upon date of \_\_\_\_\_ the puppy will be considered forfeited. Ownership remains with the breeder, and the puppy may be re-listed for sale.

No refunds of any kind will be issued.

## 6. Changes to Pick-Up Date

Any request for an extension beyond the originally agreed pick-up date must be approved in writing by the breeder.

Additional fees may apply.
