Letter from Chair

Dear Union County Democrats,

As I step down from my role as Chair, I do so with a heart full of gratitude and deep reflection. Being the first elected Black Democratic Party County chair in an area like Union County has been both a tough road to plow, as well as a great honor and a responsibility that I've carried with pride. Over the past two years, I've knocked on countless doors, had transformative conversations on porches and in driveways, stood shoulder to shoulder with many of you at rallies to fight for our rights, smiling and dialing on phone banks, and watched neighbors become friends through the shared purpose of progress. We've held educational forums that challenged our biases, hosted fun community events full of laughter and learning, and built bridges that I hope will last long beyond any one term or title.

Every meeting—whether it was two people or twenty—was a reminder that this work is slow, often difficult, but necessary. I saw the fire in our volunteers' eyes when we canvassed, the dedication in the late-night weekly Wednesday call shifts, and the joy when we gathered just to celebrate being in community with one another. It hasn't been easy, and we didn't always get the turnout or recognition we hoped for, but I have never doubted the power and potential of the people.

As I pass the baton to the incoming board, I ask you to show up for them in ways we all wish people had shown up more often over the past two years. It's time to start a new chapter, with daily opportunities to do what is right for the greater good with every action we take. The road ahead is not just about policy—it's about people, power, and perseverance. We are living in a time where comfort and convenience are used as tools of disengagement, and that plays right in to the hands of those who want to maintain the status quo rather than change it. Democracy doesn't survive on autopilot. It needs each of us—fully present, sometimes uncomfortable, but always committed.

To the new leaders: **I believe in you**. To our community: keep showing up. Because when we do, we win more than elections—and more importantly we build the future we deserve.

Rules of the Day

RULE 1. Chair. The County Party Chair (Chair) shall have general direction of the meeting and shall be authorized to take such action as necessary to maintain order. The Chair, with the guidance of the appointed Parliamentarian, shall decide all guestions of order, subject to an appeal by any delegate. Order of priority of Rules shall be (1) the North Carolina Democratic Party Plan of Organization, (2) the Rules adopted by the delegates of the Convention, and (3) Robert's Rules of Order (12th Edition). Courteous respect for one another will be the standing order of the day.

RULE 2. Obtaining Recognition. Except in the case of physical challenge, when any delegate wants to speak in debate, that delegate shall rise, approach a microphone, and await recognition by the Chair. The Chair shall inquire of the delegate the purpose for which the delegate rises. If the delegate's purpose in seeking recognition is in order, the Chair will recognize the delegate, and the delegate shall state their name and precinct name or number.

RULE 3. Limitations on Speaking and Debate. No delegate shall speak in debate more than once on the same question, or longer than one (1) minute, without permission of the assembly, granted by a majority vote without debate. Debate will be limited to five (5) minutes per motion, without permission of the assembly, granted by a majority vote without debate. Ad hominem arguments will not be tolerated by the Chair who may curtail the remaining

time of the speaker. The Chair will attempt to alternate between members in favor or opposed to a motion. A "Point of Order" should be made only if the Party Plan of Organization, Rules of the Day, or Robert's Rules of Order are being violated by the Chair or another member. A "Question or Point of Personal Privilege" should be made only if it concerns the rights of the assembly or the individual's ability to fully participate physically and is urgent in nature. Neither "Point of Order" or "Question or Point of Personal Privilege" shall be used to debate a matter that is before the body.

RULE 4. Credentialed Voting.

Credentialed delegates are those whose names appear on the official delegates' list submitted by the precincts and who have registered prior to the Convention call to order. The Chair may take voice votes, standing votes, or ballots for any and all votes. If a voice vote is used, any call for division must be sanctioned by delegates from twenty-five (25) percent of the precincts present.

RULE 5. Quorum. A quorum shall exist any time there is at least one credentialed delegate present from fifty (50) percent plus one of the organized precincts in the County. If the presence of a quorum is questioned, the Party Secretary, and/or assistants shall call the roll of precincts to determine if a quorum exists. Once a quorum has been established, no further quorum call needs to be recognized for one (1) hour. If a quorum exists when the body begins

debate on a subject, it is presumed to exist until that item is completed.

RULE 6. Nominations for County
Executive Committee Officers.
Nominations for officers shall be conducted by a nomination committee or taken from the body with nominating speeches: limited to five minutes (5) for the Nominating Committee and limited to two (2) minutes for each nomination from the floor. Nominations do not require a second.

RULE 7. Nominations for State Executive Committee Members. Only nominations for State Executive Committee members made in accordance with section 4.01 of the Plan of Organization shall be in order. (Only if there are vacancies).

Nominations for SEC shall be conducted by a nomination committee or taken from the body with nominating speeches: limited to five (5) minutes for the Nominating Committee and limited to one (1) minutes for each nomination from the floor. Nominations do not require a second.

RULE 8. Nomination of Congressional Convention Delegates. Any credentialed delegate may place in nomination the name of a registered Democrat as

delegate to the Congressional District convention as appropriate for the nominee's voting address. If nominations for delegates to a convention are closed and the number of nominations does not exceed the number of seats, a motion to elect all nominees by acclamation shall be in order.

RULE 9. Election of County Executive Committee Officers. If only one nomination has been made, a motion to elect by acclamation will be in order.

If two or more nominations have been made for an office, the election shall be conducted in accordance with the weighted vote requirements in Section 5.02 of the Plan of Organization.

RULE 10. Election of State Executive Committee Members. If the number of nominations for State Executive Committee members is equal to the number of members to which the county is entitled, and the nominations conform with section 4.01 of the Plan of Organization, a motion to elect all nominees by acclamation will be in order.

Otherwise, each delegate will Vote for no more than nine (9) people. Ballots with more than nine (9) votes will be marked spoiled and will not be counted.

Union County will have nine (9) elected SEC seats in 2025, as described in the NCDP Plan of Organization.

Furthermore, in compliance with gender equity rules set forth in that Plan:

Four (4) to five (5) of the nine (9) SEC seats will count towards the female gender identity allotment and four (4) to five (5) of the nine (9) SEC seats will count towards the male gender identity allotment.

However, when a candidate is asked to declare their gender identity, they may declare female, male or gender non-binary.

Votes for all nominated candidates will be tallied from highest to lowest and evaluated as follows:

The gender identity (either female or male) that first achieves 4 positions shall be identified. The first gender non-binary candidate who receives more votes than the 4th-placed candidate shall displace the 4th-placed candidate.

If necessary, the process will repeat for the second gender identity and/or additional candidates that have declared their gender identity to be non-binary.

RULE 11. Election of Congressional Convention Delegates. Any credentialed delegate may place in nomination the name of a registered Democrat as delegate to the Congressional District convention as appropriate for the nominee's voting address. If nominations for delegates to a convention are closed and the number of nominations does not exceed the number of seats, a motion to elect all nominees by acclamation shall be in order.

RULE 12. Resolutions. Resolutions will be presented as a group for approval. Credentialed delegates may remove individual resolutions from a group for amendments by obtaining recognition,

stating a resolution they would like to have removed, and providing a reason. Credentialed delegates may make motions to approve or deny groups of resolutions. In debate, a delegate having removed a resolution from the group of considered resolutions may be recognized for one (1) minute to speak to the reason the resolution was pulled or to make motions. A delegate from the precinct or group of precincts submitting the Resolution may be recognized for one (1) minute to speak on behalf of the resolution or explain its intent. Delegates may then be recognized to speak for one (1) minute, alternating on behalf of or in opposition of the proposed Resolution.

RULE 13. Tellers. If ballots are used in any contested election, votes shall be collected and recorded via a paper ballot provided to each in-person precinct team in attendance to record their votes. The collected ballots shall be tallied in accordance with the weighted vote requirements in Section 5.02 of the Plan of Organization. In any contested election, each nominee may designate an official observer of this process by indicating to the Chair the name and email address of their designee.

Brief description of your platform (100 words or less)

My platform is about amplifying voices that often go unheard—working-class families, youth, Black and Brown communities, LGBTQ+ folks, and rural residents. As 1st Vice

Chair, I will focus on building deeper engagement, more inclusive messaging, and year-round organizing—not just during elections. I believe in making the party accessible, accountable, and visible in every corner of Union County. I want to invest in candidate support, voter education, and trusted messengers who reflect our diverse county. My leadership will center equity, action, and community trust.

<u>Please briefly describe your activities in the Democratic Party and why you wish to serve as an officer (county executive member) or SEC member.</u>

I've supported Democratic values through local and national advocacy—focusing on education, healthcare, violence prevention, and social equity. I lead community-based calls to action through CALM, uplift working families, and help connect people to the resources and policies that impact their lives. My work has always been about turning values into action.

I want to serve as 1st Vice Chair because I believe Union County deserves bold, inclusive leadership that reflects all of us—especially those who've been left out of the conversation. I want to grow our base, build trust, and help make this party a true home for working people, young voters, and marginalized communities.

<u>Derek Werriner - 2nd Vice Chair: Training & State Executive Committee</u>

Brief description of your experience and qualifications (100 words or less) My life projects and careers vary widely across the last 25 years but there has been one constant across that spectrum: leadership. I've held leadership positions in each organization for which I've worked or volunteered.

I would also count my formative years in Texas as an important qualification for this role. I was born and raised in Dallas, surrounded by both friends and family that always trended conservative/Republican politically. As Union County is a deeply red area, we need leaders comfortable and experienced in forging relationships with citizens that may not historically align with the Democratic Party. It doesn't mean I'll compromise my deeply progressive values, but it does mean I'm well positioned, in both life experience

and temperament, to expand our reach - something that must be of the highest priority moving forward.

Brief description of your platform (100 words or less)

- Canvass year-round. Organize continually. We must empower this organization to raise money, recruit volunteers, and heighten awareness on a more robust and consistent basis.
- Frequent and much more aggressive fundraising requests (I've been to two meetings now and no one has ever asked me for a dollar.) Fundraising will underpin all of our plans for growth.
- All members shall do their best to bring a new member to every meeting.
- Greater communication between leadership and our community. Every member and every volunteer will have my direct cell phone number. I've been trying to communicate my desire to play a role in the UCDP's future for months and I still haven't had a response to my email. People MUST have easy and direct access to all of us.
- I'd like to build and host a new podcast where we'll interview local leaders and Democratic politicians about issues and events relevant to our community.
- Build a modern version of the UCDP social media presence on BlueSky, X, IG, and TikTok. As we saw in the recent Presidential contest, there are millions of voters that are not reachable by conventional outreach like door knocking and phone calls. Social media could be the only way to effectively target this demographic. Recruit a supporter with experience building social media brands to spearhead this effort.
- Organize a public debate with our Republican counterparts in Union County. I got
 the idea while recently reading Alexey Navalny's memoirs and I think it would be
 an incredibly fun and fresh way to enhance the public discourse in Union County
 while convincing people we're the only major American political party interested
 in improving people's lives.
- Hold Precinct Captains accountable to their commitments. I'll expect in-person updates from each at our monthly meetings.
- Institute internship opportunities for local high school students interested in electoral politics and issue-driven organizations. A program of this nature should eventually bring their parents into the fold.
- Empower and inspire everyone on our team! One of the most important roles of the Chair, maybe the most important, is to imbue those around me with passion and a sense of urgency. My goal will be to ensure our members and volunteers are genuinely inspired to make a difference through direct action.

<u>Please briefly describe your activities in the Democratic Party and why you wish to serve as an officer (county executive member) or SEC member.</u>

- Director of Fundraising Grassroots Campaigns (DNC) 2004; I recruited, trained, and managed paid staffers to raise money for the DNC during Kerry's presidential campaign in 2004. We raised approximately \$500,000 in Dade County, Florida solely through non-targeted, door-to-door canvassing.
- Volunteer in Union County for the Coordinated Campaign 2024; as I communicated to several members at our holiday meeting last month, I had an incredibly meaningful experience canvassing on weekends for the Coordinated Campaign after Harris began her campaign all the way through to the election. I came away from almost all of my interactions with voters hopeful and optimistic that our message, in fact, does resonate with voters. I also came away from my time canvassing with a heightened confidence that I can succeed in any environment, no matter how hostile or unlikely the prospects.

While my actual experience working directly for the Party may be a bit light, I have no doubt I make up for it in dynamic energy, communication skills, and a genuine sense of urgency. Furthermore, as evidenced by our national performance in this last cycle, we need new eyes and a fresh perspectives across the board – i.e. I don't necessarily see a dearth of experience as a negative.

No one really knows or understands what the state party or any of its affiliates or components do. This two way knowledge will help make our party and our democracy stronger going forward.
