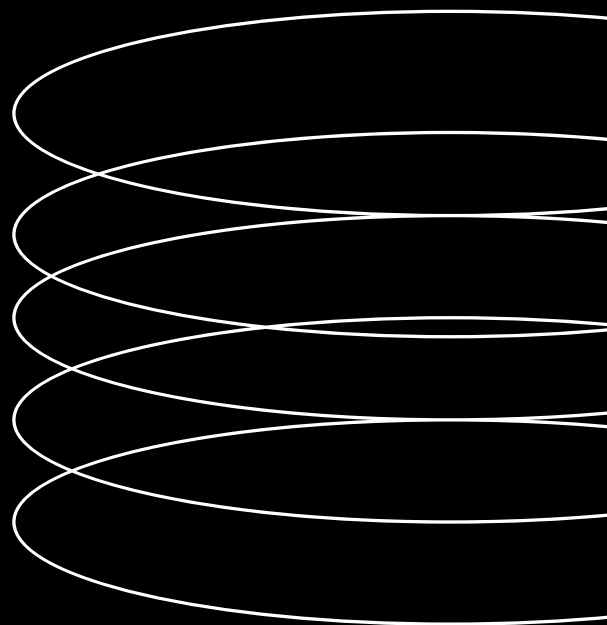
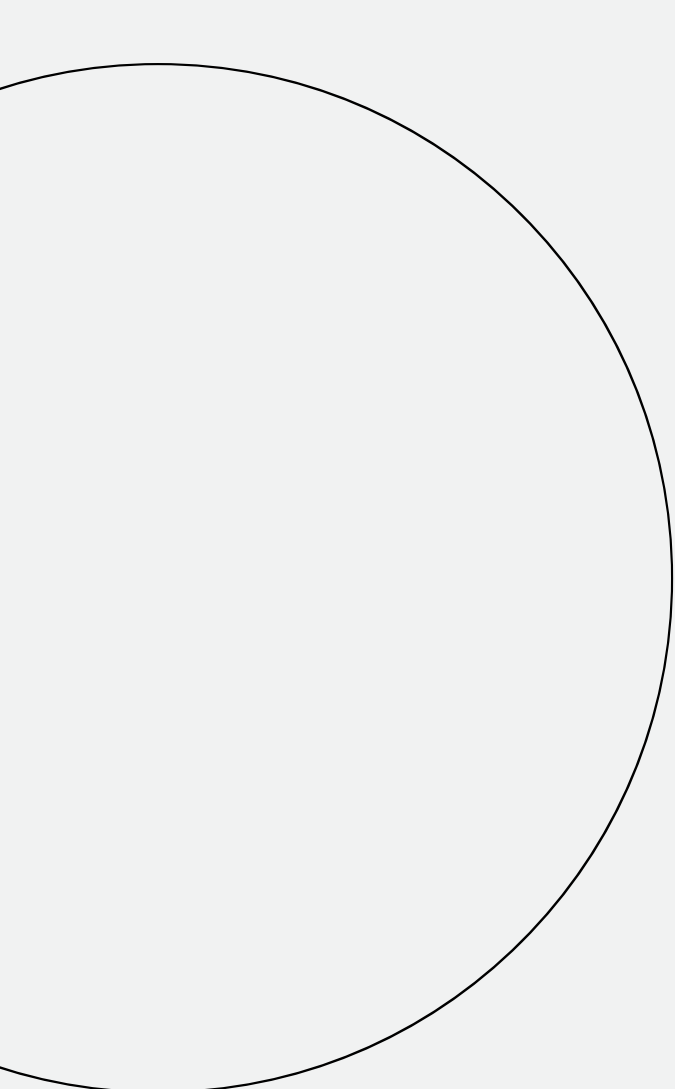




How to **Make \$1K** **in 30 Days** Selling THCa Products (Without a Smoke Shop)

INTRO:

From Customer to Supplier

You walk into smoke shops buying flower and adult candy every week...

But what if you were the one supplying it?

Thanks to the 2018 Farm Bill, you can legally sell hemp-derived products like THCa flower and gummies without needing a storefront or dispensary license. This guide shows you how to flip the script and start earning from your chill lifestyle.

You don't need to grow it.
You don't need a smoke shop.
You just need the right strategy.

What You Can Sell

Product	Average Retail Price
Adult Candy (THCa Gummies)	\$20–25 per jar
Flower (3.5g jars)	\$35–45 each
Sampler Packs or Kits	\$60–100 bundle

SOURCED FROM LEGAL HEMP SUPPLIERS UNDER 0.3% DELTA-9 THC.

\$1K/Month Strategy Example

LET'S SAY YOU JUST WANT TO COVER BILLS OR STACK PASSIVE INCOME. HERE'S WHAT IT COULD LOOK LIKE:

OPTION A: ADULT CANDY

- Buy a jar for \$3–5 wholesale
- Sell it for \$20–25 retail
- Profit per jar = \$15–20+
- Sell 2 jars/day = $\$40/\text{day} \times 30 = \$1,200/\text{month}$

OPTION B: FLOWER

- Buy a pound (unit) of flower for \$500–1,000 depending on quality
- 1 pound = 448 grams = approx. 128 eighths (3.5g units)
- Sell each eighth at \$40 = \$5,120 total revenue
- Subtract \$1,000 cost = \$4,120+ profit

MIX AND MATCH:

- SELL JUST A FEW EIGHTHS AND JARS PER DAY, AND YOU'RE WELL PAST \$1K/MONTH

How to Get Started (Without a Storefront)

1. **CHOOSE YOUR PRODUCT** — ADULT CANDY, FLOWER, OR BOTH
2. **FIND A LEGAL SUPPLIER** — LOOK FOR HEMP FARMS & PROCESSORS (THCA MUST BE UNDER 0.3% Δ9)
3. **PACKAGE IT PROPERLY** — KEEP IT CLEAN, DISCRETE, AND BRANDED
4. **MARKET SOFT** — PROMOTE LIFESTYLE, NOT THE LEAF

No storefront. No loud advertising. Just simple strategy & consistency.

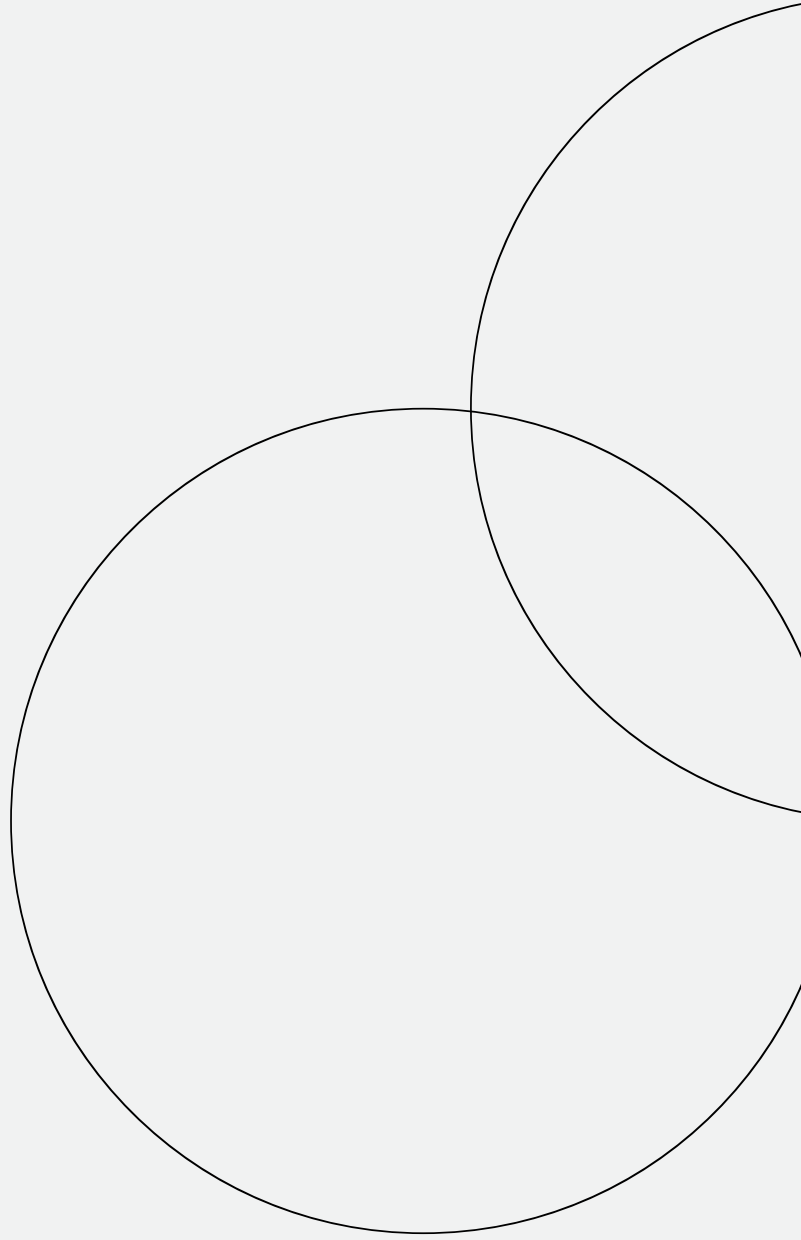
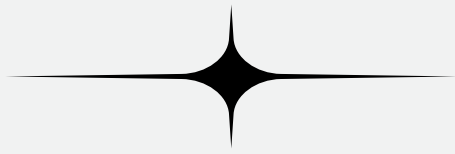
You don't need a dispensary license, but you will need the right kind of hemp license if you're trying to do this long-term and legit.
