| 4. Report from the Police   |   |
| The report from Police Scotland was read out by JK.   |   |
| There was a discussion about the need to get the information to the public and it was felt it should be included in the Ben Ledi View. RJ will contact the Police about this. Issues with homeless housing allocation in Callander were highlighted. | 5. Special Items  |   |
| 5.1 Callander Flood Group Update  |   |
| Ian McCourt, Chair of the Callander Flood Group, gave an update. Ian has attended various meetings with Stirling Council about the Flood Protection Scheme and Flood Extent Maps. He has challenged the maps with regards to accuracy. Stirling Council are currently looking at five options for flood protection in Callander. They initially came up with one option in 2019, which was a wall across the Meadows car park which the community did not support. 27 other options were considered and Stirling Council are now looking at 5 of these options. There are various constraints regarding the options which have been looked at and there is a meeting that will take place at the end of August to discuss these further. The deadline to get the preferred option is January 2026, however this is likely to be extended. There is also no money currently available once the preferred option has been decided on.     |   |
| Ian directed everyone to the Stirling Council website to look at the Flood Extend Maps. Ian has questioned the accuracy of the maps due to the generalisation and simplification of flood risk but the maps will be the basis on which decisions are made so due to the inaccuracy people could miss out on adequate flood protection. Ian also highlighted that Callander Sewage Works are liable to flood. He has already written to Councilor Earl about this, and a meeting has been arranged with the Flood Officer from Stirling Council.   |   |
| A lottery application was made for funding to complete an aerial survey to look at Natural Flood Management. The application was unsuccessful.  |   |
| The Flood Bus will be returning to South Church Street, Callander on 19 <sup>th</sup> September. It provides advice on flood adaptations to residential properties. There are also a range of activities that will be taking place in the church hall about climate change.   |   |
| 5.2 Defibrillators  |   |
| RB and MM visited Trossachs Search and Rescue who look after defibrillators in Callander. The defibrillators around the town must be adopted by the person responsible for the building they are attached to. This has caused an issue at the Post Office as Callum Menzies has now left. The defibrillator at the Post Office needs a new battery pack. The owner has also been found for the defibrillator at the golf course. Permission has been gained to remove this defibrillator as it needs new pads and a box. A new position also needs to be found for it, RB is looking at the possibility of putting it at the club house. Someone at the golf club will also need to adopt it. An application will be made to Braes of Doune to cover the cost of battery, pads and boxes. MM has clarified this is an appropriate use for the fund. RJ asked RB for a written report on all defibrillators in Callander and circulated. | MM to submit a funding application to Braes of Doune RB to send RJ a report on the defibrillators |

| Mark Nicols, Mark Reid and MM are meeting with the shop sign supplier to visit the first 4 shops for new shop signs. The grant provides the signage but not the installation which will need to be met by the shop-owner.   |                           |
| The painting of 18 shops has now been competed (counting Lady Kentmore and Rob Roy Centre as a single shop). The final report will be submitted before end September.   | MM to submit final report |
| MM applying for a further Premises Improvement Grant for 25/26 but can only be awarded 50% of the money required and it must be all completed by end March 2026, including the final report. So far, there are 5 or 6 shops willing to meet 50% of their painting costs.  | MM to apply for funds     |
| Co-option of New Community Councillors  |                           |
| Time has been spent on establishing a written method for co-option of new community councillors, for which Olga has been invaluable in providing a procedure agreed by Stirling Council. Three applications have been received and by the time of the meeting, two will have been selected.   |                           |
| Speeding along Main Street  |                           |
| CCC has received further correspondence from a resident who has previously enquired about the Transport Scotland speeding survey carried out across Scotland as she followed up with an FOI enquiry to them for the individual results for a more indepth survey. She then wrote to our MSP and has recently received a reply and a promise of some action. She will present progress at the next CCC meeting in September. |                           |
