Conditions which prevent satisfactory operation of equipment do not relieve lessee of his responsibility for rental charges, **Lessee** assumes all responsibility for equipment while out of possession of lessor and promises to return such equipment to the lessor in as good of condition as it was at the effective date of rental agreement-natural wear from responsible use is expected. Lessee shall be liable for any loss, theft, or destruction of leased property. All equipment lost or damaged beyond repair will be paid for by the lessee at the regular replacement price and all damaged equipment which may be repaired will be repaired by the lessor on return thereof and the cost of such repairs shall be paid by the lessee. Accrued rental charges cannot be applied against the purchase price or cost of repairs of such damaged or lost equipment. Skipper Land & Cattle LLC does not have roadside assistance. The lessee is responsible for the return of the trailer to the rental lot. Schedules rental rates begin when equipment leaves the rental lot and continues until return thereto. **Lessee will be charged for all days rented** including days Skipper Land & Cattle is closed. A cleaning charge may be added on items returned unclean. Lessee will use equipment with the understanding that no one under the age of 21 can drive, be on, in, or around the equipment. The **lessee assumes** all responsibility for any persons under the age of 21. Lessee is responsible for all insurance. If lessee does not return equipment by required due date, this contract will be turned over to the district attorney's office for prosecution. The lessee will be responsible for all charges for rental, damage, cleaning or material. The lessee will pay all collection **fees, attorney fees**, court costs, and any other expenses incurred in the collection of the charges by the court of the county in which indebtedness is incurred. Skipper Land & Cattle LLC is not responsible for any damage the lessee causes due to improper trailer hookup, loading, unloading or securing of trailer/contents. Lessee is responsible for all tolls incurred during rental period. **It is the responsibility of the lessee to inform Skipper Land & Cattle LLC in the event the rental contract is to be extended.**
