Dear Friends,

We are living through a frightening and painful time. At this point, many of us have lost friends, neighbors or family members to the COVID-19 pandemic. Our hearts have broken seeing these many losses, especially because we know that so many of these deaths are the result of systemic racism putting communities of color most at risk. This year also we watched in horror as George Floyd and Breonna Taylor and too many others were murdered – knowing that the ever-present risk of police brutality weighs heavily on these same communities.



Our theme this year, Discrimination is Deadly, pushes us to recognize that the threats posed by systemic racism are deeply connected – we can't understand the racially disparate impacts of the COVID-19 pandemic without understanding environmental racism; we can't understand gentrification without analyzing the role of policing in Black and Brown communities; and we can't address the eviction crisis that currently threatens more than 30 million of our neighbors across the U.S. without addressing longstanding injustice in our housing system.

We host this Summit each year to honor Dr. Martin Luther King Jr.'s central role in the struggle against segregation and in the historic passage of the Fair Housing Act of 1968. In doing so, we hope to lift up the essential role of movements in creating change. As much as this was a year of loss, it was also a year of movement building. We have been heartened to see people in the streets – in unprecedented numbers despite a pandemic – as well as providing mutual aid and taking creative action to draw attention to injustice. We're inspired by them and we're honored to highlight their work throughout our summit this year.

We appreciate your support of housing justice, more now than ever. We hope you're continue to be involved in LaFHAC's work so we can keep up the pressure for a just response to the COVID-19 pandemic and a just recovery for all of our communities.

A STATEWIDE FAIR HOUSING AGENCY

The Louisiana Fair Housing Action Center (LaFHAC) is a nonprofit civil rights organization established in 1995 to eradicate housing discrimination. LaFHAC's work throughout Louisiana includes educational offerings, free legal services for victims of housing discrimination, policy advocacy, and foreclosure prevention counseling. LaFHAC is dedicated to fighting discrimination because it is an illegal and divisive force that perpetuates poverty and segregation, and limits access to opportunity.

The Center works strategically in four program areas:

Outreach & Education

LaFHAC teaches housing authorities, landlords, and management companies about their fair housing obligations and responsibilities to proactively address discrimination. The Center also educates consumers, including youth, families, and first-time homebuyers, about their fair housing rights, and what to do if they suspect housing discrimination, and offers fair housing trainings for professionals in industries such as architecture, real estate, and supportive housing.

Foreclosure Prevention and Housing Counseling

The Center's HUD-certified counselor assists homeowners facing foreclosure and other issues that stem from possible fair housing violations. Fair housing violations related to homeownership include the targeting of racial minorities for subprime loans and the targeting of elderly persons for mortgage rescue scams.

Policy Advocacy

Center staff analyze and disseminate housing data and work closely with local, state, and national policymakers, government entities, and stakeholders to promote equitable housing policies on the local, state, and federal levels.

Enforcement

LaFHAC investigates possible fair housing violations and, when necessary, helps victims file administrative complaints with HUD and the Louisiana Department of Justice and/or file lawsuits in state or federal court. The Center responds to complaints from the public and conducts "testing," or mystery shopping, to measure and address housing discrimination.

Colette Pichon-Battle



Colette Pichon-Battle is a generational native of Bayou Liberty, Louisiana. As founder and Executive Director of the Gulf Coast Center for Law & Policy, she develops programming focused on Equitable Disaster Recovery, Global Migration, Community Economic Development, Climate Justice and Energy Democracy. Colette works with local communities, national funders and elected officials in the post-Katrina/post-BP disaster recovery. She was a lead coordinator for Gulf South Rising 2015- a regional initiative around climate justice and just transition in the South. In addition to developing advocacy initiatives that intersect with race, systems of power and ecology, Colette manages GCCLP's legal services in immigration and disaster law. In 2019, Colette was named an Obama Fellow for her work with Black and Native communities on the frontline of climate change. In 2018 Colette was awarded with an Honorary Doctorate from Kenyon College; in 2016 Colette was named a White House Champion of Change for Climate Equity; and in 2015 she was selected as an Echoing Green Climate Fellow. Under Colette's leadership, the Gulf Coast Center for Law & Policy co-chairs the national Water Equity and Climate Resilient Caucus with PolicyLink and anchors the five-state, multi-issue initiative - Gulf South for a Green New Deal.

MONIQUE HARDEN is the Assistant Director of Law and Policy and the Community Engagement Program Manager at the Deep South Center for Environmental Justice. The Center provides research, education, community and student engagement support, as well as worker training in environmental careers. Ms. Harden has more than 20 years of achievements in the practice of law that have helped predominantly African American communities win significant environmental justice victories in the Gulf Coast Region. She is the former co-director of Advocates for Environmental Human Rights, a public interest law firm whose representation of Mossville Environmental Action Now achieved the international precedent that environmental racism is a human rights violation and U.S. residents have the right to seek remedies for it at the Inter-American Commission on Human

Rights. She is the architect of the Gulf Coast Fund for Community Renewal and Ecological Health, the first of its kind community driven philanthropy in response to the systemic oppression laid bare by Hurricane Katrina. Ms. Harden has authored papers and lectured on the right of people to live in a healthy environment and the duties of government to protect this right. She has spearheaded local, regional, and international coalitions in support of communities advocating for the human right to a healthy environment. She works to democratize policymaking on environmental matters by supporting community-based organizations to engage policymakers on preventing pollution that harms their health and warms our planet.



LYDWINA HURST is a retired nurse who resides in the Gordon Plaza subdivision in the Upper Ninth Ward, Desire area. The homes in this area were built on a dump site. This issue has motivated her to serve as an activist, fighting for an end to environmental racism and injustice. She is a board member of The Residents of Gordon Plaza, Inc. where she organizes meetings with residents, participates in rallies, and attends meetings with political leaders and members of organizations in regard to environmental racism and injustices.



SHARON LAVIGNE was born and raised in St. James, Louisiana. She is the mother of 6 amazing children and the grandmother of 12 wonderful grandchildren. She has invested 39 years in the school system teaching students with special needs and disabilities. In October 2018, with guidance from God, she formed a faith-based organization called RISE St. James. Along with the members of RISE St. James, she has taken on the battle against Formosa Plastics to prevent the mega-industry from building in their beloved hometown. Today, they are taking on other hazardous industries as well and continue to advocate for basic human rights such as clean air, clean water and soil.

MICHAELA HARRISON is an international vocalist whose career is rooted in relaying the healing, transformational power of music through song. She has toured in Jamaica, Japan, France, Germany, Italy, England, Switzerland, the Netherlands, and has recorded with members of Sweet Honey and the Rock, Bill Summers, Kermit Ruffins, and Mother Tongue. Shameka Parrish-Wright



Shameka Parrish-Wright is a dedicated community organizer, educator and activist. She currently serves as Operations Manager for The Bail Project, a non-profit organization designed to disrupt mass incarceration. She is passionate about fighting daily to end the cash bail system. She was appointed by the Mayor of Louisville as a Louisville Human Relations Commissioner and she served from 2008 until 2012. She currently serves on many boards including the Homeless Coalition Continuum of Care, The Anne & Carl Braden Memorial Center, Louisville Books to Prisoners, and The Kentucky Alliance Against Racist & Political Repression. She was worked with Kentuckians For the Commonwealth, Kentucky Jobs for Justice and The

Kentucky Alliance Against Racist & Political Repression. The Kentucky Alliance one of the oldest civil rights organizations in Louisville and Kentucky and has played a pivotal role in the Justice for Breonna Taylor Movement. As co-chair, Shameka Parrish-Wright and other Black women organizers set up Injustice Square Park, a key site of organizing for the Justice for Breonna Taylor Movement, out of which Breonna's Law was born. Mrs. Parrish-Wright lives in Louisville with her husband James, six children and six grandchildren.

CHANCELA AL-MANSOUR, Executive Director of the Housing Rights Center, joined HRC in November of 2010 after having been actively involved in fair housing advocacy for 18 years. Al-Mansour worked at Neighborhood Legal Services of Los Angeles County where she supervised the Housing Unit, the Bankruptcy Court Self-Help Center and its HPRP (homeless prevention) work with L.A. City and L.A. County and she litigated hundreds of cases involving landlord-tenant, housing element, mortgage fraud and fair housing laws. Al-Mansour has extensive experience litigating fair housing cases involving familial status, disability and race, producing training and resource materials, and training attorneys in state and federal fair housing law. In private practice, she and her law partner filed the landmark *Roommates.com* case, and litigated cases involving predatory lending and fraudulent mortgage broker practices. She was also an attorney with the Western Center on Law and Poverty. She serves on the boards of the California Reinvestment Coalition, the National Fair Housing Alliance and Friends in Deed (Pasadena food pantry). Al-Mansour graduated from Vassar College and the University of California at Davis School of Law.



BENNETT CAPERS joined Fordham Law School in Fall 2012. He teaches Evidence, Criminal Law, and Criminal Procedure, and is also the Director of the Center on Race, Law, and Justice. A former federal prosecutor, his academic interests include the relationship between race, gender, technology, and criminal justice, and he is a prolific writer on these topics. In addition to co-editing the forthcoming *Critical Race Judgments: Rewritten U.S. Court Opinions on Race and Law* (Cambridge University Press) and *Feminist Judgments: Rewritten Criminal Law Opinions* (Cambridge University Press), he also has a forthcoming book about prosecutors, *The Prosecutor's Turn* (Metropolitan Books). His commentary and op-eds have appeared in the *New York Times*, *Washington Post*, and other journals. He is an elected member of the American Law Institute, a Director of Research for the Uniform Laws Commission, and has served as Chair of the AALS Criminal Justice Section and Chair of the AALS Law and Humanities Section. Governor Cuomo has twice appointed him to serve on judicial screening committees. He has also served for several years as a Commissioner on the NYC Civilian Complaint Review Board.



WENDI COOPER is a transgender woman of color who is a native of New Orleans, Louisiana. She has been a healthcare provider and mental health professional for over a decade. Wendi earned a B.S. in biology at Southern University at New Orleans in 2011. Additionally, she has an Executive Masters of Criminal Justice with a concentration in juvenile justice from Southern University. Because of her connections with the transgender community, Wendi was proclaimed by council member Latoya Cantrell before being appointed to Mayor Cantrell's transition team. She was a community organizer for the NO Justice Project in New Orleans, LA where she provided key testimony in the federal lawsuit that successfully challenged Louisiana's Crime Against Nature by Solicitation (CANS) law, securing the removal of more than 700 women from the sex offender

registry. Wendi has been featured in an MSNBC News documentary on transgender women's advocacy in Louisiana, in *Floodlines: Community and Resistance from Katrina to the Jena Six* by Jordan Flaherty, and in a Human Rights Campaign on Crime Against Nature by Solicitation feature story. Wendi's goal is to help all women, particularly transgender women, overcome their fears.

SHA'CONDRIA "iCON" SIBLEY is an Alexandria, Louisiana native and longtime New Orleans-based award-winning poet, author, performing artist, visual artist, teaching artist, host, event curator, and creator of the viral "*to all the little Black girls with big names*" movement. A multiple-time national poetry slam champion and performer, she travels the country and has made many television and stage appearances, including on TV One's *Verses and Flow* and at mainstage at the Essence Music Festival. Her work has been featured on many outlets such as *Huffington Post*, *For Harriet*, *Teen Vogue*, *InStyle*, *BET*, and *BBC World Radio*. She has also featured on musical projects with multiple national recording artists and has co-written two short films. iCon uses her work/words largely to speak on her existence as a southern Blk woman as they relate to identity, family/community, faith, and healing. Her first

published work, *My Name Is Pronounced Holy*, will be available early 2021.

CARROLL FIFE



Carroll Fife is an executive director, a community leader, a mother and a fearless freedom fighter. As director of ACCE Oakland, she helped found Moms for Housing and passed legislation at the state and local level to build collective power for tenants. She has fought back against police terrorism and helped to build a network of Black organizations and individuals working together for community self-determination. She has been involved in Oakland electoral politics for over a decade. She is an elected member of the Oakland NAACP's Executive Committee and serves as the housing chair of the organization. Since 2014, she has managed several campaigns, including Oakland's first ever slate of all Black women candidates for City

Council and the OUSD Board. She was a 2016 and 2020 Platform Committee delegate for Senator Bernie Sanders and drafted an amendment for the 2020 Democratic National Convention Platform to make housing a human right.

Carroll's legislative and electoral accomplishments include the grassroots organizing energy behind Oakland's Department of Race and Equity, pushing for the Cannabis Equity Permit program, protecting the Coliseum area from gentrification, passing Oakland's emergency eviction moratoria and pandemic eviction ban, and most recently, pressuring the City Council to reopen the City budget in order to divest from Oakland's police department to invest in community services. Carroll facilitates many grassroots coalitions, mentors youth organizations and candidates running for elected office and is a trusted advocate and servant of marginalized people everywhere.

In November 2020, Carroll was elected to Oakland's City Council representing District 3.

CONGRESSWOMAN MAXINE WATERS



Congresswoman Maxine Waters is considered by many to be one of the most powerful women in American politics today. She has gained a reputation as a fearless and outspoken advocate for women, children, people of color and the poor.

Congresswoman Waters was born in St. Louis, Missouri, the fifth of 13 children reared by a single mother. She began working at age 13 in factories and segregated restaurants. After moving to Los Angeles, she worked in garment factories and at the telephone company. She attended California State University at Los Angeles, where she earned a Bachelor of Arts degree. She

began her career in public service as a teacher and a volunteer coordinator in the Head Start program.

Congresswoman Waters was elected in November 2018 to her fifteenth term in the U.S. House of Representatives with more than 70 percent of the vote in the 43rd Congressional District of California. Congresswoman Waters made history as the first woman and first African American Chair of the House Financial Services Committee. An integral member of Congressional Democratic Leadership, Congresswoman Waters serves as a member of the Steering & Policy Committee and is the Co-Chair of the bipartisan Congressional Task Force on Alzheimer's Disease. She is also a member of the Congressional Progressive Caucus, and member and past chair of the Congressional Black Caucus.

Legislative Leadership

Throughout her more than 40 years of public service, Maxine Waters has been on the cutting edge, tackling difficult and often controversial issues. She has combined her strong legislative and public policy acumen and high visibility in Democratic Party activities with an unusual ability to do grassroots organizing.

Following the Los Angeles civil unrest in 1992, Congresswoman Waters faced the nation's media and public to interpret the hopelessness and despair in cities across America. Over the years, she has brought many government officials and policy makers to her South Central L.A. district to appeal for more resources. They

included President Clinton, Vice President Al Gore, Secretaries of Housing & Urban Development Henry Cisneros and Andrew Cuomo, and Alan Greenspan, chairman of the Federal Reserve System. Following the unrest, she founded Community Build, the city's grassroots rebuilding project.

She has used her skill to shape public policy and deliver the goods: \$10 billion in Section 108 loan guarantees to cities for economic and infrastructure development, housing and small business expansion; \$50 million appropriation for "Youth Fair Chance" program which established an intensive job and life skills training program for unskilled, unemployed youth; expanded U.S. debt relief for Africa and other developing nations; creating a "Center for Women Veterans," among others.

As she confronts the issues such as poverty, economic development, equal justice under the law and other issues of concern to people of color, women, children, and poor people, Rep. Waters enjoys a broad cross section of support from diverse communities across the nation.

Congresswoman Waters has led congressional efforts to mitigate foreclosures and keep American families in their homes during the housing and economic crises, notably through her role as Chairwoman of the Subcommittee on Housing and Community Opportunity in the previous two Congresses. She authored the Neighborhood Stabilization Program, which provides grants to states, local governments and nonprofits to fight foreclosures, home abandonment and blight and to restore neighborhoods. Through two infusions of funds, the Congresswoman was able to secure \$6 billion for the program.



MAXWELL CIARDULLO is the Director of Policy and Communications for the Louisiana Fair Housing Action Center (LaFHAC). At LaFHAC he leads the organization's legislative, regulatory, and communications work at the local, state, and federal levels related to policies that encourage fair housing choice and decrease segregation. Prior to joining LaFHAC, he served as a health care access policy fellow with the New Orleans Health Department as part of the White House Strong Cities, Strong Communities initiative. Maxwell holds a master's degree in regional planning from the University of Massachusetts, Amherst and an undergraduate degree in Sociology from the University of Illinois, Champaign-Urbana.



TARA RAGHUV EER is the founding director of KC Tenants. She is also the Homes Guarantee Campaign Director at People's Action, a national network of grassroots organizations committed to racial, economic, gender, and climate justice. Tara is an Australian-born, Indian-American immigrant who came to the US with her family in 1995 and grew up in Kansas City.



Y. FRANK SOUTHALL is the Lead Organizer and Community Engagement Coordinator for the Jane Place Neighborhood Sustainability Initiative (Jane Place), a community landtrust and housing rights organization. At Jane Place, Frank coordinates the organization's renter justice work, workshops and community outreach to various individuals, communities and groups in Orleans Parish. Frank has been involved in various forms of student, political and environmental organizing work for about twenty years.



SARAH CARTHEN WATSON is Associate Counsel in the Fair Housing and Community Development Project. Prior to assuming the role of Associate Counsel, Sarah was the George N. Lindsay Fellow, where she used a three-pronged approach of impact litigation, local advocacy and community engagement to challenge the discriminatory effects of nuisance and crime-free ordinances on minorities, victims of domestic violence, and low-income communities. In addition to continuing the Fair Housing Project's Nuisance and Crime-Free Initiative, Sarah works with the rest of the Fair Housing and Community Development team to bring litigation challenging discriminatory housing practices, engaging in strategy and advocacy around fair housing policy issues, and working with jurisdictions around the country to draft and implement their fair housing plans in

compliance with the Affirmatively Furthering Fair Housing Rule. Sarah received her J.D. and Certificate in Public Interest Law from Washington University School of Law in. While in law school, she served as Co-Chair of the Dean's Advisory Committee, Vice-President of the Black Law Students Association, and participated in the Civil Rights, Community Justice and Mediation Clinic. As a clinic student, she worked first as a law clerk at the Metropolitan St. Louis Equal Housing and Opportunity Council doing fair housing litigation, staffing the Landlord-Tenant Hotline, and mediating over 50 cases in eviction court. Sarah also spent a clinic semester at the St. Ann Municipal Courthouse outside St. Louis, working on eliminating records backlogs that contribute to the criminalization of poverty through fines and fees. She also worked as a law clerk at the St. Louis District Office of the Equal Employment Opportunity Commission, the New York City Law Department, the Civil Rights Bureau of the New York State Attorney General, and Legal Aid at Work. Prior to law school, Sarah earned her B.S. in Education and Social Policy from Northwestern University, with a minor in African American Studies. While at Northwestern, Sarah was leader in numerous on-campus student activism and social justice efforts, including Co-Founding the school chapter of Sustained Dialogue Campus Network, serving as the Coordinator of the Black Student Alliance, and leading student protest efforts that ultimately lead to the creation of the office of Campus Inclusion and Community. She is licensed to practice in Minnesota.


