

AFGC FACILITY ACCESS & USE REQUIREMENTS

The safety of all users, this facility and the environment is our top priority. Therefore, **EVERYONE** entering the AFGC property for any purpose must follow all posted AFGC rules.

EVERYONE ENTERING THE AFGC PROPERTY MUST SIGN IN AT THE CARETAKERS CARPORT.

THE LAW REQUIRES THAT ALL (RIFLE-SHOTGUN & ARCHERY) RANGE USERS MUST SIGN IN.

ALL RIVER USERS ARE ALSO REQUIRED TO SIGN-IN

Failure to follow all posted AFGC rules may result in an immediate request for you to leave the AFGC facility.

ALL AFGC FACILITY USERS WILL AGREE TO THE FOLLOWING:

1. River Access hours

- Open daily from 7:00 am until sunset or 8pm whichever comes first
- Parking for river access is by donation

2. Range Access Hours

- Open daily from 9 am until 8 pm.
- Non-members range use fee nineteen and older is \$20.00 per person per day and youth 18 and younger use fee is \$10.00. Non-members must be accompanied by a member. Maximum number of guest per member is two.

2. Range Light Protocols

RED ON - FIRING POINT IS ACTIVE

-No firearms will be loaded except at the firing line

-Discharge is in progress

-NO ACCESS DOWNRANGE

-Guns may be uncased only on the shooting bench ENSURING muzzle is pointing downrange.

GREEN ON -FIRING POINT IS CLEAR.

NOTE: When going downrange beyond 100 yards. You must take the GREEN Flag and place it in the pipe at the end of the 50 yard backstop when placing or removing targets beyond the 100 yard backstop. Last person coming back removes the flag and brings it back to the firing point area.

-Firearms will be unloaded

-Firearms must have action open and, in the rack or cased

-ACCESS IS PERMITTED DOWN RANGE

-No firearms to be handled, adjusted, etc., under a green light.

- No access beyond 100 yard without a high visibility vest worn

NO LIGHT ON NO ACCESS DOWN RANGE

Clean firing point after use.

Remove used targets from stands after use.

Paper plates for targets is PROHIBITED.

Human silhouette body targets are not acceptable

ALL metal targets MUST be approved by the Caretaker or Executive BEFORE using them on the range.

Center fire – 100 yards minimum. Rim fire 20 yards minimum.

Metal targets are not to be used on the Shotgun range. Shotgun slugs are not to be used on the Shotgun range.

No dogs allowed on the Rifle or Shotgun Range.

Please do not bring cardboard boxes empty or filled from home, use proper targets.

It is the responsibility of all range users to ensure that no wildlife is present on the range prior to, or during the discharge of any firearms.

NO HUNTING IS PERMITTED ON ALBERNI FISH & GAME CLUB PROPERTY
ALL SHOOTERS MUST:

-Ensure that there is no wildlife present on the range prior to the discharge of any firearm.

-Ensure if wildlife enters the range during shooting: ALL SHOOTING MUST CEASE AND FIRING POINT MADE SAFE.

-Ensure wildlife be chased off then range prior to resumption of shooting.

In the case of wildlife being struck or injured by any projectile:

- 1. Shooting must cease immediately**
- 2. Firing point must be made safe**
- 3. Condition of animal must be assessed.**

4. Particulars are to be documented, including sequence of events and picture taken if possible.
5. Contact must be made with the caretakers immediately (if present) or a member of the AFGC executive immediately (if the caretaker is not present.)
6. A conservation Officer must be contacted immediately to determine the fate of the animal (if saving is an option)
7. If either the caretaker, AFGC Executive Member nor the Conservation Officer is immediately available, contact must be made with the RCMP.
8. The animal is to be left in place until direction is given by a Conservation Officer, Caretaker, AFGC Executive Member or RCMP.
9. A conservation Officer can be contacted at 1-877-952-7277 (RAPP) toll free and you will get to talk to someone in Victoria, who will reply your message for you.
10. Shooting may recommence once pertinent information has been documented, required contacts have been made and permission has been granted to proceed.

GENERAL SAFETY RULES

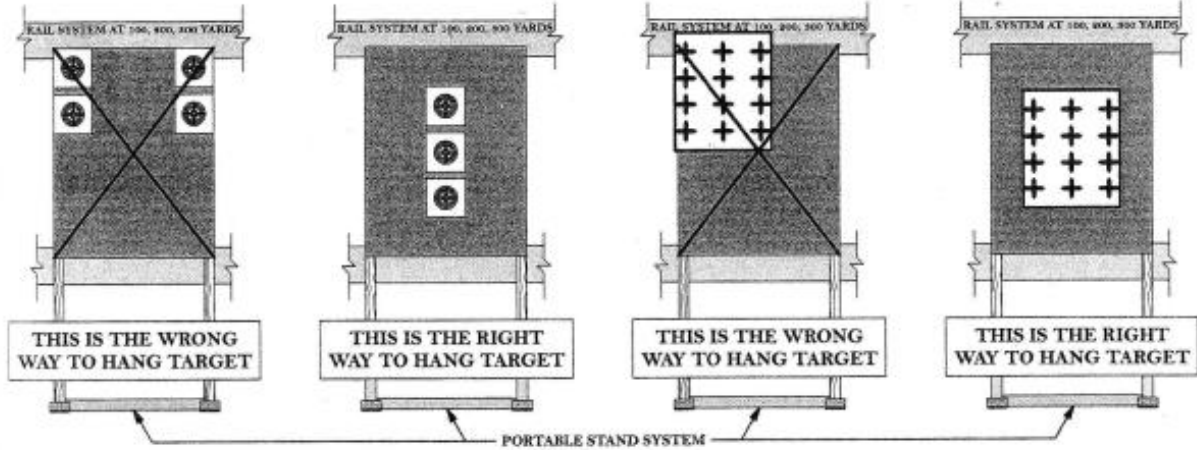
- Hearing and eye protection is mandatory on the Shotgun and Rifle/Handgun ranges.
- All firearms to be pointed in a safe direction.
- On arrival, uncase rifles on shooting bench pointing downrange. Same when leaving.
- Metal stands are for .22 rim fire silhouettes ONLY.
- Explosive and flammable targets are prohibited.
- Magazines (clips) designed to contain center fire rifle cartridges and designed or manufactured for use in semi-automatic rifles are limited to a maximum of five (5) cartridges.
- Alcohol is not permitted on an active shooting range
- The use of drones on AFGC property is not permitted due to the proximity to the airport.
- Maximum Rifle Caliber 338 Lepua Magnum, Maximum Pistol .40 Smith & Wesson

HOUSEKEEPING RULES

- CLEAN FIRING POINT AFTER USE
- REMOVE USED PAPER TARGETS FROM STANDS AFTER USE

After receiving this package you are required to read the attached information and then date and sign this form and drop it off in the metal box at the sign-in station at caretakers house, at the range. By signing you acknowledge that you are aware of the safety rules to be followed while on the property. Once you have signed the acknowledgement and dropped it off at the range, your membership will be activated.

Sign and drop off at the range. Once received your membership will be activated.
