

Alberni Fish and Game Club (AFGC)

Rental policy and agreement (effective May 15, 2026)

The ranges and clubhouse can be privately rented throughout the year by AFGC members, non AFGC members and law enforcement agencies to help offset the high cost of operating the club.

A minimum advance notice of 2 weeks is required for all rental requests by e-mail, to ensure the AFGC website is updated and members are sufficiently notified.

Contact the AFGC President or Vice President (as listed on the AFGC website) to check for availability if you wish to inquire about booking one or more of the ranges or clubhouse.

The ranges can only be rented Monday to Friday.

The ranges cannot be rented on Saturdays, Sundays or Statutory Holidays.

The clubhouse can be rented any day of the week (except AFGC mtg dates), including weekends and statutory holidays.

Clubhouse - Business rental - \$250 for full day (9am to 8pm)

Member rental - \$25 for full day (9am to 8pm, possibly later only by AFGC President/Vice President approval)

Rifle/Pistol Range - \$375 for half day (9am to 1pm or 1pm to 5pm)
\$500 for full day (9am to 5pm)
\$3000 for full 5 day week, Mon to Fri (9am to 5pm)

Archery Range - \$275 for half day (9am to 1pm or 1pm to 5pm)
\$400 for full day (9am to 5pm)

EVERYONE renting and entering the AFGC property for any rentals must read and be oriented on the AFGC FACILITY USE & REQUIREMENTS Document and follow all posted AFGC rules.

The renters Designated Range Officer (Rifle/Pistol, Shotgun or Archery) MUST SIGN IN AT THE CARETAKER'S CARPORT on behalf of the renters group and keep a recorded list of all attendees.

Failure by any of the renter's group to follow all AFGC rules may result in an immediate request for the offending individual and/or group to leave the AFGC facility and could jeopardize the renter's future AFGC facility rental opportunities, at the AFGC Executive's discretion.

Excessive property damage (including targets and stands) will result in a replacement cost fee being charged to the renter at the AFGC Executive's discretion.

Range access hours for renters are no earlier than 9am, and no later than 5pm.

Rental cancellations or rescheduling must be made at least 48 hours before the requested rental date and time.

Cancellations and rescheduling made within 48 hours will be subject to a 50% cancellation or rescheduling fee. No-shows will be charged the full rental fee. Thank-you for respecting the AFGC member's restricted access during rental requests.

Target restrictions, additional to the AFGC FACILITY USE & REQUIREMENTS Document:

- Only proper paper targets are to be used.
- Human silhouette body targets are only permitted for use by law enforcement agency rentals.
- Metal stands are for .22 rim fire silhouettes ONLY.
- Explosive and flammable targets are prohibited.
- Shooting at the Rim-fire swinger box is only permitted with a rim fire caliber. Any damage to the box from larger calibers by the rental party will result in an extra \$1,000 fine.

General safety rules, additional to the AFGC FACILITY USE & REQUIREMENTS Document:

- Ground strikes on the Rifle/Pistol ranges are prohibited, and could result in termination of current and future rental agreements.
- All shooting on the Rifle/Pistol range MUST be parallel to the dirt burms. (for example - no shooting across the range at an angle to other than the 100 yard target you are facing.
- Magazines (clips) that are designed or manufactured to contain more than 5 center fire rifle cartridges for use in semi-automatic rifles are only permitted for law enforcement agencies. All other renters are only permitted to use clips that are designed or manufactured to hold a maximum of 5 cartridges.
- Alcohol is not permitted on the AFGC site or to be consumed prior to AFGC facility use. Permission of Alcohol consumption may be granted upon written approval from the AFGC Executive for Clubhouse rentals only when all ranges are closed. Serving of alcohol at the clubhouse will require a liquor license.
- Bullying, harassment and Impairment of any kind will not be tolerated on the AFGC property.
- Maximum Rifle Caliber use is .338 Lapua Magnum.
- Maximum Pistol use is .40 Smith & Wesson.

Housekeeping rules, additional to the AFGC FACILITY USE & REQUIREMENTS Document:

- Clean firing point after use.
- Remove used paper targets from stands after use.
- Clubhouse rentals require cleaning to starting use condition.

After receiving this package, the Renter's Designated Range Officer is required fill out, date and sign this form and forward to the AFGC President or AFGC Vice President for approval.
