I hereby expressly agree for myself and my principals, representatives, employees and agents: 1) to be bound by the rules of the Clay Station Horse Park and local rules of this clinic / show / lessons; 2) that every horse, driver, attendant, groom and/or passenger and spectator is eligible as entered; 3) and to accept as final any decision of the clinic / show officials on any question arising under the clinic / show rules and any local rules of the clinic / show and agree to hold Clay Station Horse Park and Starkey Family Trust harmless from and against all claims including any injury or loss suffered during or in conjunction with the clinic / show or facility whether or not such claim, injury or loss resulted, either directly or indirectly, from negligent acts or omissions of the Clay Station Horse Park or Starkey Family Trust.
