("ADS") and its officers, directors, Event judges, officials, workers, volunteers or organizing committee nor the property owners accept or shall have any responsibility of any nature whatsoever for accidents, damage, injury or illness (including communicable diseases) to the horses, owners, riders, drivers, grooms, passengers, attendants, spectators, volunteers, officials, or any other person or property in connection with the Event.

I hereby expressly agree without any limitation or condition for myself and my principals, representatives, employees, agents and assigns:
