3.1 Correspondence: Neda from the Carmi Recreation Society attended the meeting and spoke with the PST attendees. Their group is 2 years old and has obtained tenure on an extensive recreation area in the upper Carmi area (from Saliken Drive up to the reservoir on Beaverdell Rd)., but their focus is primarily on the Carmi Recreation Trail Area Proper (trail system on both sides of the parking lot area at Km 3.5. They focus on non-motorized use areas and the primary use is the winter months for snowshoe hikers and cross country skiers and are limiting their effort at this time to the trial maintenance, trail signage, and parking lot maintenance. They want to continue offering the area for use at no costs to users in order to retain the current user groups of the trails and area.

Discussion with the PST was primarily focused on how signage will help educate all users of the areas, and that it will likely take some time for conflicts with motorized users to diminish. There was some brief discussion of track setting and trial maintenance and if the PST may want to be involved.

After Neda finished her presentation and left, the general discussion was that this was not something PST wanted to be actively involved with, given our own planned trails and maintenance programs.
