12 Strand DNA Potential

The Way of The Illumined One

Introduction From the local Intergalactic Confederation – Why Reclaim the 12 Strand DNA?

The DNA of the original Terran form was patterned after the *Soul Light Codes* of the 7th Density Pa'a Noa hundreds of millions of years ago as they projected themselves into a 5th Density biological form. This form was always meant to support the embodiment of *Souls*. The DNA also specifically included codes regarding the true source of the *Soul Light Codes* and the *Soul's* ability to evolve and return home outside of time back to the 7th Density. Please understand, the copies of the *Soul Light Codes* were never meant to be permanent and significantly degrade within time.

A decision has been made from beyond the boundaries of this universe, and in cooperation with the many other Intergalactic Confederations scattered throughout this universe, that the experiments and distortions of dense physical life and time within the lower densities will sequentially evolve. This process is supported by

the introduction of the frequency of Harmony and the presence of Light Beings who embody Neutrality in this universe which has never before existed here. *Souls* and all their fractured aspects of *Light* are being called home outside of time. This is why many are currently being called to do the great work of remembering which some call the *Great Awakening*.

Reclaiming 12 Strand DNA and what it means for Terrans:

Activating DNA must be a *Soul* choice. If the embodied personality self is not in alignment with the *Soul*, evolution can and will be problematic and potentially extremely limited.

The potentiality of each strand of DNA coming online will highlight any lines of code or templates that are not in alignment with the *Original Intent* ultimately being expressed through that strand.

When a strand of DNA begins to come online, it does not mean the strand is fully activated, it means that the potential to realize the traits of that strand, and to release the many layers of limitation and resistance to evolution programmed in that strand, becomes available.

DNA strands one and two provide for the basic biological functioning of the Terran body and create etheric templates for created consciousness and energetic bodies. These strands also hold a significant amount of limiting programming which serve to invalidate the other 10 strands as well as the *Soul* itself. At this point, the body is the messenger of the *Soul* through pain and illness.

The *Original Intent* of the previously altered 24th chromosome was to function as a bridge to the higher strands of DNA and represented the primary mechanism for

Embodied Soul confluence with Creator Source. This included clear instructions that each *Soul* had the sovereign free will to transmute all unfinished business and return outside of time immediately upon making such a choice.

Higher strands of DNA facilitate *Soul* interactions with the body, *Soul*-level psychic awareness, and refine the neurological, cellular and bioenergetic functionality of the Terran body and energy field.

For each of the *higher* strands of DNA to come online, the Assemblage Point will shift to realign incrementally with the body level compartmentalized chakra system, thus unlocking each strand's potential, ultimately dissolving numerous etheric templates in the process.

The primary Assemblage Point of each *Embodied Soul*, initially located at the sternum, locks in place the subtle bodies, meridians and chakra system according to programmed etheric templates through tens of thousands of lines of code within Terran DNA. These systems have become known as the energy field, luminous architecture or auric field and are firmly anchored into the *Embodied Soul's* 3rd Density reality through metaphysical beliefs both programmed into multiple strands of Terran DNA and widely taught and accepted throughout the world such that they have become a belief system unto themselves.

The chakra system itself has always been a complex visual metaphor representing the intention to significantly limit the *Soul's* interaction with Terran DNA. Further, the Meridian System replaced the higher functioning intercellular communication of the endothelial glycocalyx system within the body, was easily programmable and not readily individually managed or understood. These systems have

significantly limited the nervous system and the entire physical, mental, emotional, and energetic experience for nearly all *Embodied Souls* on the planet.

Throughout this process the Assemblage Point will eventually reunite with the 8th chakra or *Soul Star Chakra*, allowing the 7th strand of DNA to come online. At this point, and with the availability of *higher* strands of DNA, one has the ability to align with and/or embody the *Oversoul* over time. This will happen for each individual according to the *Soul's* choice and whether it is in alignment with the embodied personality self. Due to this, a greater awareness of the multidimensional nature of the *Soul* becomes available if one can accept and embody it. Further, the ability for the *Soul* to create a completely new unified energy field is possible.

When one is willing to release attachment to the structures of archetypes and created consciousness including ego, limbic mind processes, being a healer and all forms of religion, the 5th D frequencies become available. At this point the 6th strand of DNA will become available and one's ability to heal through intention now becomes even more possible. Further the potential for the healing of forced fragmentation at this level is profound.

Much of one's unfinished business at this level of awareness will begin to resolve through the intentions of the *Embodied Personality Self*. Through dreams, meditations or even life experiences, some of what has taken hold within one's being that is not aligned with the *Soul's* sovereign choices will be brought forward to be resolved through what may appear consciously as resistance to autonomy and self-responsibility, interpersonal conflict, various forms of co-dependency or distorted guidance from fractured selves or external beings one has given their power away to.

When one has extricated themselves from the constructs of the false matrix, entanglement with others will begin to fall away. The transition from 4th Density into a 5th Density reality, which will not be a completely linear process for anyone, can be somewhat disorienting for even the most “prepared” *Embodied Soul*.

When the individual has completely embodied all *Soul Light Codes* that are available to them in this reality, and the *Original Intent* of our creation has been reclaimed, the *Assemblage Point* will ultimately move back to the area of the heart. At this point the Soul will begin to communicate through the open and fully activated neurology of the heart. This will not happen until the first 10 strands of DNA are fully activated. The completion of this process may not be available for every *Soul* currently incarnate. The process will unfold according to each individual *Soul's* choice and whether the embodied personality self is willing to break free of deeply engrained belief systems and structures coded within Terran DNA.

At this point, the *Embodied Soul* will have completely freed themselves from the extreme confinement of the chakra and meridian systems, created a completely new dynamic biofield with a unique planetary grounding system, fully integrated their masculine and feminine aspects, freed themselves of the AI managed Ego and Limbic System programs and erased potentially millions of lines of code within the DNA. This will include the VMAT2 gene, often referred to as “the god gene,” which provides the templates for the creation stories of religion and worship, creates covalent bonds with other *Soul* (false god) lineages as well as the technology of the false matrix, and is as unique to every individual as the Terran thumbprint.

Additionally, the functioning of the mitochondrial DNA (ATP), gut microbiome DNA, endoplasmic reticulum and endothelial glycocalyx will completely change, and there will be greatly improved processes for the functioning of the mirror neurons and telomeres as well as biosynthesis including apoptosis, cellular mitosis, autophagy and phagocytosis. The biological systems will begin to self-regulate without outside intervention, medication or supplementation. Further, the original intent of the pineal gland will be restored, and the memories of the *Soul* will now be carried within the *Soul Stream* itself as was originally intended by Source and no longer a burden on the body.

****For the purpose for this document, the term Consciousness associated with the metaphysical term 'level of consciousness,' is being replaced with the term Awareness.*** This is being done to accommodate and facilitate the awareness of the fact that consciousness itself (*one may refer to Dr. David R. Hawkins' Map of Consciousness*) on this planet has been both created and manipulated in numerous ways and has been programmed into Terran DNA with the intention of displacing the Soul and replacing it with an artificially generated 'ego mind' that for the most part eludes Terran awareness.

Third Strand of DNA:

The potentiality of the third strand of DNA comes online when the Assemblage Point moves from the sternum to the 5th chakra as the *Embodied Personality Self* begins to align with the intention to understand the self as a *Soul* is made clear. Seeking wisdom and self-knowledge, and no longer external saviors, is crucial.

***Many templates or veils exist through the creation of religious paradigms and programs in Terran DNA.**

Symptoms and/or Realization:

The *Soul* then releases the chakra overlay, and all locking mechanisms are removed. These mechanisms of control do exist within every Terran (who has not been intentionally altered) whether one is aware of it or not.

This allows for expanded telepathic abilities at a basic level, minor shifts to the nervous system and physical vision, and provides for a limited multidimensional awareness opening the possibility of past and/or future incarnations to become incrementally available in one's awareness.

Fourth strand of DNA:

The potentiality of the fourth strand of DNA comes online when the Assemblage Point moves from the 5th chakra to the 4th chakra. This happens when the *Embodied Personality Self* begins to align with the heart and becomes both aware of, and intends to release, all interference between *Soul* and the *Embodied Personality Self* including all created consciousness and archetypal constructs that are so pervasive on the planet.

Many templates or veils are programmed into the Terran DNA that anchor in belief systems, created consciousness and archetypal constructs.

Symptoms and/or Realization:

As this awareness becomes available, the frequencies of the fourth density aspects of us begin to become available, and one begins to psychically open awareness to created consciousness, thought forms, egregores, tulpas, BOTS (Beings of Togetherness taught in India and in the West by Yogis and others). In other words,

the ability to discern, interact with and release various forms of created consciousness that were formerly perceived as *Soul* communication becomes possible.

At first, one may not realize that the created consciousness being expressed is not authentically their own thoughts and feelings or Soul guidance. Throughout this process, hearing consciousness telepathically can be, and often is, perceived as a “psychic attack.” *Now is the time* to begin to keep track of and monitor all thoughts, feelings, emotions and nagging memories and address them through this heightened level of awareness. This can be time-consuming, but at this time on the planet, it is a necessary step in becoming more self-aware.

One may also begin to question long-held belief systems and address this programming on multiple levels including past and/or future incarnations.

Additionally, one may experience small shifts in the functionality of the nervous system, which may present as a “nervous system upgrade.” This type of incremental shift will be experienced multiple times on one’s journey.

Fifth strand of DNA:

The potentiality of the fifth strand of DNA comes online when the Assemblage Point moves from the 4th chakra to the 6th chakra as the *Embodied Personality Self* holds the intention to accept responsibility for oneself in terms of the desire to reclaim sovereignty over the body, mind, energy field and *Soul*. At this stage, the *Embodied Personality Self* and the Soul must be in alignment with the choice to release ALL agreements and attachments of any kind.

Symptoms and/or Realization:

As this awareness becomes available, the felt experience of the physical embodiment of the *Soul* may be realized through a deep sense of groundedness and a greater physical presence within the body. One may experience an increased level of self-awareness, and the ability to observe and question one's choices, habits and relationships in this life while simultaneously identifying patterns stemming from unfinished business in other lifetimes.

Further, one may perceive a heightened awareness of the functionality of the third eye and slight or variable alterations to physical eyesight. At this point the “barnacle” appearing as a pinecone will be released from the pineal gland in the brain. The pineal gland was originally created by the Pa'a Noa, but its' original form has been altered. Several strands of DNA have been interfered with to limit its' functionality. Strands 2, 3, 4, 5 and 7 contribute to the “pinecone” attachment, which reroutes *Soul* communication and information through the limbic system which serves to screen and filter the information through belief systems and subconscious programs as well as other distortion within the DNA itself. Strands 9, 11 and 12 have been interfered with to alter the original form of the pineal gland itself which was meant to be the interface of multi-dimensional *Soul*-awareness.

As a result, expanded but still limited, multi-dimensional psychic phenomenon may begin to manifest including: the ability to telepathically hear other people's thoughts and projections and/or the projections attached to other people; the ability to “read” one's own DNA; and/or variable states of multi-dimensional awareness either at the *Soul* level or within the reality field around oneself.

*The individual may need support in identifying, understanding, developing and creating boundaries around these abilities.

When this strand is fully activated, the functionality of the mirror neurons within the human body will be significantly altered.

Sixth strand of DNA:

**This strand of DNA and the accompanying distortions is the most difficult and uncomfortable transition phase for most humans to navigate.*

At this point some may choose to stay incarnated within a 4D reality to continue to work out unfinished business or choose to move forward in this life on an accelerated evolutionary path. One must be willing to align with all Soul aspects outside of time in order to become an Illumined Being.

The potentiality of the sixth strand of DNA comes online when one is willing to release attachment to the structures of all archetypes and created consciousness. This specifically includes ego, mind, healer and all forms of religion as well as all attachment to male/female separation at the level of the *Soul* which was agreed to upon incarnating within this galaxy.

One's ability to heal through intention now becomes possible, barring other programming or beliefs intended to prevent this, much of which may be programmed into the DNA itself.

Symptoms or realization:

As this awareness becomes available it allows for greater heart opening (potentially self-love?), a greater alignment with the intentions of the *Soul*, and supports the brain in rewiring the optic nerve and visual cortex, as well as a merging of sorts of functioning of the left and right brain.

Further, the frequencies of the fifth density aspects of us begin to become available. Much of the unfinished business of the *Soul* at that level will begin to resolve through *Soul* awareness and conscious *Embodied Personality Self* intentions. Planetary, galactic and universal created consciousness and archetypal consciousness continue to be witnessed and released. Much of this may be prompted by what people perceive through meditation or as “dream time” communication or awareness.

Much of what has taken hold within one's being that is not aligned with the *Soul's* conscious sovereign choices will be brought forward to be resolved through what appears as resistance, personal conflict and distorted guidance from fractured selves or other beings one has given their power away to.
